Item 1 Approval of Minutes

President Strength stated that the first item on the agenda was approval of the minutes from the June Board meeting.

Upon a Motion by Councilmember Lombard (seconded by Judge Whitley), and unanimous vote of all members present, the Board approved the minutes of the June Executive Board meeting.

Item 2 Resolution to Accept and Approve the Quarterly Investment Report

Monte Mercer, Deputy Executive Director, explained that in accordance with NCTCOG's Investment Policy and the Public Funds Investment Act, he was submitting, for Board acceptance and approval, the Investment Report for the quarter that ended June 30, 2018. The report shows the average rate of return, cumulative transactions, and beginning and ending balances for the quarter. He also provided a supplementary schedule regarding the State's investment activity for the Regional Toll Revenue funds as well as the NTTA Hwy 161 funds.

Upon a Motion by Mayor Voelker (seconded by Commissioner Mitchell), and unanimous vote of all members present, the Board approved the resolution as presented.

Item 3 Resolution Endorsing the 2018 Update to the Water Quality Management Plan for the NCTCOG Region

Edith Marvin, Director of Environment and Development, informed the Board that the 2018 Update to the Water Quality Management Plan (WQMP) for the NCTCOG Region includes current and future planning information concerning regional water quality, wastewater infrastructure development, watershed management, and related issues. She explained that the Texas Commission on Environmental Quality (TCEQ) provides the funding to

develop the WQMP, which is included by reference in the statewide WQMP, a requirement of the Clean Water Act, Section 604(b). She explained that the Water Resources Council endorsed the WQMP and recommends endorsement by the Board.

Upon a Motion by Judge Whitley (seconded by Councilmember Rodriguez), and unanimous vote of all members present, the Board approved the resolution as presented.

Item 4 Resolution Endorsing BUILD Grant Applications Submitted to the United States Department of Transportation

Dan Kessler, Assistant Director of Transportation, explained that the 2018 Better Utilizing Investments to Leverage Development (BUILD) Discretionary Grant Program has replaced the Transportation Investment Generating Economic Recovery (TIGER) Discretionary Grant Program. The United States Department of Transportation (US DOT) announced the availability of \$1.5 billion nationwide for the BUILD Discretionary Grant Program in 2018. BUILD is dedicated to surface transportation projects expected to have a significant local or regional impact and final applications were due by July 19, 2018. He told the Board that on July 12, 2018, the RTC approved submittal of three grant applications for a total of \$75 million in funding under the BUILD Discretionary Grant Program: IH 635 LBJ East; Trinity Railway Express (TRE) Multimodal Improvements; and AllianceTexas/Haslet Accessibility Improvement Project.

Upon a Motion by Judge Whitley (seconded by Councilmember Wilemon), and unanimous vote of all members present, the Board approved the resolution as presented.

Item 5 Resolution Authorizing a Contract Amendment with United Road Towing Texas, Inc. for Wrecker Services on SH 161

Dan Kessler, Assistant Director of Transportation, asked the Board to authorize a contract amendment with United Road Towing Texas, Inc. (URT), in an amount of \$75,000 (\$60,000 Congestion Mitigation and Air Quality Improvement Program (CMAQ) funds and \$15,000 state match provided by TxDOT) for a revised not to exceed amount of \$375,000. This is expected to cover services through December 31, 2018, after which SH161 will be under construction and these services will no longer be needed. He explained that the contract is for a bottleneck improvement consisting of shoulder restriping for a three-mile section of road, enabling three lanes of traffic during peak travel periods. The additional lane capacity provides congestion relief for travelers within and adjacent to a section of State Highway (SH) 161 between Belt Line Road and SH 183 in Irving. A key component of this bottleneck improvement is the staging of tow trucks that: conduct a sweep of the shoulder for debris or vehicles prior to the lane opening; notify TxDOT that the lanes are clear and ready to be opened; and coordinate with courtesy patrols to quickly respond to incidents that require motorist assistance during operational periods. The project is located within the City of Irving and the city ordinance requires the Irving Police Department to dispatch URT, which is its contracted wrecker service provider. The City included the scope of services to stage and operate the SH 161 pilot project in its procurement and has now requested that NCTCOG enter into an agreement directly with URT to continue the service.

Upon a Motion by Mayor Sanders (seconded by Mayor McCowan), and unanimous vote of all members present, the Board approved the resolution as presented.

Item 6 Resolution Modifying the FY2018 Purchase of Computer Hardware, Software and Information Technology Contract Services for the Agency

Tim Barbee, Director of Research & Information Services, asked the Board to approve a modification to an October 2017 authorization for purchase of computer hardware, software and related services, in an amount not to exceed \$3,640,000. The request also sought authorization for the Executive Director or designee to increase contract amounts for certain purchase categories up to a maximum 25%, subject to the total authorized amount.

He explained the requested modification includes changes to allocations, but the overall original authorization amount is unchanged. The requirements for information technology purchases have varied from the originally approved anticipated purchases, necessitating a modification of the 2017 amounts for individual vendors.

Item 7 Resolution Authorizing a New Lease for the Stephenville Workforce Center

Randy Richardson, Senior Fiscal Manager, Administration, asked the Board to authorize a new 33 month lease (beginning August 1, 2018) at a rate of \$12.80 per square foot, for the current Workforce Center facility in Stephenville. He reminded the Board that the Vocational Rehabilitation (VR) staff of The Texas Workforce Commission (TWC) will eventually integrate within all existing Workforce Centers and that current plans are to integrate in May 2021. This new lease will be co-terminus with the current TWC VR lease in Stephenville, which is set to expire in April 2021, and will include an expansion option for 1,200 square feet of additional space that could potentially be utilized to accommodate the additional staff.

Item 8 Resolution Authorizing a Contract with General Datatech, L.P., for 9-1-1 Hardware and Services

Christy Williams, Director of 9-1-1 Programs, requested authorization to purchase a combination of products and services to implement a geo-diverse core infrastructure and other services needed for future 9-1-1 projects. The geo-diverse core infrastructure solution will allow services to stretch across locations and will also mitigate against the manual failover of systems. The contract, through a Master Services Agreement with General Datatech, L.P., would be an amount not to exceed \$1,500,000.

Item Title: Resolution Amending the Authorized FY 2018 Contracted Amount for Temporary Staffing Services

The North Central Texas Council of Governments (NCTCOG) utilizes temporary staffing services in order to meet its business needs. These engagements have primarily been technology related and utilized for defined-term and/or special projects. These services are essential as the labor market tightens and the search for talent has become increasingly more difficult.

In October 2017, the board authorized the agency to incur up to \$300,000 in expenses for FY18 utilizing six (6) contracts procured through the North Texas SHARE program. Due to various projects, including streamlining initiatives leveraging Laserfiche and another database development project, the agency will exhaust the \$300,000 authorization prior to the end of the fiscal year. In order to continue these projects through September 30, 2018, staff is requesting to amend FY18's authorization to allow for an additional \$75,000 in approved spending for these contracted resources.

A draft resolution authorizing an amendment to the October 2017 resolution, increasing the authorization for temporary staffing services by \$75,000 utilizing existing contracts with Abacus Services, Corp., Ad-A-Staff, Apple One, Matrix Resources, Superior Group, and U.S. Technical Solutions, is attached for Executive Board consideration.

**RESOLUTION AMENDING THE AUTHORIZED FY 2018 CONTRACTED AMOUNT FOR

WHEREAS , the North Central Texas Council of Governments (NCTCOG) is a Texas political subdivision and non-profit corporation organized and operating under Texas Local Government Code Chapter 391 as the regional planning commission for the 16-county North Central Texas region; and,

WHEREAS , NCTCOG is a voluntary association of, by and for local governments established to assist in planning for common needs, cooperating for mutual benefit, and coordinating for sound regional development; and,

WHEREAS , the FY2018 utilization of existing contracts from the North Texas SHARE purchasing cooperative for temporary staffing services was approved by the Executive Board in October 2017 in an amount not to exceed \$300,000; and,

WHEREAS, the requirements for temporary staffing services purchases have varied from the originally anticipated purchase amount necessitating an increase in the authorization amount for vendors by \$75,000; and,

WHEREAS, the North Central Texas Council of Governments has complied with federal and state regulations regarding contracting and procurement.

NOW, THEREFORE, BE IT HEREBY RESOLVED THAT:

- Section 1.** The NCTCOG Executive Board amends its authorization for FY 2018 temporary staffing services by \$75,000, for a revised not to exceed amount of \$375,000.00.
- Section 2.** The Executive Director or designee is authorized to execute agreements necessary to carry out the initiatives described herein, in the name of the North Central Texas Council of Governments.
- Section 3.** This resolution shall be in effect immediately upon its adoption.

Item Title: Resolution Authorizing Acceptance of the FY 2018 Homeland Security Grant Program (HSGP) Funds to Support Regional Activities

The North Central Texas Council of Governments (NCTCOG) wishes to continue to assist the Office of the Governor Homeland Security Grants Division (OOG) and the Urban Area Security Initiative (UASI) in administering and planning the Homeland Security Grant Program (HSGP) for the region and urban area. This is a continuation project.

This funding is a part of the 2018 Department of Homeland Security (DHS) Appropriations Act. The DHS Homeland Security Grant Program includes provisions for funding assistance of approximately \$1,900,000 to NCTCOG to provide planning, equipment, training, and exercise assistance to the local governments. It will also support the regional Citizen Corps Program. Consequently, it effectively fills the gaps between needs and existing capabilities pertaining to prevention, preparedness, mitigation, response, and recovery activities. The performance periods for projects under this grant program are October 1, 2018, to September 30, 2020.

The Office of the Governor Homeland Security Grants Division will enter into an Interlocal Cooperation Agreement with NCTCOG for approximately \$74,000 to manage and administer the 2018 Homeland Security Grant Program and the 2019 Homeland Security Grant Program application process. NCTCOG annually leads the application process for the HSGP as outlined and accepted by the Regional Emergency Preparedness Advisory Committee (REPAC), the Emergency Preparedness Planning Council (EPPC), and the Executive Board. NCTCOG also provides technical assistance to local sub-grantees, including grant rules, regulations, and guidance, and the web-based grant management systems. The performance period is October 1, 2018 to September 30, 2019.

A draft resolution authorizing acceptance of approximately \$1.9 million in FY 2018 Homeland Security Grant Funds is attached for Executive Board consideration. At this time, the grant program is 100% federally funded with no local cost-share or match requirements.

Item Title: Resolution Authorizing Receipt of Grant Funds to Support Hazard Mitigation Action Plan (HazMAP) Updates for Erath, Hood, Hunt, Palo Pinto and Parker Counties

In October 2017, the North Central Texas Council of Governments (NCTCOG) applied for 2017 Pre-Disaster Mitigation Grant (PDM-17) funds in the amount of \$324,000 to update the Erath, Hood, Hunt, Palo Pinto, and Parker County HazMAPs. It is expected NCTCOG will be awarded the full \$324,000 federal share requested.

When complete, the multiple county HazMAPs will cover 5 counties and 22 municipalities, helping each to recognize hazards, risks and vulnerabilities common to Texas as identified by the Texas Division of Emergency Management. Data from the plans will be used to create policy, procedures, plans and/or projects to mitigate identified hazards and reduce risk and vulnerabilities. Once adopted, the plans will also result in eligibility for future federal mitigation grant funds.

Each participating jurisdiction understands the level of commitment necessary to complete the project, and have agreed to commit in-kind time and resources equaling \$108,000 (25% non-federal match), for a total project cost of \$432,000. The 27 participating jurisdictions will share responsibility for required match equally, currently at \$4,000.

A draft resolution authorizing receipt of approximately \$324,000 in grant funds through the Texas Department of Public Safety to update Hazard Mitigation Action Plans for Erath, Hood, Hunt, Palo Pinto and Parker Counties is attached for Executive Board authorization.

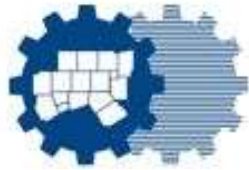

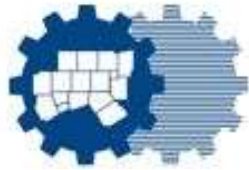

Item Title: Resolution Authorizing Contracts with Instruction and Training Providers

The North Central Texas Council of Governments (NCTCOG), in its capacity as the designated Area Agency on Aging (AAA), receives federal and state funding that may be used to educate older adults, caregivers and professionals about aging-related issues (e.g., dementia care). The AAA funds Instruction and Training services as both a direct and contracted service. Currently, NCTCOG has contracts with four competitively procured entities to provide Instruction and Training, with periods of performance that will terminate on September 30, 2018.

In May 2018, NCTCOG distributed a request for proposals soliciting Instruction and Training services for up a four-year term and subsequently received two proposals. Aging Program staff convened a review committee, comprised of members of its Regional Aging Advisory Committee, which recommended that both respondents be selected in order to meet programmatic needs.

Staff is proposing that contracts be awarded for a period beginning October 1, 2018, and terminating September 30, 2022, subject to available funding. Contractors will be reimbursed for actual expenses and subject to both program and fiscal reviews during the four year proposed contract period.

With this as background, staff is requesting Executive Board authorization to contract with the following two entities:

- Maurice Barnett Geriatric Wellness Center d/b/a Wellness Center of Collin County, in an amount not to exceed \$340,000 during the four year contract period; and
- Golden Well in an amount not to exceed \$60,000 during the four year contract period.

Attached is a draft resolution authorizing contracts for Instruction and Training Providers for Executive Board consideration. I will be available August 23rd should you or the Board have any questions.

The North Central Texas Council of Governments (NCTCOG), in its capacity as the designated Area Agency on Aging (AAA), receives funding from the Texas Health and Human Services Commission (HHSC) for housing navigator services, which include developing an inventory of affordable housing, advocating for the expansion of affordable housing, and commenting on housing policy.

Item Title: Resolution Authorizing Contracts with Caregiver Support Providers

The North Central Texas Council of Governments (NCTCOG), in its capacity as the designated Area Agency on Aging (AAA), receives federal and state funding that may be used to provide education, information, and supportive counseling to unpaid caregivers of older adults, older persons who care for adults with severe disabilities, and grandparents who have primary custody of grandchildren under the age of 18. The AAA funds Caregiver Information Services and Caregiver Education and Training as contracted services. Currently, NCTCOG has contracts with eight competitively procured entities to provide these caregiver support services, with periods of performance that will terminate on September 30, 2018.

In May 2018, NCTCOG released a Request for Proposals to secure new providers. In response, NCTCOG received nine proposals. Aging Program staff convened a proposal review subcommittee, comprised of members of its Regional Aging Advisory Committee, which scored all proposals and ranked them. Subcommittee members recommended that all proposals be funded, with rankings determining funding levels.

Staff is proposing that contracts will be awarded for a period beginning October 1, 2018 and terminating September 30, 2022, subject to available funding. Contractors will be reimbursed for actual expenses and subject to both program and fiscal reviews during the four-year contract period.

With this as background, staff is requesting Executive Board authorization to contract with the following entities, listed in rank order with funding limits, during the four-year contract period as indicated:

- Mascari Corporation: \$106,000
- Alzheimer's Association, Dallas and Northeast Texas Chapter: \$110,000
- Alzheimer's Association, North Central Texas Chapter: \$165,000
- Z-Quest: \$35,000
- Maurice Barnett Geriatric Wellness Center, d/b/a Wellness Center for Older Adults: \$330,000
- Senior Connect: \$26,000
- The Senior Source: \$68,000
- Meals on Wheels Senior Services: \$37,000
- Liferoads: \$13,000

Item Title: Resolution Authorizing Short-Term Extensions of Contracts with Managed Care Organizations for Relocation Services

From 2007 to 2017, the North Central Texas Council of Governments (NCTCOG) contracted with the legacy Texas Department of Aging and Disability Services/Texas Health and Human Services Commission (HHSC) to relocate Medicaid-eligible nursing home residents with complex needs from facilities to community. In September 2017, relocation services were carved into managed care. As authorized by the Executive Board, NCTCOG entered into relocation contracts with five managed care organizations (MCOs) selected by HHSC to provide STAR+PLUS Medicaid waiver services for adults with disabilities.

Under the MCO relocation contracts, NCTCOG staff and contractors assist MCO members in transitioning from nursing facilities to independent living. Relocation specialists (NCTCOG staff and contractors) help find affordable housing, arrange community-based services (e.g., transportation and money management), and access transition grants for provision of essential goods and services.

Under the MCO contracts, payments to NCTCOG are made on a per member per month (PMPM) basis, based on the number of nursing facility residents who are enrolled in the MCO and reside in the North Central Texas region. During Fiscal Year 2018, MCO payments to NCTCOG will total approximately \$1,100,000. The MCO contracts expire on August 31, 2018.

Staff wishes to work with MCO representatives to transition the current payment methodology, which is based on nursing home census (rather than on persons served) to pay-for-performance to ensure NCTCOG fully recovers its costs. Although the current payment methodology resulted in level funding for the program, it does not fully compensate NCTCOG its costs for work done or allow for program growth. Staff is seeking authorization for a short-term extension of these contracts to permit additional time to re-negotiate the payment provisions.

Attached is a draft resolution for Executive Board consideration authorizing an extension through no longer than November 30, 2018 for each of the five MCO contracts (i.e., Superior, Inc., Anthem, Inc., a/k/a Amerigroup, HealthSpring Health and Life Insurance Company, Inc., a/k/a Cigna HealthSpring, Molina Healthcare of Texas, Inc., and United Healthcare Insurance Company). I will be available during the August 23rd Board meeting to respond to any questions Board members may have.

WHEREAS, staff is requesting authorization for short-term extensions of the five MCO contracts for no longer than November 30, 2018, to permit time to re-negotiate the compensation provisions.

NOW, THEREFORE, BE IT HEREBY RESOLVED THAT:

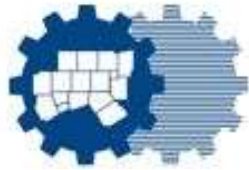

Item Title: Resolution Authorizing Contracts for Case Management Services

The North Central Texas Council of Governments (NCTCOG), in its capacity as the designated Area Agency on Aging (AAA), receives funding from the Texas Health and Human Services Commission under the Older Americans Act to provide case management services to older adults and their family caregivers. In addition, NCTCOG has received funding in the past from five managed care organizations (MCOs) to provide case management (also known as “relocation”) services to nursing home residents who wish to return to community living. These programs are supported by a combination of staff and contract care coordinators. Contract workers help ensure timely and cost-effective services since program volumes are highly variable. In addition, using contractors who are dispersed helps control expense associated with home visits.

NCTCOG has contracts with 15 entities for case management services that terminate August 31, 2018. Staff issued a Request for Qualifications in June and received proposals from 13 respondents, all of whom are currently under contract. Aging Program staff convened a review committee that evaluated proposals, ranked them, and deemed all qualified.

Under the proposed contracts, case managers who are sole proprietors are reimbursed on a unit rate basis, with unit rates that may not exceed \$75 per unit. This is consistent with state averages. A unit is defined as time spent by the caseworker in working on an eligible case. A unit does not include travel time or training time. For the proposed non-profit contractor, REACH, compensation would be on a cost reimbursement basis. However, these rates may be adjusted based on the result of negotiations with the MCOs which are paying for these services. Staff is proposing that case management contracts will be awarded for a period beginning September 1, 2018, through August 31, 2019, with annual options to renew for up to four consecutive years, subject to available funding.

NCTCOG has budgeted approximately \$1,000,000 for these activities for FY 2019 with the primary funding source being the MCO contracts. These proposed contracts will be scaled commensurate with MCO contracts executed for FY 2019. Staff can control these expenses by managing the number of referrals given to each of the independent contract care coordinators. As part of its quality assurance and cost control strategies, staff routinely analyzes care coordinators’ cost per consumer and gives preference to care coordinators with lower cost who are in full compliance with programmatic requirements.

With this as background, staff is requesting Board authorization to contract with case management service providers and thereby address the needs of older persons, family caregivers, and nursing home residents. Attached is a draft resolution for Executive Board consideration.

WHEREAS, the North Central Texas Council of Governments (NCTCOG) is a Texas political subdivision and non-profit corporation organized and operating under Texas Local Government Code Chapter 391 as the regional planning commission for the 16-county North Central Texas region; and,

WHEREAS, NCTCOG's Aging Program receives funding from five managed care organizations to help nursing home residents return to the community;

WHEREAS, contracting for case management services is an efficient means of ensuring adequate staffing and controlling program expense; and

WHEREAS, NCTCOG has engaged in a competitive procurement process, whereby it has solicited, received, and evaluated proposals for case management services.

NOW, THEREFORE, BE IT HEREBY RESOLVED THAT:

- Section 1.** Contracts between the North Central Texas Council of Governments and case management providers, as specified in Attachment 1, for an initial term of up to one year, for an annual amount not to exceed \$1,000,000, with four optional renewals, be and are hereby approved. This authorization is contingent on execution of managed care organization contracts.

- Section 2.** The contracts authorized in Section 1 shall be scaled in scope and number commensurate with managed care organization contracts executed, if any, for Fiscal Year 2019 and beyond.

- Section 3.** The Executive Director or designee is authorized to execute agreements necessary to carry out this program in the name of the North Central Texas Council of Governments.

- Section 4.** This resolution shall be in effect immediately upon its adoption.

Item Title: Resolution Authorizing Agreement with the Town of Addison for Repayment of Funds for the Cotton Belt Rail Line

In 2015, the Town of Addison committed \$5 million to the Dallas Area Rapid Transit (DART) for the construction of the Cotton Belt Rail Line. Addison's commitment was conditioned on funds not being paid to DART until the Cotton Belt was finished (i.e., commencement of revenue service). However, DART needs the funding available prior to construction. DART and Addison jointly approached the Regional Transportation Council (RTC) with a proposal that the RTC fund Addison's contribution in the timeframe needed by DART and, in return, Addison would return funds to the RTC post construction of the Cotton Belt Line.

On August 9, 2018, the RTC programmed \$5 million to DART in Fiscal Year (FY) 2019 as Addison's contribution to the Cotton Belt Rail Line. RTC's action was contingent on Addison returning funds back to the North Central Texas Council of Governments (NCTCOG), as RTC's fiscal agent, starting 30 days after Cotton Belt revenue service commencement, which is anticipated in FY2022. Return of funds would occur over a maximum of 10 years with an interest rate of 1.8 percent. To that end, an Interlocal Agreement (ILA) has been developed among NCTCOG, RTC, and Addison to further memorialize the terms and conditions of this funding strategy. The Town of Addison approved the Interlocal Agreement at its meeting on August 14, 2018.

A draft resolution authorizing an agreement with the Town of Addison for the repayment of funds to NCTCOG, as RTC's fiscal agent, for the Cotton Belt Rail Line is attached for Executive Board consideration. I will provide a brief presentation on this item and will be available to answer any questions prior to requesting Board approval.

Similar to Round One, eligible projects were to be in the 12-county Metropolitan Planning Area and address innovative outcomes focused on three elements – Blue (water), Green (environment), and Grey (transportation infrastructure). Eligible applicants could include teams of individuals, private firms, and governmental agencies and could receive a maximum award of \$50,000.

NCTCOG received a total of eight applications. The Selection Committee met on July 3, 2018, to review and evaluate applications and recommended awards for the following projects:

- Amanda Popken Development – Retrofitting Neighborhood Commercial Green Bicycle Park
- City of Watauga – Hightower Drive Biofiltration Rain Gardens
- Huitt-Zollars – Micro-Detention Storage System

The Regional Transportation Council approved awards for these projects on August 9, 2018. Executive Board approval will be requested to enter into agreements for implementation of these projects, in an amount not to exceed \$138,500. Regional Transportation Council Local funds will be used to fund these awards.

Item Title: Resolution Amending Agreement Authorization with the City of Mineral Wells for the Clean Fleets North Texas 2018 Call for Projects

The Regional Transportation Council (RTC) opened the Clean Fleets North Texas 2018 Call for Projects on March 22, 2018. The primary goal of this program is to reduce emissions of ozone-forming nitrogen oxides from diesel-powered heavy-duty vehicles or equipment in the Dallas-Fort Worth 10-county ozone nonattainment area by replacing older, high-emitting vehicles or equipment with new, low-emitting vehicles and equipment. This initiative is funded by the Environmental Protection Agency (EPA) National Clean Diesel Funding Assistance Program and the Texas Commission on Environmental Quality (TCEQ) Supplemental Environmental Project (SEP) Program, as detailed in Attachment 1. Additional State funds are integrated into this Call for Projects as they are received to expedite utilization of funds. State dollars are reserved for replacement of school buses.

Eligible applicants include local governments and private companies with a contract with a local government who own heavy-duty diesel vehicles or equipment operating in the nonattainment area and who have adopted the RTC Clean Fleet Policy. A list of eligible applicants is available at www.nctcog.org/fleetpolicy. Applications are accepted and reviewed on a modified first-come, first-served basis with monthly application deadlines. Applications will be accepted until January 25, 2019, or until all funds are awarded, whichever occurs first. The Executive Board approved the first subawards under this Call for Projects on June 28, 2018, including an award to the City of Mineral Wells in the amount of \$23,000 EPA funds and \$69,000 local funds, for a total project cost of \$92,000. Attachment 1 summarizes these previous awards.

Since then, the City of Mineral Wells has submitted an additional application requesting replacement of one piece of non-road equipment for a total of \$51,555 in EPA funds and \$154,665 in local funds, as illustrated on Attachment 1. The RTC approved award of this project on August 9, 2018. The City of Mineral Wells will provide local contributions of 75 percent of the total project cost, as required by EPA according to project type; all local contributions will be tracked and documented.

A draft resolution amending the agreement authorization for the City of Mineral Wells to include this additional award for a total of \$74,555 EPA funds and \$223,665 local match, for a total project cost of \$298,220, is attached for Executive Board consideration. Staff continues to accept applications and will bring additional recommendations to the Executive Board in future months. I will provide a brief presentation on this item and will be available to answer any questions prior to requesting Board approval.

Item Title: Resolution Authorizing Receipt of Funds for the Clean Cities University
Workforce Development Program

Since 2010, the US Department of Energy, through Argonne National Laboratory and the American Society for Engineering Education, has administered the Clean Cities University Workforce Development Program. This program provides interns to designated Clean Cities Coalitions through a Request for Proposals. The students support the selected Coalitions in planned activities and strengthen each Coalition's efforts and its workforce. The program also has the potential to help mentor students to further their efforts towards building public awareness of advanced technology vehicles, alternative fuel vehicles, and other measures for the overall reduction of petroleum consumption in the transportation sector. The North Central Texas Council of Governments (NCTCOG), through the Dallas-Fort Worth Clean Cities Coalition, has been awarded an intern since the program's inception.

In June 2018, NCTCOG submitted an application to receive funding to support an intern position for Fiscal Year 2019. Staff is requesting Executive Board approval to execute necessary agreements to receive approximately \$14,400 from the American Society for Engineering Education to provide funding for an intern for the 2018-2019 school year and a 2019 summer term. No local match is required.

A draft resolution authorizing receipt of funds from the American Society for Engineering Education is attached for Executive Board consideration. I will provide a brief presentation on this item and will be available to answer any questions prior to requesting Board approval.

Item Title: Status Report on Department of Energy Response to Correspondence
Requesting Evaluation of the Clean Cities Program

At the January 2018 Board meeting, an item was presented to accept funding from the Department of Energy for ongoing activities as the Dallas-Fort Worth Clean Cities Coalition. During discussion, Board members questioned whether the program had become obsolete due to the changing dynamics of energy security and fuel supplies. At the Board's request, the North Central Texas Council of Governments (NCTCOG) submitted a letter to the Department of Energy (DOE) asking that the agency evaluate whether the program was still necessary or whether its focus should be modified.

The Clean Cities program is organized at the national level within the Technology Integration division of the Vehicle Technologies Office, which is charged with providing objective and unbiased data and real-world lessons learned to inform future research needs and support local decision making.

The Dallas-Fort Worth Clean Cities Coordinator recently attended trainings with staff of the national Clean Cities program and learned about a shift in the focus of the program. The priorities of the DOE Vehicle Technologies Office are evolving in response to changing transportation technologies. The Vehicle Technologies Office develops advanced transportation technologies to:

- 1) Improve Energy Efficiency,
- 2) Increase Domestic Energy Security,
- 3) Reduce Operating Cost for Consumers and Businesses, and
- 4) Improve Global Competitiveness of the US Economy.

NCTCOG also recently received correspondence from the DOE responding to the letter transmitted by NCTCOG on behalf of the Executive Board. A copy of this letter is attached. Staff will be available to answer any questions on this topic.

Thank you for your February 16, 2018, letter to Energy Secretary Perry regarding the Department of Energy's (DOE) Clean Cities initiative. Your letter was forwarded to the Vehicle Technologies Office (VTO) for review and response.

Clean Cities activities reside in VTO's Technology Integration Program, which provides objective, unbiased data and real-world assessments that inform future research plans. Our activities with Clean Cities are constantly evolving over time to stay ahead of industry trends while supporting data and systems research needs. We support a broad technology portfolio that spans alternative fuels (e.g., biofuels, electricity, hydrogen, natural gas, and propane) as well as new energy efficient mobility technologies and systems.

Today's cities are shaping the definition of the "smart city," introducing new mobility strategies into traditional public transportation and planning for connected and automated vehicles. Therefore, communities and Clean Cities coalitions have asked VTO for technical support to understand these new technologies and the impact they will have. VTO has begun research in this area and is working with cities to consider how improving the affordability and energy efficiency of transportation systems complements local technology innovation objectives. Our Funding Opportunity Announcement issued on May 1, 2018, exemplifies the strategic change that we are making around advanced mobility solutions to make transportation more affordable and efficient. Clean Cities coalitions were encouraged to apply for these competitive opportunities to develop initiatives that are relevant to their communities in overcoming barriers to mobility. We expect to announce selections for award later this summer.

I hope this information about our evolving Clean Cities activities is helpful and addresses any concerns you may have about priorities. On behalf of my staff in VTO, we welcome the opportunity to meet with you and your board to address any questions, share details about the direction of our program, or discuss your feedback and suggestions.
