Task 6 -The subcommittee reviewed the draft 5-year outreach and implementation strategy. Each plan category has associated tasks listed in the outline, 38 tasks in total. Estimated budgets for each task to be added.

Task 7- Subcommittee discussed the five water quality BMP details and specifications revisions to fit into the Site Development Controls Manual.

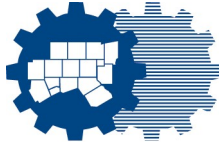

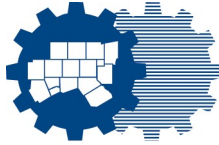
