Eligible Disposition and Ownership Options

Eligible Disposition Options:

Existing Vehicle to Be Replaced	Disposition Option
Diesel MY 2010 or older	Must be Scrapped
Any fuel type MY 2011 or newer	Can be Scrapped, Sold, or Donated
Eligible Transit Vehicles ONLY: Any fuel type MY 2011 or newer	Can be Moved to a Reduced Service

Frequently Asked Questions (FAQ) Related to Eligible Disposition Options:

- I only operate MY 2011 vehicles in the NCTCOG region, but I operate diesel MY 2010 or older vehicles in other regions. Do I have to scrap the MY 2010 vehicles even though they are not located in the eligible project area?

North Texas Zero Emission Vehicles Call for Projects

Eligible Ownership Options:

- The applicant must have an existing vehicle in its fleet to replace as part of the vehicle replacement project (*no fleet expansion*)
- The new vehicle must be owned by the applicant (*applicant must purchase the new vehicle, no leasing*)
- The new vehicle does not have to be operated by the applicant (*applicant/owner may lease the new vehicle to a different operator*)

- What if I don't own an existing vehicle (e.g., I lease my current vehicle), but want to own a new zero-emission vehicle (ZEV) funded under this CFP?
