
# PROJECT DETAILS

## Project Scope & Limits

*Implementing Agency:* TxDOT Fort Worth

*Limits:* SH 121 from IH 35W to Riverside Drive

*Scope of Work:* Reconstruct Sylvania Ave Bridge over SH 121 with Reconstruction of Existing 2 lane Frontage Roads to 2 lane Frontage Roads and Associated Ramps



# FUNDING DETAILS

## Construction Cost:

~\$142 million

## Funding:


\$97 million from TxDOT (state funds)

\$45 million from Regional Toll Revenue (RTR) (new)

\$142 million Total

RTR account NTE-3AB, balance remaining after request is \$30 million


# **IH 635 East (LBJ East) Change Order Funding Request**

# PROJECT DETAILS

## Project Scope & Limits

Limits: IH 635 from US 75 to IH 30

Scope of Work: Lane striping, pavement markings, painting for beams/concrete barriers/walls, improvements to transitions at IH 30 and HOV lanes, & drainage improvements



# FUNDING REQUEST

- TxDOT has requested up to \$10 million in RTR funds from the LBJ East managed lane excess revenue account
- Original funding for the project was \$1.6 billion
- Request is less than 0.63% of construction funding

RTR account: LBJ EAST account, balance remaining after request is \$5 million



# RTR FUNDING REQUEST SUMMARY

## Proposed Action:

- Approve TxDOT's request to use \$97 million of state funds & \$45 million of RTR NTE-3AB funds
- Increase Funding for LBJ Express by \$10 million RTR LBJ East funds
