5. FY2020 Cost Share Program.

NCTCOG will present the current status of FY2020 cost share program.

[The Council made several suggestions on how to increase participation:](#)

- Contact previous participants and encourage them to continue participating
- Contact current member who haven't committed yet for this Fiscal Year and ask them to commit
- Enforce the consequences of not paying an invoice (language on the invoice states that there is a penalty for late payment, but it has not been enforced)

- Include more information on the invoice itself as to the programs and benefits of the program, so it is clear and available
- Include program information with invoice (as separate documentation)
- Include the formula so members know how their participation cost share was formulated

Staff has moved forward with creating a full page flyer highlighting the benefits of the Regional Stormwater Program, including the subcommittees. Staff will discuss with the Accounting group putting this information on invoices.

6. Regional Stormwater Resources and Programs. NCTCOG staff will present information on using additional resources to promote programs in our region.

Brian Geck presented information from the Solid Waste team and the resources used to promote their **Know What to Throw** campaign. While the example program received funding through a grant, the information regarding costs, opportunities, and timing could be used in deciding whether to spend stormwater funds on additional promotional items. The Council had several ideas and questions on this topic:

- Does the Public Education Task Force (PETF) have a specific advertising campaign in mind for this request? What is the proposed budget?
 - PETF does not have a specific campaign in mind at this time. The task force wanted COG staff to gather information on additional resources in advance of springtime promotions.
- Will the Council have the opportunity to vote on funding specific or individual ads?
- The suggestion that the members of PETF that want to use a specific resource enter a cost-share program to fund that specific resource was raised by two members
- Pull in animal services departments to help spread the word on pet-related items would increase readership
- What needle are we moving with the new resource, and how do we measure the results?
- This item will be brought back to the Council with additional information, if the task force or other subcommittee has a specific campaign and budget

7. Training Opportunities/Programs. NCTCOG staff will present information on regional training opportunities, post construction inspection roundtables, promotional policies, and marketing information.

COG staff presented information on proposed trainings, and the type of trainings Staff has included on the department calendar or sent out notices to members. The Council elected to receive information on all trainings, regardless of the cost of the training. Staff to look into the best way to send out notifications: via emails, active campaign flyers, or other? The discussion of post construction implementation roundtables was postponed to the next meeting.

COG staff presented information on the update to the definition of Waters of the United States (WOTUS), HR 4266 - Clean Water Through Green Infrastructure Act, and Proposition 8 - constitutional amendment providing for the creation of the flood infrastructure fund. 9. FY2020 Work Program. The NCTCOG staff will discuss on-going, and planned task force activities and other components of the regional stormwater management program. Topics will include:

 - Creating educational messaging toolkit for members to use Jan. – Sept.
 - Addressing types of litter and floatables,
 - Addressing why its an issue and include fact-based messages,
 - Creating educational infographics,
 - Highlighting personal challenges or “daily differences” residents can make
 - Working on coordinating a region-wide Spring clean-up challenge
 - Reaching out to KTB Affiliates to piggyback on their events
 - Event must be completed during a set month and include clean-up of or be adjacent to a water body


