Item 1 Approval of Minutes - January 22, 2026

Item 2 Resolution Authorizing TXShare Contracts for AI Governance, Compliance, and Enablement Platform

Board authorization was requested to enter contractual agreements for AI Governance, Compliance, and Enablement Platform through the North Central Texas Council of Governments TXShare cooperative purchasing program. NCTCOG issued RFP 2026-010, receiving 19 responsive proposals. An evaluation committee representing the Cities of Little Elm and McKinney and NCTCOG reviewed submissions and recommended awarding contracts to multiple vendors across two service categories. Recommended firms include providers for Service Category 1 (AI Governance Platform), Service Category 2 (AI Governance-related tools), or both. The contracts with the selected vendors are as follows and for terms up to five years:

Item 3 Resolution Authorizing TXShare Contracts for Healthcare Benefits Brokerage / Consulting and Ancillary Services

Board authorization was requested to enter contractual agreements for Healthcare Benefits Brokerage/Consulting and Ancillary Services through the North Central Texas Council of Governments TXShare cooperative purchasing program. NCTCOG issued RFP 2026-007, with proposals due January 23, 2026. Five responsive proposals were received and evaluated by representatives from Cherokee County and the Cities of Cedar Hill and McKinney. The Evaluation Committee recommended awarding contracts to Butler Benefits & Consulting, LLC; Higginbotham Public Sector, LLC; HUB International Texas, Inc.; Lockton-Dunning Series of Lockton Companies, LLC; and McGriff, a Marsh & McLennan Agency LLC, all for both service categories.

Item 4 Resolution Authorizing the Stephenville Workforce Center Lease Extension

Board authorization was requested authorizing a two-year extension of the lease for the Stephenville Workforce Center located at 2165 West South Loop, Suites 1–3, which includes 4,200 square feet of space currently leased from Peacock Investments LLC and shared with TWC Vocational Rehabilitation staff. Staff explained that the extension, at a rate not to exceed \$15.00 per square foot, will provide needed flexibility while a region-wide strategic analysis of Workforce Solutions service delivery and center locations is completed. Avison Young confirmed the proposed rate is within the local market range, and the Workforce Development Board recommended approval on March 3, 2026.

Item 5

Resolution Authorizing a Contract for the FY26 Teacher Externships Program

Board authorization was requested to enter a contract with North Central Texas InterLink (InterLink) to provide outreach services and support for implementation of the FY26 Teacher Externships Program, for a term of up to eleven months and an amount not to exceed \$165,000. NCTCOG, serving as the Administrative Entity and Grant Recipient for the North Central Texas Workforce Development Board, received Texas Workforce Commission funding to deliver externships for approximately 50 middle and high school teachers and counselors across the 14-county region. InterLink, a regional nonprofit that connects industry, education, and government, will assist with outreach to school districts and businesses to support program delivery. The North Central Texas Workforce Development Board recommended approval on March 3, 2026.

Item 6

Resolution Authorizing Interlocal Agreements for Receipt of Local Contributions from Local Governments and Participation in the Regional Traffic Signal Program

Board authorization was requested to enter into Interlocal Agreements with local governments participating in the Regional Traffic Signal Program. The Regional Transportation Council approved funding for this program on October 13, 2022, to improve corridor mobility, enhance safety, reduce congestion, and support regional air quality goals within the Dallas–Fort Worth nonattainment area. NCTCOG will use contracted consultants to conduct traffic signal retiming activities, including data collection, development and implementation of optimized timing plans, and performance evaluation. Participating local governments will contribute to the program and formalize roles and responsibilities through Interlocal Agreements. Board approval also covered a contingency list of additional local governments that may participate if funding allows.

Item 7

Resolution Authorizing Revisions to the North Texas MOVES BUILD Grant and Agreement Amendments with Dallas Area Rapid Transit and Trinity Metro

Board authorization was requested for NCTCOG to amend the North Texas Multimodal Operations, Velocity, Efficiency, and Safety (NT MOVES) FY2020 Better Utilizing Investments to Leverage Development (BUILD) Grant and related subrecipient agreements. NCTCOG received \$25 million through the U.S. Department of Transportation BUILD Discretionary Grant Program to support the NT MOVES program, originally approved with an estimated cost of \$72 million. Following design development and construction procurement, the total project cost increased by approximately \$58 million due to construction cost inflation and design changes needed to provide a permanent track configuration at the Trinity Railway Express crossing of IH-35E. To address the increased cost, the Regional Transportation Council approved additional funding sources, including Surface Transportation Block Grant, Congestion Mitigation and Air Quality, Texas Mobility Funds, and Regional Toll Revenue, on March 13, October 9, and December 11, 2025. While the BUILD grant amount remains unchanged, amendments are required to reflect the revised project cost and funding commitments and to update subrecipient agreements with Dallas Area Rapid Transit and Trinity Metro.

Details of the updated funding commitments are identified below.

Item 8

Appointment to the North Central Texas Economic Development District Board (NCTEDD)

Board approval was requested to appoint Michael Kowski, President and CEO, McKinney Economic Development Corporation to the North Central Texas Economic Development District (NCTEDD) Board under the 100,000 – 250,000 population category for a three-year term. The NCTEDD Board guides the work of the region’s Economic Development District, which is managed and staffed by NCTCOG. The region was designated as a District by the U. S. Economic Development Administration (EDA) in December 2016.

Upon a Motion by Commissioner Mitchell (seconded by Mayor Pro Tem Flores), to approve Consent Agenda Items 1 - 8, and unanimous vote of all members present, the Board approved the Consent Agenda Items as posted.

ITEMS FOR INDIVIDUAL CONSIDERATION:

Item 9 Resolution Authorizing 2026 FIFA World Cup Grant Program (FWCGP) and Related Agreements

Maribel Martinez, Director of Emergency Preparedness, requested Board authorization for NCTCOG to submit, manage, and administer approximately \$51.6 million in 2026 FIFA World Cup Grant Program funds on behalf of the North Texas FIFA World Cup Organizing Committee. The grant, administered by the U.S. Department of Homeland Security through the Federal Emergency Management Agency (FEMA), will support security and preparedness activities for the 2026 FIFA World Cup, during which the Dallas region will host nine matches, including a semi-final in Arlington. While only Host City Committees are eligible applicants, subawards are permitted and will be directed by the North Texas FIFA World Cup Task Force. NCTCOG will serve as the primary subrecipient, administer the grant, enter into interlocal agreements to subgrant funds to participating jurisdictions, and oversee reimbursement, compliance, and documentation. The grant period is July 4, 2025, through August 31, 2026, is 100 percent federally funded with no local match required, and will reimburse NCTCOG for eligible administrative costs.

Upon a Motion by Councilmember Justice (seconded by Councilmember Mendelsohn), and unanimous vote of all members present, the Board approved the resolution as presented.

Item 10 Resolution Authorizing Update of Proposed Final 2026 FIFA World Cup 2026 Cost Allocations and Approval of Partner Agreements

Michael Morris, Director of Transportation, requested Board authorization to reallocate previously approved Regional Transportation Council (RTC) funding associated with transportation planning and operations for the 2026 FIFA World Cup. The RTC had previously approved \$11.8 million in October 2023 and March 2025 for transit services, staging areas, and transit passes; however, refined cost estimates, agency role adjustments, and the availability of \$10.0 million in new Federal Transit Administration funding announced March 3, 2026, have created surplus RTC local funds. Staff identified approximately \$7.1 million in available RTC local funds and proposed \$3.47 million for final work authorizations supporting the FIFA Transportation Plan, including operational services, construction modifications, incremental Trinity Railway Express service costs, road closure expenses, and wayfinding and signage. Approval of this action resulted in a remaining contingency of \$3.63 million in RTC local funds, with no additional funding anticipated. A draft resolution proposed the use of \$3.47 million in RTC local funds, increasing existing agreements not to exceed \$5.72 million with the Cities of Fort Worth and Arlington, Dallas Area Rapid Transit, the Dallas FIFA World Cup Organizing Committee, and tow truck operators.

Upon a Motion by Councilmember Hogg (seconded by Commissioner Mitchell), and unanimous vote of all members present, the Board approved the resolution as presented.

Judge Hill joined the meeting virtually.

Item 11 Resolution Recommending General Assembly Enactment of the Amended Bylaws of the North Central Texas Council of Governments

Ken Kirkpatrick, General Counsel, requested Board approval of the proposed Amended NCTCOG Bylaws. He reviewed that, at the previous meeting, the Executive Board approved revisions to certain provisions and provided guidance on others, with discussion focused on four primary areas: the Immediate Past President role, the process for filling vacancies in dedicated seats, the structure and application of term limits, and the General Assembly appointment process for dedicated seats. In addition, the Executive Board recommended changes to the nominating committee composition and provided direction regarding appointments and vacancies related to dedicated seats. The Bylaws Committee was provided a written summary of these revisions and considerations.

The Board took up consideration of Section V.M. individually, with Councilmember Mendelsohn making a motion (2nd by Councilmember Justice) to amend it as follows:

Should a vacancy lasting more than sixty (60) calendar days occur in the Officers or Directors of the Executive Board other than those representing the four (4) largest counties and three (3) largest cities, a successor shall be appointed by the remaining members of the Board to fill the unexpired term and in accordance with Section V. H.

Motion passed with Commissioner Mitchell voting no.

Upon a Motion by Councilmember Justice (2nd by Mayor Bristol), and vote of all members present, the Board subsequently approved the full Amended NCTCOG Bylaws redlines, including those voted on during the meeting, and recommended to be presented to the NCTCOG General Assembly at its June 2026 meeting, with Commissioner Mitchell voting no.

INFORMATION ITEMS:

Item 12 Announcement of the President's 2026 Executive Board Nominating Committee

Victoria Johnson, President and Councilmember for the City of Burleson, announced the 2026 Executive Board Nominating Committee. She noted that all Past Presidents will be invited to participate on the Nominating Committee. She stated that the election of Officers and Directors for the NCTCOG 2026–2027 Executive Board will take place at the Annual General Assembly Meeting on Friday, June 12, 2026, to be held in person at the Hurst Conference Center. It was further noted that it is customary for the current President to serve as Chair of a Nominating Committee comprised of past NCTCOG Presidents. The committee is responsible for qualifying prospective nominees and preparing a slate of candidates for submission to the General Assembly.

Item Title: Resolution Endorsing FY 2027 Criminal Justice Priorities for North Central Texas

The North Central Texas Council of Governments (NCTCOG) has an Interlocal Cooperation Agreement with the Office of the Governor's Public Safety Office (PSO) through which NCTCOG is responsible for determining regional criminal justice priorities. Priorities are submitted annually to PSO, which provides funds for local project implementation each year. The FY 2027 Criminal Justice priority projects, as contained in the referenced attachments, are being presented for Executive Board endorsement.

Applications were reviewed, discussed and scored by teams composed of members of NCTCOG's Criminal Justice Policy Development Committee (CJPDC). In accordance with CJPDC policy, new and renewal applications receiving a score of 70 or higher are recommended for funding. Priority lists were then developed for each category based on scores from highest to lowest and approved by CJPDC. Per CJPDC Policies and Procedures, non-competing continuation projects retain the score assigned in the initial year of the three-year prioritization cycle.

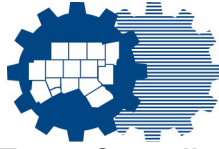

Item Title: Resolution Endorsing the Homeland Security Grant Application for the Nonprofit Security Grant Program (NSGP)

The North Central Texas Council of Governments (NCTCOG) Foundation, Inc., is a 501(c)3 non-profit corporation established in 2002 to receive funding to supplement NCTCOG activities to provide broader service opportunities to NCTCOG's constituents and the North Central Texas region. The Foundation has no employees, is managed by NCTCOG staff, and the NCTCOG Executive Board serves as the Board of the Foundation.

Staff is requesting endorsement of a March 2026 application to the Non-Profit Security Grant Program (NSGP) by the NCTCOG Foundation. The NSGP provides funding support for physical security enhancements and other security-related activities for organizations that may be at high risk of a terrorist attack. If awarded, funding would support security improvements at the Regional Police Academy (RPA) training facility to enhance the safety and protection of academy personnel, instructors, recruits, and visitors. These improvements focus on strengthening access control, increasing situational awareness, and enhancing overall facility protection. The project is intended to improve emergency response capabilities and increase the safety of RPA staff, instructors, recruits, and visitors.

A draft resolution endorsing the application, and authorizing receipt and administration of an amount not to exceed \$200,000 in FY2026 Non-Profit Security Grant Program funding is attached for consideration. The grant program is 100 percent federally funded and does not require a local cost share or match. The federal performance period for projects funded under the FY2026 NSGP is September 1, 2026, through February 28, 2029.

Staff will be available at the NCTCOG Foundation Board meeting to answer any questions.

**RESOLUTION ENDORSING THE HOMELAND SECURITY GRANT APPLICATION FOR THE
NONPROFIT SECURITY GRANT PROGRAM (NSGP)**

WHEREAS, the North Central Texas Council of Governments (NCTCOG) Foundation, Inc., is a 501(c)3 non-profit corporation; and,

WHEREAS, the NCTCOG Foundation was established in 2002 with the purpose to receive funding to supplement NCTCOG activities in order to provide broader services opportunities to NCTCOG's constituents and the North Texas region; and,

WHEREAS, the health, safety and welfare of recruits, staff, instructors, visiting officers, and other personnel at the Regional Police Academy may be impacted by natural, technological, or human-caused hazards, including acts or threats of terrorism; and,

WHEREAS, the NCTCOG Foundation finds it in the best interest of the North Central Texas region to support participation in the FY2026 Homeland Security Grant Program – Non-Profit Security Grant Program (NSGP); and,

WHEREAS, the NCTCOG Foundation agrees that, in the event of loss or misuse of Office of Governor grant funds, such funds will be returned to the Office of the Governor in full.

NOW, THEREFORE, BE IT HEREBY RESOLVED THAT:

- Section 1.** The North Central Texas Council of Governments Foundation, Inc., is authorized to apply for, receive, and administer an amount not to exceed \$200,000 in FY2026 Homeland Security Grant Program – Non-Profit Security Grant Program funding to support security enhancements at the Regional Police Academy for the grant period of September 1, 2026, through February 28, 2029.
- Section 2.** The NCTCOG Executive Director or his designee is designated as the authorized official to apply for, accept, execute, reject, alter, or terminate the grant(s) and any subsequent or related agreements on behalf of and in the name of the North Central Texas Council of Governments Foundation, Inc.
- Section 3.** The NCTCOG Director of Administration or his designee is designated as the grantee's financial officer. The financial officer is given the power to submit financial and/or programmatic reports or alter a grant on behalf of and in the name of the North Central Texas Council of Governments Foundation, Inc.
- Section 4.** This resolution shall take effect immediately upon its adoption.
