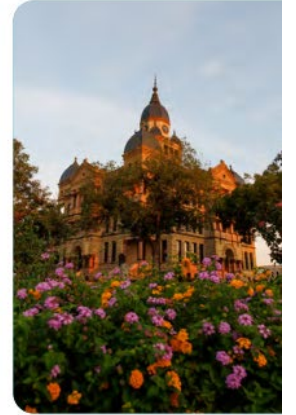

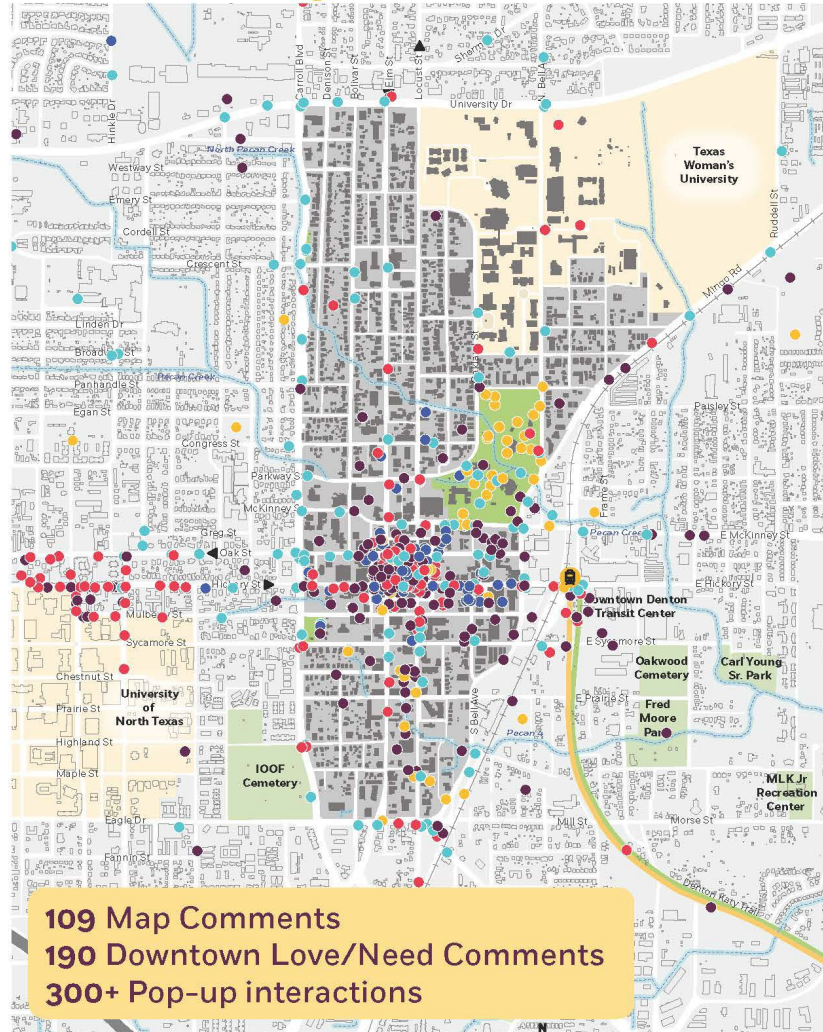

## Traffic and Transit (26 comments)

Address parking on the Square. Some would like to see more street closures for events and gatherings or removing traffic and parking from the Square altogether to create a pedestrian destination. Others want more paid parking to be introduced, a parking garage, and for parking regulations on deliveries to be added and back-in parking rules to be enforced.

***"I like the idea of closing the Square to traffic. Keeps it clean, safe, and allows more outdoor patio space for business."***

## Bike/Pedestrian Mobility (15 comments)

Make road crossings into the park safer, and improve bike network between Quakertown Park, Downtown and neighborhoods.

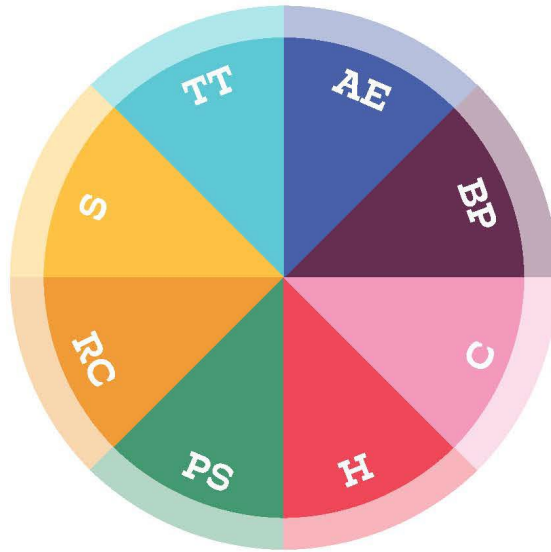

## Bike and Pedestrian Infrastructure (26 of 36 comments in area)

Consider reduction of vehicle lanes and crossing distance, expansion and improvement of protected bike lanes, add pedestrian crosswalks and improve walkability.

***"Protected bike lanes going both directions here...The demand for biking/rolling exists. Our families need protected infrastructure to get to/from school."***

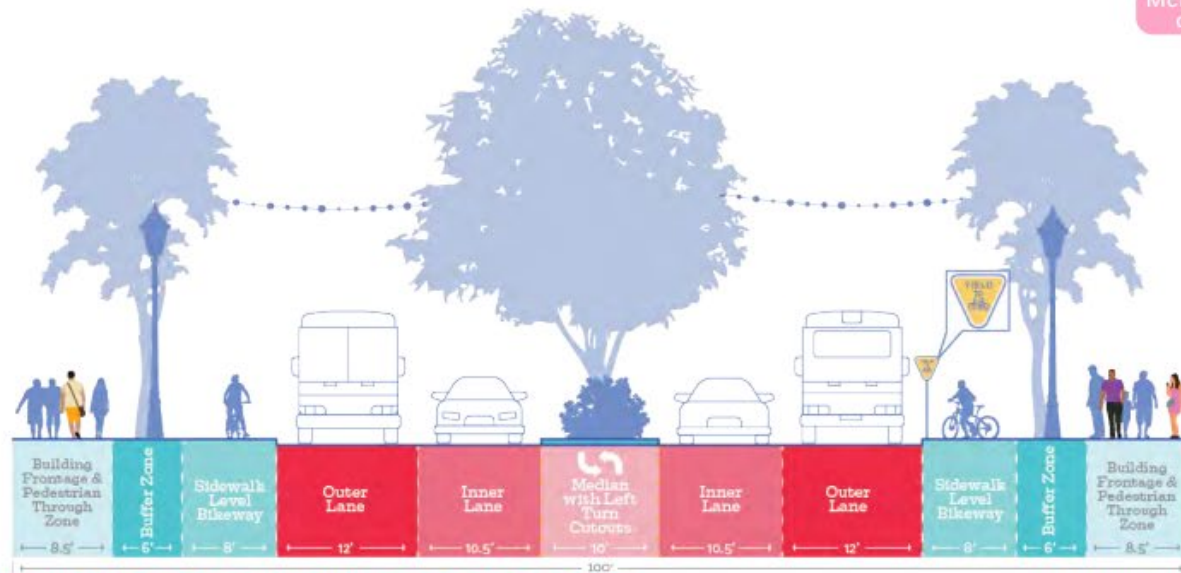

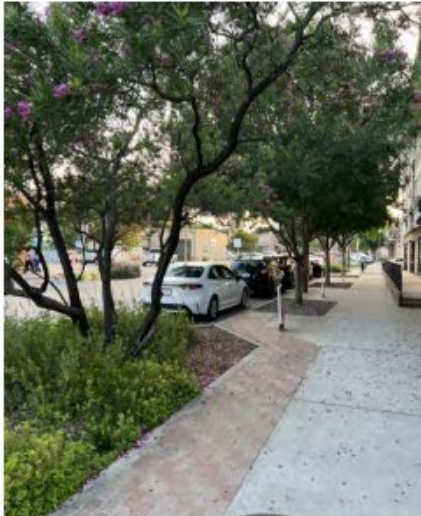
Rightsizing Street Cross Sections to maximize walkability and safety and reduce barriers between Downtown and the adjacent neighborhoods.



Carroll Boulevard Proposed Section

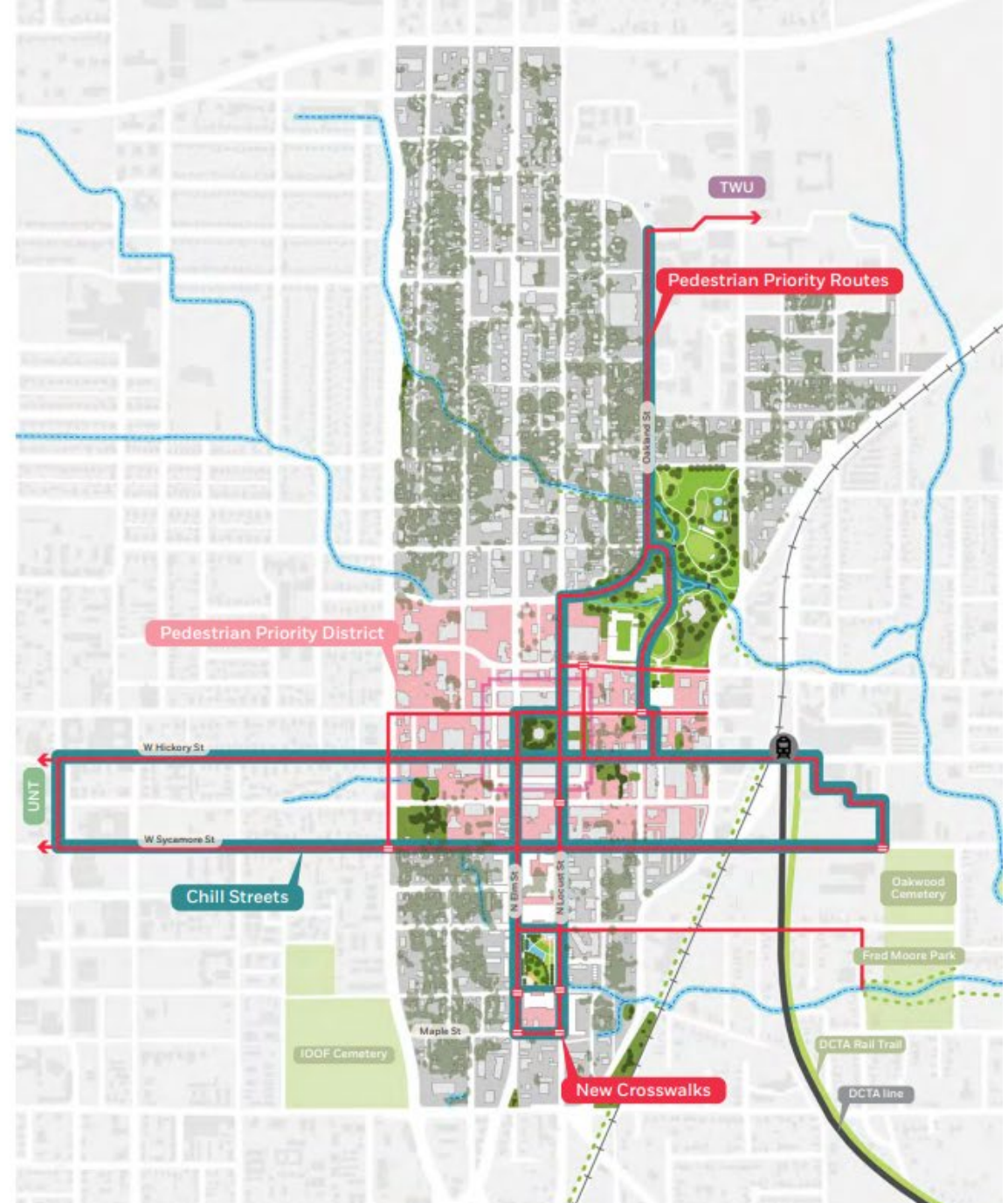


# Pedestrian Priority Routes and Denton Chill Streets



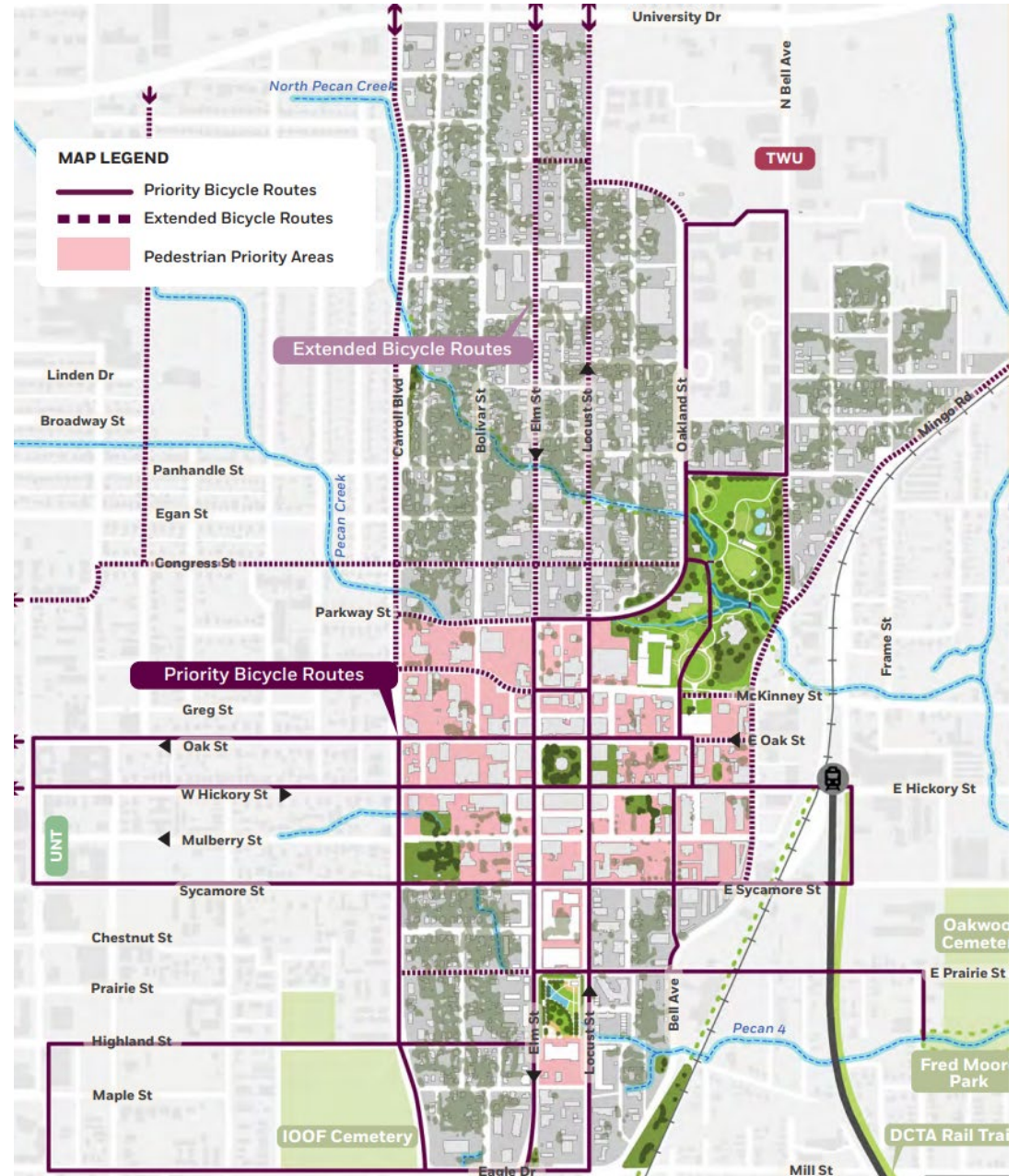

# 1C Improve Bike Connections

- **Build Behind-the Curb Priority network**
  - Focus City funding and construction efforts to prioritize bike lanes that connect to UNT, Denton Square, TWU, and Quakertown Park
  - Extend the curbs along this network so that there is enough space to put bike infrastructure behind it
- **Develop Expanded Protected Bike Network**
  - Update the Mobility Plan to recommend construction of a larger network of protected and behind-the-curb bike lanes
  - Update Denton Development Code (DDC) and Criteria Manual to only implement sharrows\* and non-protective infrastructure where there is not ROW available for protected bicycle infrastructure.
  - Prioritize safety and quality of important routes over quantity of less protected infrastructure.

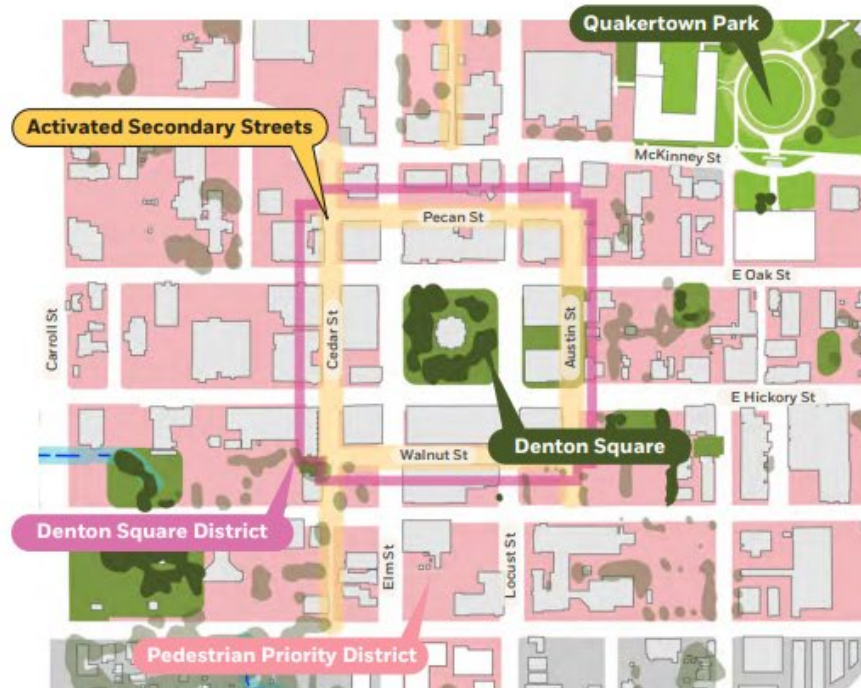

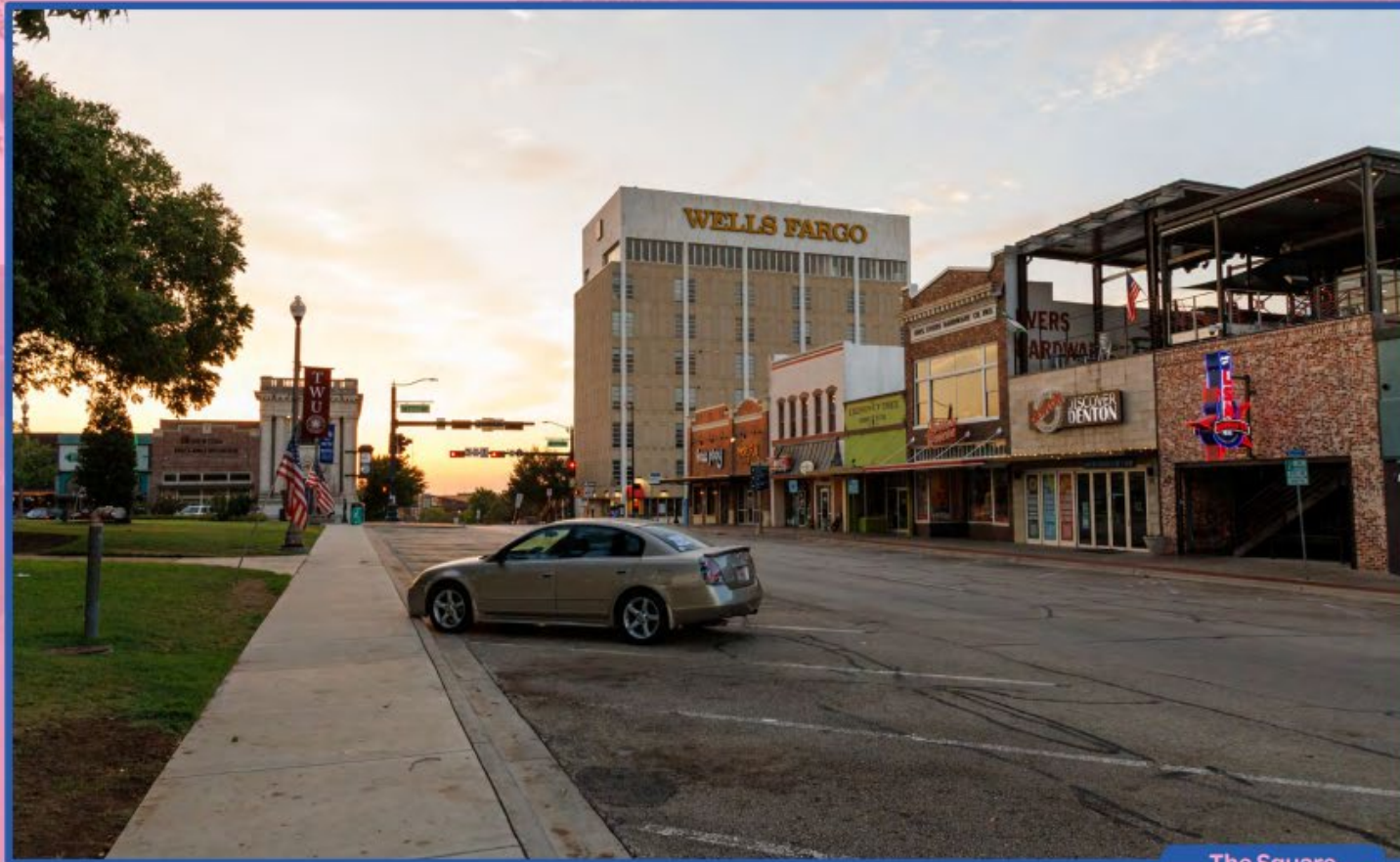


## Activation of Underutilized Streets

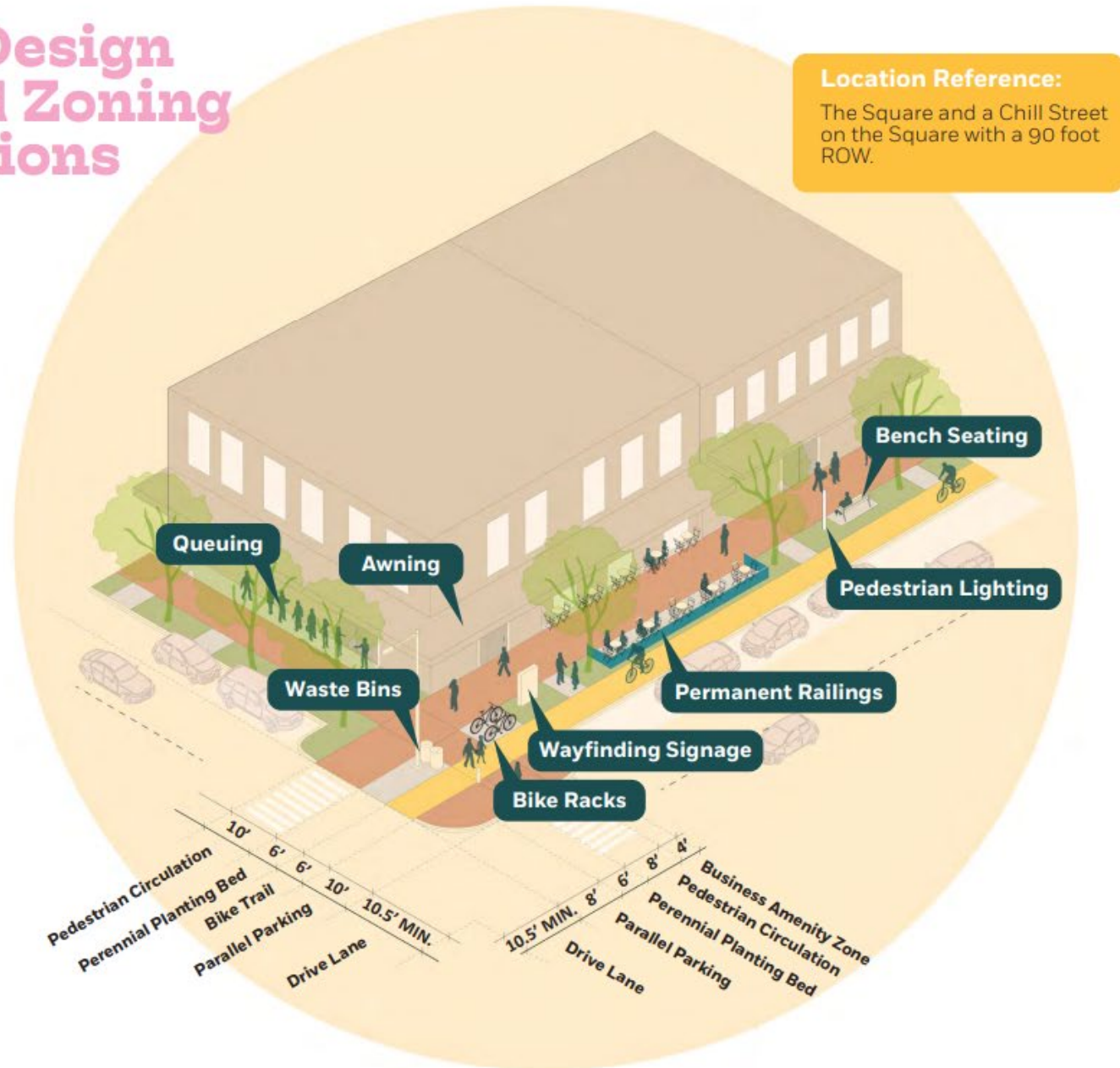

- Update Downtown's zoning south of the Square to support the proposed Public Improvement District and reduce parking requirements.





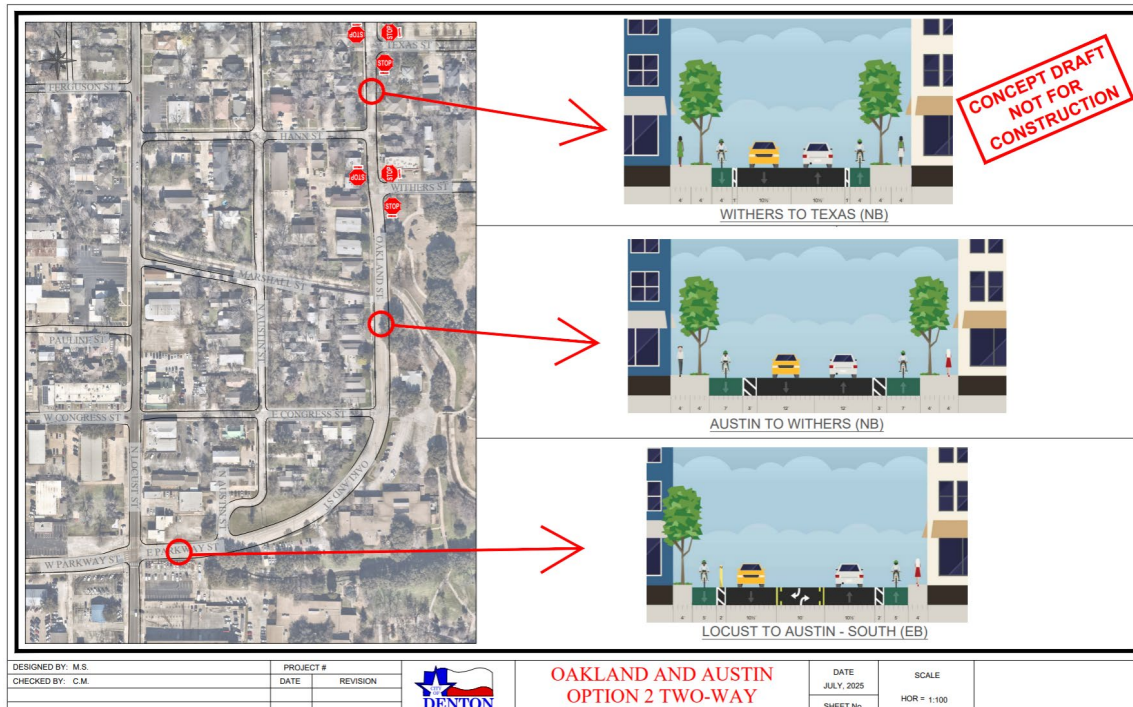

# Implementation

- Design Downtown Denton “Pedestrian Priority Routes” now shaping Capital Projects (*not final*)
- Previously planned capital project to resurface Oakland Street adjusted to align with DDD plan for expanding bike lanes on key routes
- Referencing the DDD provided leverage to engage with TWU, eliminate parallel parking to provide more space => Potential Result: *two-way* protected bike lanes



# Next Steps

- ★ **Continue to partner with Transportation Services to pursue grants for DDD bike/ped improvements**
- ★ **Continue to partner with Capital Projects to prioritize pedestrian space and protected bike lanes in city projects**
- ★ **Pass new standards for private development along Pedestrian Priority Routes and Priority Bicycle Routes**

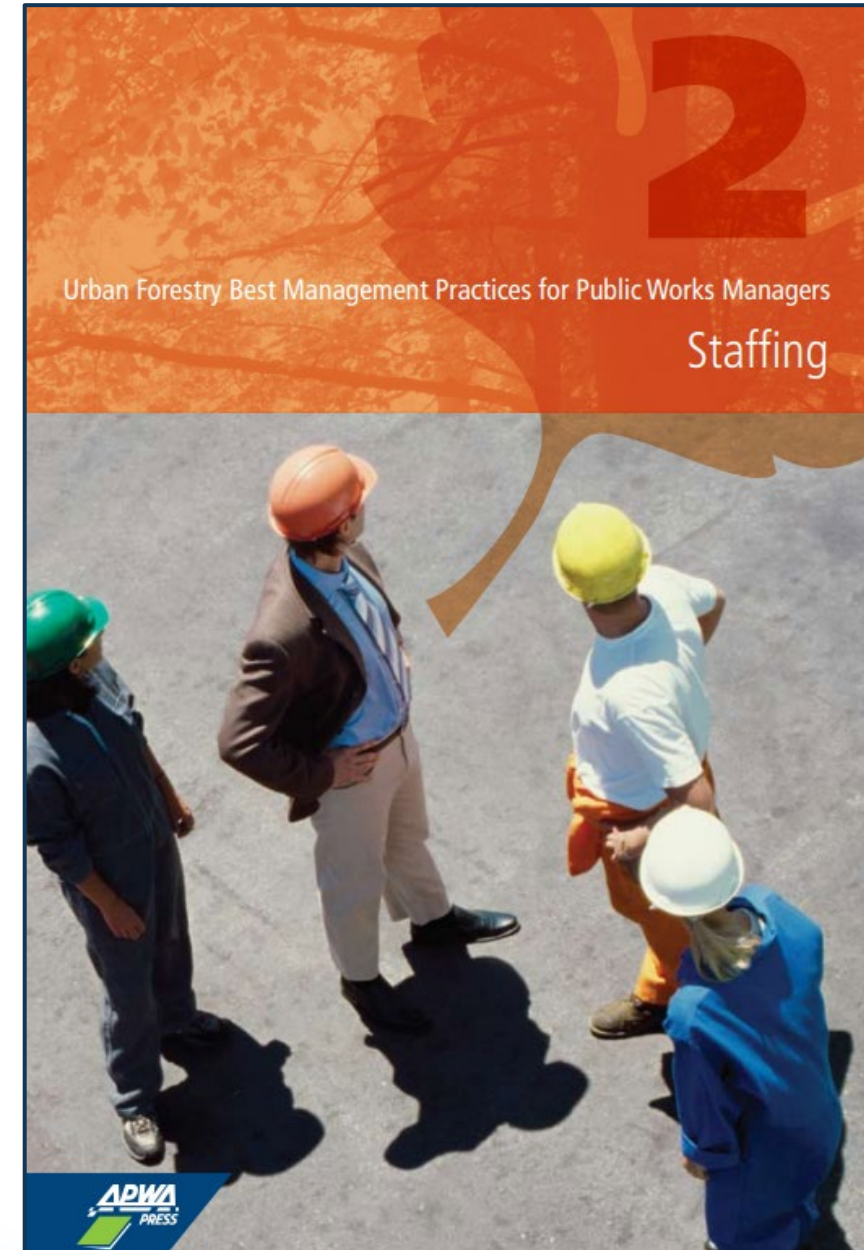
