REGULAR SESSION

PUBLIC COMMENT ON AGENDA ITEMS

President Johnson opened the meeting for public comment and asked if there was anyone present wishing to speak. There being no one, she proceeded with the meeting.

CONSENT AGENDA ITEMS:

Items 1 - 11 were posted on the agenda as Consent Items.

Item 1 Approval of Minutes

Item 2 Resolution Authorizing a Contract for Animal Care Supplies

This item was pulled from the Consent Agenda for Individual Consideration by Councilmember Justice.

Item 3 Resolution Authorizing Contracts for Technical Skills Training

This item was pulled from the Consent Agenda for Individual Consideration by Councilmember Justice.

Item 4 Resolution Authorizing a Contract with Deltek, Inc. for Enterprise Resource Planning Software

Board authorization was requested to enter into a contract with Deltek, Inc. for Enterprise Resource Planning (ERP) software licensing, maintenance, and support services. The proposed agreement is for a maximum term of thirty-eight (38) months and in an amount not to exceed \$655,000. NCTCOG has relied on Deltek's integrated ERP platform for over twenty-nine (29) years to support essential functions including financial management, budgeting, procurement, payroll, human resources, and reporting. Due to the proprietary nature of the system and the significant investment required to transition to a new provider—including time, training, data migration, and reimplementation—staff recommended proceeding with an exemption from competitive procurement.

Item 5 Resolution Endorsing Submittal of a Grant Application to the OOG for the Criminal Justice Program - Justice Assistance Grant (JAG)

This item was pulled from the Consent Agenda for Individual Condiseration by Councilmember Mendelsohn.

Item 6 Resolution Authorizing a Contract with Plug & Play, LLC for the Implementation of the Innovation Ecosystem Pilot Program

This item was pulled from the Consent Agenda for Individual Consideration by Councilmember Johnson.

Item 7 Resolution Endorsing Fiscal Year 2025 Safe Streets and Roads for All Implementation Grant Application to the United States Department of Transportation

Board endorsement was requested for the submittal of a \$12 million application to the United States Department of Transportation (USDOT) under the FY 2025 Safe Streets and Roads for All (SS4A) Implementation Grant Program. The proposed funding will support the Hemphill Street Community Based Safe Street Project in Fort Worth, aimed at significantly reducing roadway fatalities and serious injuries through targeted safety improvements for all users. The total project cost is estimated at \$15 million, with a \$3 million local match provided by the City of Fort Worth. The Regional Transportation Council (RTC) endorsed the application on July 10, 2025. As the RTC's fiscal agent, NCTCOG will coordinate with USDOT to facilitate the transfer of awarded funds to the City of Fort Worth.

Item 8 Resolution Authorizing Amendment to Personal Services Agreement with Ahmad Sadegh to Expedite the Development and Implementation of Regional Multimodal Transportation Data Hub

This item was pulled from the Consent Agenda for Individual Consideration by Councilmember Mendelsohn.

Item 9 Resolution Authorizing Contract with MediaValet USA, Inc. to Provide a Digital Asset Management System

Board authorization was requested to enter a contract with MediaValet USA, Inc. to provide a web-based, digital asset management system in an amount not to exceed \$200,000 over five years. The contract includes an initial one-year term with four optional one-year renewals. MediaValet is the current provider of these services, which support the Transportation Department's management of digital images and video assets. The system integrates with Adobe and Microsoft applications, offers auto-tagging, and enhances departmental efficiency. The procurement process was initiated on March 5, 2025, and two proposals were received. Following evaluation by the Consultant Selection Committee in May 2025, MediaValet was recommended for continued service. This subscription purchase is funded through the Transportation Management and Administration Allocation under Task 1 of the Unified Planning Work Program and does not include subcontracting opportunities.

Item 10 Resolution Authorizing Regional Transportation Council Local Funds to Backstop Local Match Commitments for Diesel Emissions Reduction Act Projects

Board authorization was requested for the use of \$175,000 in Regional Transportation Council (RTC) Local funds to support implementation of a Diesel Emissions Reduction Act (DERA) grant awarded to NCTCOG by the Environmental Protection Agency (EPA). The grant requires a local match, which will be fulfilled through expenditures by rebate participants. To demonstrate project progress, EPA has requested NCTCOG begin drawing down federal funds prior to rebate activity and match collection. While reimbursement could proceed without match, the Transportation Department will follow its standard practice of seeking reimbursement only for the federal share of expenses to mitigate financial risk. The Regional Transportation Council authorized this use of RTC Local funds on July 10, 2025. These funds will be reimbursed upon collection of local match, leveraging \$5.5 million in federal funding.

Item 11 Resolution Authorizing Agreement with City of Colleyville for SH 26 Traffic Signal Maintenance

Board authorization was requested to enter an agreement with the City of Colleyville for the maintenance of ten (10) traffic signals along SH 26 corridor, utilizing up to \$150,000 in Regional Transportation Council (RTC) local funds. The corridor is being removed from the state highway system, and the City has requested funding support for signal maintenance at a rate of \$3,000 per signal annually, totaling \$30,000 per year over five years. The Regional Transportation Council approved this funding on July 10, 2025. Staff noted that the RTC is developing a broader program to address congestion and establish minimum standards for traffic signal reliability and performance, with future updates to be presented to the Executive Board.

Upon a Motion by Commissioner Mitchell (seconded by Mayor Bristol), the Board unanimously approved the Consent Agenda Items as posted with the exception of Items 2, 3, 5, 6, and 8.

ITEMS FOR INDIVIDUAL CONSIDERATION:

Item 2 Resolution Authorizing a Contract for Animal Care Supplies

This item was pulled from the Consent Agenda for Individual Consideration by Councilmember Justice.

Board approval was requested to enter a contractual agreement with Unipak Corp., for Animal Care Supplies, for a maximum five (5) year term. The contract will be available through the TXShare cooperative purchasing program.

Mr. Little mentioned that Item 2 had an amended resolution to retain the services of firms that offer Animal Care Supplies and that the amended resolution was located at each Board member's seat for reference.

Upon a Motion by Commissioner Mitchell (seconded by Mayor Bristol), and unanimous vote of all members present, the Board approved the amended resolution as presented.

Item 3 Resolution Authorizing Contracts for Technical Skills Training

This item was pulled from the Consent Agenda for Individual Consideration by Councilmember Justice.

Board authorization was requested to enter contracts with Coherent Cyber Education LLC, Cengage Learning DBA Infosec, and Mother Daughter ISH, for Online Technical Skills Training, for maximum five (5) year terms.

Additionally, authorization was requested to enter contracts with Earth Forward Group LLC, Kevin Mitch Group Inc., and Telemedia, LLC DBA TPC Training, for Online and On Customer Site Technical Skills Training, for maximum five (5) year terms. All contracts will be made available through the North Central Texas Council of Governments TXShare cooperative purchasing program.

Mr. Little mentioned that Item 3 had an amended resolution to retain the services of firms that offer Online Technical Skills Training and On Customer Site Training Services and that the amended resolution was located at each Board member's seat for reference.

Upon a Motion by Commissioner Mitchell (seconded by Mayor Bristol), and unanimous vote of all members present, the Board approved the amended resolution as presented.

Item 5 Resolution Endorsing Submittal of a Grant Application to the OOG for the Criminal Justice Program - Justice Assistance Grant (JAG)

This item was pulled from the Consent Agenda for Individual Consideration by Councilmember Mendelsohn.

Christy Martinez, Director of Regional Police Academy, requested Board endorsement for the submittal of a Criminal Justice Program – Justice Assistance Grant (JAG) application to the Office of the Governor's Public Safety Office, in an amount up to \$143,740. The proposed funding would support the expansion of NCTCOG's Regional Police Academy (RPA) Law Enforcement Training Program by funding an additional Police Training Coordinator position. This role would enable the RPA to add two Basic Peace Officer Courses (BPOCs) to its annual training calendar. Each BPOC consists of 880 hours of instruction and prepares recruits for peace officer licensing in Texas. The expansion is expected to significantly increase police recruit enrollment, helping to meet regional workforce demands and enhance the hiring capacity of local law enforcement agencies with qualified, professionally trained officers.

Councilmember Mendelsohn commended the initiative to seek additional support for training efforts and inquired about the adequacy of current training space. Ms. Martinez acknowledged that space limitations remain an ongoing challenge. She noted that the Law Enforcement Training Advisory Committee (LETAC) is actively exploring the possibility of establishing satellite campuses to address the issue. While no specific location has been finalized, there are contingency options available on COG's premises should a satellite site not be secured.

Upon a Motion by Councilmember Mendelsohn (seconded by Commissioner Mitchell), and unanimous vote of all members present, the Board approved the resolution as presented.

Item 6 Resolution Authorizing a Contract with Plug & Play, LLC for the Implementation of the Innovation Ecosystem Pilot Program

This item was pulled from the Consent Agenda for Individual Consideration by Councilmember Johnson.

Phedra Redifer, Executive Director for Workforce Development, requested Board authorization to enter a contract with Plug & Play, LLC for the implementation of the Innovation Ecosystem Pilot at Tarleton State University's (TSU) Stephenville campus. The contract will span up to 18 months and will not exceed \$170,000. This initiative is part of the Workforce Innovation Fund Grant, for which North Central Texas was one of five workforce boards selected statewide. In collaboration with Plug & Play, TSU, and Workforce Solutions for North Central Texas, the pilot aims to stimulate innovation, entrepreneurship, job creation, and economic development in rural areas. Plug & Play will

lead the development and execution of key program components, including entrepreneurship workshops, campus innovation events, networking opportunities, business pitch sessions, access to venture capital, internships, a founder's toolkit, and student engagement activities with Stephenville ISD. Plug & Play and TSU were named as critical partners in the grant application and are essential to the pilot's success.

Councilmember Johnson pulled this item from the Consent Agenda to highlight its significance, and Judge Boedeker expressed appreciation for the staff's efforts.

Upon a Motion by Judge Huckabee (seconded by Councilmember Hogg), and unanimous vote of all members present, the Board approved the resolution as presented.

Item 8 Resolution Authorizing Amendment to Personal Services Agreement with Ahmad Sadegh to Expedite the Development and Implementation of Regional Multimodal Transportation Data Hub

This item was pulled from the Consent Agenda for Individual Consideration by Councilmember Mendelsohn.

Michael Morris, Director of Transportation, requested Board authorization to amend the Personal Services Agreement with Ahmad Sadegh by adding an amount not to exceed \$250,000 in Regional Toll Revenue (RTR) funds. Mr. Sadegh provides technical support for the development and implementation of the Regional Multimodal Transportation Data Hub and other initiatives, including wrong-way driver alert systems and connected/autonomous vehicle projects. The original agreement, approved by the Board on July 27, 2023, was for an amount not to exceed \$200,000. NCTCOG seeks to continue retaining Mr. Sadegh's services under the exemption from competitive bidding provided by Texas Local Government Code §252.022(a)(4). No local match is required for this amendment.

Judge Jenkins made a motion to approve an amended resolution with the condition that only initiatives approved by the Regional Transportation Council would be performed under the personal services agreement (seconded by Councilmember Mendelsohn). By unanimous vote of all members present, the Board approved the resolution as amended.

Item 12 Resolution to Accept and Approve the Quarterly Investment Report

Randy Richardson, Director of Administration, provided the Investment Report for the quarter ended June 30, 2025, and requested Board acceptance and approval. This report is required by the Investment Policy and Public Funds Investment Act and shows an average rate of return, cumulative transactions and beginning and ending balances for the quarter.

Upon a Motion by Judge O'Hare (seconded by Commissioner Mitchell), and unanimous vote of all members present, the Board approved the resolution as presented.

Item 13 Resolution Endorsing the 2025 Update to the North Central Texas Water Quality Management Plan

Susan Alvarez, Director of Environment and Development, requested Board endorsement for the 2025 Update to the North Central Texas Water Quality Management Plan (WQMP) and authorization to transmit relevant materials to the Texas Commission on Environmental Quality (TCEQ) for certification and subsequent transmission to the U.S. Environmental Protection Agency (EPA) for approval. The WQMP is updated annually to support regional planning efforts related to water quality, wastewater infrastructure, and watershed management. Developed with input from the Water Resources Council, and presented as an online Story Map Journal, the 2025 Update was endorsed by the Water Resources Council on July 9, 2025. Funding for the plan is provided by TCEQ. The full 2025 Update to the North Central Texas Water Quality Management Plan is available at: https://storymaps.arcgis.com/stories/3f2e3d10cdd44dec8db41fc187a95a81/

Mayor Bristol asked about several sanitary sewer overflows (SSOs) marked on the regional map within his community, noting that he was unaware of any incidents occurring in 2024. Ms. Alvarez clarified that the utility responsible for the system is charged with both identifying and correcting SSOs, and that as part of their annual reporting to the Texas Commission on Environmental Quality (TCEQ), they estimate the volume discharged and document the resolution of each event. It was noted that SSOs are a widespread issue and not unique to any one community. Judge Boedeker asked whether the increasing number of municipal utility districts (MUDs) and privately operated wastewater disposal facilities has impacted the regional wastewater quality plan. Ms. Alvarez responded that no direct impact has been observed at this time, though they actively track the formation of new MUDs and share that information with the Water Resources Council. MUDs are considered a useful mechanism for extending sanitary sewer service to rural or developing areas, but they present ongoing challenges related to operations and maintenance.

Upon a Motion by Councilmember Horne (seconded by Councilmember Justice), and unanimous vote of all members present, the Board approved the resolution as presented.

Item 14 Comprehensive Resolution Authorizing Fiscal Years 2026-2027 Funding Initiatives Supporting Sustainable Environmental Excellence

Susan Alvarez, Director of Environment and Development, requested Board authorization for the following FY 2026-2027 funding initiatives supporting Sustainable Environmental Excellence:

- NCTCOG is authorized to execute necessary agreements with the Texas Commission on Environmental Quality (TCEQ) for funding in an amount of approximately \$290,000 in federal/state funds per annum through FY2027 to allow NCTCOG to carry out its responsibilities as the designated area-wide water quality management planning agency, consistent with the work program initiatives endorsed by NCTCOG's Water Resources Council and approved by the TCEQ.
- NCTCOG is authorized to execute necessary agreements with TCEQ and associated program recipients for Watershed Nonpoint Source Pollutant funding in an amount of approximately \$150,000 in federal/state funds per annum through FY2027 to allow NCTCOG to conduct a nonpoint source management initiative in water quality impaired watersheds in the Greater Trinity River basin.
- NCTCOG is authorized to seek and accept fee-for-service funding from local governments and regional
 agencies in an amount of approximately \$800,000 per annum through FY2027 for stormwater management
 initiatives and monitoring contract services consistent with the work programs endorsed by NCTCOG's
 Regional Stormwater Management Coordinating Council.
- NCTCOG is authorized to seek and accept fee-for-service funding from cities and counties, and also funding
 from state or federal agencies for flood risk reduction efforts along the Trinity River corridor in an amount of
 approximately \$300,000 per annum through FY2027 for the Trinity River COMMON VISION program,
 consistent with the work program initiatives endorsed by the Trinity River COMMON VISION Steering
 Committee.
- NCTCOG is authorized to seek and accept fee-for-service funding from local governments and regional
 agencies in an amount of approximately \$600,000 per annum through FY2027 for public works initiatives
 consistent with the work programs endorsed by NCTCOG's Public Works Council.
- NCTCOG is authorized to seek and accept fee-for-service funding from local governments and regional
 agencies in an amount of approximately \$150,000 per annum through FY2027 for wastewater and treatment
 initiatives consistent with the work programs endorsed by NCTCOG's Wastewater and Treatment Education
 Roundtable.
- NCTCOG is authorized to execute necessary agreements with the Federal Emergency Management Agency (FEMA) and/or the Texas Water Development Board for funding in an amount of approximately \$100,000 per annum through FY2027 to build on the Cooperating Technical Partners for flood risk reduction, consistent with the work program initiatives endorsed by NCTCOG's Public Works Council.
- NCTCOG is authorized to execute necessary agreements with the Texas Department of Agriculture to support the Texas Community Development Block Grant program in an amount of approximately \$25,000 in

federal/state funds per annum through FY2026 for providing administrative services and technical assistance through Community and Economic Development Assistance funding.

- NCTCOG is authorized to seek and accept fee-for-service funding from local governments and regional
 agencies in an amount of approximately \$100,000 per annum through FY2027 for building codes
 coordination initiatives consistent with the work programs endorsed by NCTCOG's Regional Codes
 Coordinating Committee.
- NCTCOG is authorized to execute necessary agreements with the State Energy Conservation Office
 (SECO) for funding in an amount of approximately \$650,000 in federal/state funds through FY2027 to build
 upon efforts towards reductions in energy consumption and resulting improvements to air quality, consistent
 with the Principles of Development Excellence and recommendations within Vision North Texas.
- NCTCOG is authorized to seek and accept fee-for-service funding from local governments and regional
 agencies in an amount of approximately \$100,000 per annum through FY2027 for engaging interested local
 governments in peer-exchange opportunities to support sustainability and environmental initiatives
 consistent with the work program requested by NCTCOG's Regional Integration of Sustainability Efforts
 (RISE) Coalition.
- NCTCOG is authorized to continue to conduct Center of Development Excellence and Vision North Texas outreach to member local governments, the development community, and other interested parties.
- NCTCOG is authorized to pursue other opportunities for cooperation or funding to implement the Sustainable Environmental Excellence visions, strategic plan, and objectives through FY2027, including but not limited to, cooperative activities and drafting of memoranda of agreements with state and federal partners, extension of interagency agreements to other local governments, identification of additional funding sources, and participation in and support of initiatives by other agencies.

Councilmember Johnson inquired about a circulating rumor regarding the potential end of Community Development Block Grant (CDBG) funding and asked what types of projects might be affected if the funds were discontinued. Ms. Alvarez responded that CDBG funds are primarily used to support rural development initiatives. While current funding levels are about half of what was previously available, they still exceed initial expectations. She noted that the program may be nearing the end of its funding cycle. Potential uses of remaining funds could include updating codes, developing policies, and establishing programs to increase public awareness and understanding. Mayor Hulsey asked for clarification on Item 8, which pertains to CDBGs. Ms. Alvarez explained that these grants are typically small and locally focused, aimed at encouraging economic development in rural communities. They are sometimes used to support policy development and public outreach efforts, but their primary purpose is to provide local support for economic growth.

Item 15 Resolution Approving Scoring Criteria for Charging and Fueling Infrastructure Community Electric Vehicle Charging Grant Call for Projects

Michael Morris, Director of Transportation, requested Board approval for the scoring criteria associated with the Charging and Fueling Infrastructure (CFI) Community Electric Vehicle Charging Grant Call for Projects. This initiative, supported by the Federal Highway Administration (FHWA), aims to strategically deploy electric vehicle (EV) charging stations across the North Central Texas region. Screening criteria are based on FHWA program requirements and elements included in NCTCOG's original grant proposal. Eligible projects will be evaluated and prioritized based on scoring criteria detailed in the following table:

This information was presented at the June Board meeting as part of a status update. The Regional Transportation Council approved the Call for Projects, including eligibility, screening and scoring criteria, and the schedule, at its July 10 meeting. Recommendations for final site selection and EV charging station vendor(s) will be brought for Board approval at a future date.

Councilmember Horne raised a question regarding areas with insufficient electric vehicle (EV) charging infrastructure and the regional population of EVs, referencing a "barbell approach" to deployment. Mr. Morris acknowledged the concern and noted that current forecasts reflect short-term trends. He explained that while an initial score may be assigned to a location, that score can decrease as more charging stations are added to the system, which currently applies only to public land. A method is in place to update mobile software applications with real-time information on charging station availability. Mr. Morris confirmed that there is a commitment requirement: each station must remain operational for at least five years, with a portion of the revenue generated allocated to cover ongoing operations and maintenance. Judge Hill inquired whether stations on public property would be accessible only to government entities or also to the private sector. Mr. Morris clarified that the stations are open to everyone.

Item 16 Resolution Authorizing Agreement with the North Texas FWC Organizing Committee for the Operation of Bus Shuttles and Direct Services During 2026 World Cup Events

Michael Morris, Director of Transportation, requested Board authorization to enter into a contractual agreement with the North Texas FWC Organizing Committee to provide charter bus services for the 2026 FIFA World Cup. The agreement will support direct transportation from the Trinity Railway Express (TRE) Centreport Station to Lot H in Arlington on nine designated event days. On March 13, 2025, the Regional Transportation Council (RTC) approved up to \$3,600,000 in RTC Local funds for this purpose. The funding will cover bus operations and related services and is structured as a loan to be reimbursed by the Dallas Sports Commission upon completion of the tournament. Transportation Department staff have been actively coordinating with regional stakeholders to ensure mobility needs are met in preparation for hosting the World Cup. A map showing the charter bus route is included for reference.



Item 17 Resolution Approving the <u>FY2026 and FY2027 Unified Planning Work Program</u> for Regional Transportation Planning

Michael Morris, Director of Transportation, requested Board approval for the FY2026 and FY2026 and FY2026 and FY2026 and FY2027 Unified Planning Work Program for Regional Transportation Planning (UPWP). The UPWP outlines transportation and related air quality planning activities to be conducted from October 1, 2025, through September 30, 2027, and identifies the funding sources that support the Metropolitan Planning Organization (MPO). These activities carried out by the North Central Texas Council of Governments (NCTCOG) staff, are primarily funded through Federal Highway Administration (FHWA) PL 112 funds and Federal Transit Administration (FTA) 5303 funds, both allocated to NCTCOG through formula distribution. The UPWP ensures compliance with federal planning requirements and supports regional mobility, air quality improvements, and long-range transportation goals. The UPWP has been approved by the Surface Transportation Technical Committee and the Regional Transportation Council. Item 18 Status Report on Disadvantaged Business Enterprise Goal Update for US Department of Transportation Contracting Opportunities

Ken Kirkpatrick, General Counsel, provided a status report on the Disadvantaged Business Enterprise (DBE) Goal, which is required to be updated every three years by the Federal Transit Administration. The DBE goal applies to U.S. Department of Transportation-assisted contracting opportunities and is designed to ensure fair competition and remove barriers for small businesses owned by socially and economically disadvantaged individuals. The current DBE Participation Goal of 17% remains in effect through September 30, 2025. Staff have developed draft DBE goals for Fiscal Years 2026–2028 based on federal regulations and have initiated a public comment process. The update also considers recent legal developments, including the Mid-America Milling Company case in the U.S. District Court for the Eastern District of Kentucky, which challenges the constitutionality of race- and sex-based presumptions in the DBE program. Approval of the DBE goal is scheduled for the August 28, 2025, Executive Board meeting following the conclusion of the public input period.

Item 19 Status Report on Metropolitan Planning Organization Planning Agreement Two Year Extension

Michael Morris, Director of Transportation, provided a status report on the Metropolitan Planning Organization (MPO) and the recent extension of the MPO Planning Agreement. The Texas Department of Transportation (TxDOT) has unilaterally extended the agreement by two years, now valid through September 30, 2027. This extension does not require approval from the Regional Transportation Council (RTC) or the North Central Texas Council of Governments (NCTCOG) Executive Board.

NCTCOG and the RTC jointly serve as the MPO for the Dallas–Fort Worth metropolitan area. RTC functions as the MPO Policy Committee, responsible for setting transportation policy and adopting key planning documents such as the Metropolitan Transportation Plan, Transportation Improvement Program, and Unified Planning Work Program. The NCTCOG Executive Board acts as the Fiscal Agent, overseeing fiscal, personnel, and staff support services, including administration of federal transportation planning funds. Item 20 Status Report on Flooding and Disaster Preparedness

A joint presentation was delivered by the Directors of Environment and Development, Emergency Preparedness, and Transportation to provide a comprehensive status report on current flooding and disaster preparedness efforts across the North Central Texas region. In light of the devastating July 4th floods in the Texas Hill Country, which claimed over 130 lives and overwhelmed local infrastructure, the North Central Texas Council of Governments (NCTCOG) has intensified its regional coordination to mitigate future disaster impacts. The presentation highlighted ongoing initiatives across departments, including policy development, regional planning, deployment of flood warning technologies, and practical training programs. These efforts aim to strengthen community resilience across NCTCOG's 16-county service area. Notably, the Environment and Development Department continues to support floodplain management through programs like the Community Rating System and the Regional Flood Warning Software Program.

Mr. Little also shared developments from the Regional Police Academy, including discussions about expanding capacity to meet growing demand. The academy currently trains approximately 300 recruits annually, with projections to reach 370 recruits in the next fiscal year. He concluded by highlighting upcoming committee meetings, including the Bylaws Committee scheduled for August 21st, the Finance Committee on August 28th, the Audit Committee planned for February, and the Long Range Planning Committee set for October.

Item Title: Resolution Authorizing a Contract with Nearmap to Provide Recurring Aerial and

Oblique Imagery Services

Since 2001, NCTCOG has facilitated the purchase of high-quality, color, digital aerial photography and derivative products for North Central Texas as a cost-sharing objective for public and private entities under its Spatial Data Cooperative Program. In 2020, NCTCOG began offering a service for subscription-based orthophotography and oblique data.

Specifically, this service includes imagery captured 2 to 3 times a year at six-inch or higher resolution for those entities who sign on to participate. The data delivers within 30 days of the flight, which is ideal for participants who need the imagery quickly. The current contract for this service will expire on November 30, 2025, and participating entities have requested a continuation of the project. Funding for the project will be provided entirely by regional participants.

NCTCOG conducted Request for Proposals (RFP) #2025-073, which closed on August 4, 2025, and, following evaluation, is recommending Nearmap, again, to perform these services. Nearmap is a leading provider of cloud-based geospatial information services with offices in the US and Australia and is ranked one of the ten largest aerial survey companies in the world for annual data collection volumes. If awarded, the project is anticipated to begin in December 2025.

A draft resolution authorizing a contract with Nearmap for orthophotography and oblique imagery services for a maximum five (5) year term and in an amount not to exceed \$3,000,000 is attached for Executive Board consideration.

Item Title: Resolution Authorizing Agreements with Additional Rebate Recipients for the

North Texas Diesel Emissions Reduction Project

The Regional Transportation Council (RTC) opened the North Texas Diesel Emissions Reduction Project (NTDER) Call for Projects (CFP) on December 16, 2024. This initiative is funded from approximately \$1.6 million previously awarded from the Environmental Protection Agency (EPA) National Clean Diesel Funding Assistance Program to reduce emissions of ozone-forming nitrogen oxides from diesel-powered heavy-duty vehicles or equipment in the Dallas-Fort Worth 10-county ozone nonattainment area by replacing older, high-emitting vehicles, engines, or equipment with new, low-emitting vehicles, engines, or equipment, as well as installing locomotive idle-reduction technology and related infrastructure.

Eligible applicants of NTDER include private companies and public entities such as local governments who own heavy-duty diesel vehicles or equipment operating in the nonattainment area and who have adopted the RTC Clean Fleet Policy. Nearly 100 entities have adopted the RTC policy. A list of entities who have adopted the RTC Clean Fleet Policy is available at www.nctcog.org/fleetpolicy.

Based on two applications and available NTDER funding, one eligible project was received from Dallas-Fort Worth International Airport and one eligible project was received by Delta Air Lines. Staff recommends rebate awards to Dallas-Fort Worth International Airport not to exceed a total of \$335,250 in EPA funds to replace one diesel vehicle with a newer, zero-emission vehicle and to Delta Air Lines not to exceed a total of \$379,426 in EPA funds to replace ten diesel nonroad equipment with newer, zero-emission nonroad equipment. As required by the EPA for replacement projects, Dallas-Fort Worth International Airport and Delta Air Lines will provide a local contribution of at least 55 percent of the project cost. The proposed project will benefit residents because it reduces diesel engine emissions that create ground-level ozone and reduces noise. The RTC approved funding for this CFP recommendation at its August 7, 2025, meeting. After funding the recommendation, a balance of approximately \$560,000 remains for the NTCDP and will be made available through continuing funding opportunities. In its role as RTC's fiscal agent, Executive Board approval will be requested to enter into agreements with Dallas-Fort Worth International Airport and Delta Air Lines to carry out this RTC initiative.

Item Title: Resolution Authorizing an Agreement with Feonix Mobility Rising for a

Transportation Assistance Hub through the Transit Strategic Partnership

Program

The North Central Texas Council of Governments (NCTCOG) is a designated recipient for Federal Transit Administration (FTA) Section 5310 Enhanced Mobility of Seniors and Individuals with Disabilities Program funds in the Dallas-Fort Worth-Arlington Urbanized Area. These funds are allocated to NCTCOG by the Regional Transportation Council (RTC). As a designated recipient, NCTCOG reserves a portion of the funding and awards it for eligible transit projects serving transit-dependent individuals through the Transit Strategic Partnerships Program, ensuring they address service gaps in the region and fulfill eligibility requirements of the federal funding programs.

Staff reviewed projects submitted in the May 2024 Cycle of the Transit Strategic Partnerships Program and one project was selected and recommended for funding, Feonix Mobility Rising. Through a Transportation Assistance Hub, Feonix Mobility Rising will offer mobility navigators to connect riders with existing public and private transportation services and create sustainable mobility plans to meet their needs. For those riders in Southern Dallas County and Northern Ellis County, Feonix Mobility Rising would offer volunteer drivers to fill gaps in service to mobility impaired residents and senior citizens where no other service is available or accessible. The RTC approved funding for this project on October 17, 2024, and is requesting implementation through NCTCOG. Executive Board, in its role as RTC's fiscal agent, is requested to authorize an agreement with Feonix Mobility Rising for an amount not to exceed \$705,851 (\$454,648 Federal and \$251,203 Local). Item Title: Resolution Endorsing the 2024 International Fire Code and Regional Code

Amendments

The North Central Texas Council of Governments (NCTCOG) has actively promoted the standardization of model construction codes since 1967 when the Regional Codes Strategy Committee first documented the wide disparity in codes used by cities in the region. NCTCOG has continued to serve as a facilitator in the recommendation of model codes, code standards, and regional amendments to the model codes. The goal of the Regional Codes Coordinating Committee (RCCC), NCTCOG's codes advisory committee, is to standardize the model codes used throughout North Central Texas. Composed of public and private sector code professionals, the RCCC and its five advisory boards encourage the adoption of the latest codes and NCTCOG regional amendments to reduce the variation of local construction codes in the region.

By encouraging cities to adopt standardized codes and regional amendments, NCTCOG has helped North Central Texas municipalities reduce the cost of training codes personnel. These efforts have also made it easier for contractors, builders, and developers to do work from city to city throughout the region, thereby reducing overall construction costs.

To continue these code uniformity initiatives, the RCCC's Advisory Boards conducted several open review meetings to review and develop regional amendments to the 2024 Editions of the: International Building Code, International Residential Code, International Existing Building Code, International Swimming Pool and Spa Code, International Plumbing Code, International Mechanical Code, International Fuel Gas Code, and the International Energy Conservation Code.

The RCCC reviewed and approved the regional amendments to the aforementioned codes on February 27, 2025, and at their recommendation, the NCTCOG Executive Board endorsed these regional amendments at the March 27, 2025 meeting.

The 2024 Edition of the International Fire Code required additional review time and received the RCCC final approval on July 15, 2025. The amendment package can be viewed at https://www.nctcog.org/envir/regional-building-codes/amendments.

The RCCC is seeking NCTCOG Executive Board action and endorsement of the recommended regional amendments to the 2024 Editions of the International Fire Code. Additionally, in an effort to achieve regional code uniformity, the RCCC is seeking the Executive Board's recommendation that all cities in the North Central Texas region adopt the 2024 International Fire Code and corresponding regional amendments. I will be available to answer any questions prior to requesting Board approval.



Item Title: Resolution Authorizing Contracts for Phase 2 of the UAS Airspace Awareness

Pilot Program

The North Central Texas Council of Governments (NCTCOG) issued a procurement for Phase 2 of the UAS Airspace Awareness Pilot Program on May 9, 2025. Phase One sought firms to provide a tool that will keep residents and businesses informed on local drone operations by providing live data. Phase Two is necessary to continue activities of Phase One while also working to develop a process that will enable the sharing of data across all platforms. Consistent with the NCTCOG pilot program effort, eligibility for Phase 2 was limited to the vendors that participated in Phase 1. Phase 1 participants were not required to participate in Phase 2. Phase 2 advances the region's capability to monitor and manage low-altitude UAS activity, centralizes municipal drone advisory entry under NCTCOG to improve workflow, expands participating cities, and enhances interoperability across platforms via a unified operating dashboard. The program aligns with the FAA's UTM Key Site initiative by facilitating safe, standards-based data sharing among regional partners.

Two proposals were received in response to the Request for Proposals. The Selection Committee recommends both firms, AirDEX, Inc. (dba ATAA Aviation) and Airspace Link, Inc. for this initiative. Efforts will focus on data integration, advisory interoperability, and regional stakeholder support. Executive Board, in its role as RTC's fiscal agent, is requested to authorize contracts with ATAA Aviation and Airspace Link, Inc. for Phase 2 of the UAS Airspace Awareness Pilot Program. Each entity will receive an amount not to exceed \$150,000 for a total of \$300,000. Funding for this effort is RTC Local funds.

A draft resolution authorizing contracts with ATAA Aviation and Airspace Link, Inc. for Phase 2 of the UAS Airspace Awareness Pilot Program is attached for Executive Board consideration. I will provide a brief presentation on this item and will be available to answer any questions prior to requesting Board approval.

The Regional Transportation Council approved the proposed goal at its August 7, 2025 meeting. Additional information is included in the attached presentation. No substantive changes have been made since the presentation of this item at the July Executive Board meeting.



Context of DBE Goal Update Mid-America Milling Company vs. USDOT

Mid-America filed a lawsuit in the U.S. District Court in Eastern District of Kentucky in 2023 challenging the constitutionality of the DBE program.

Challenge is based on the use of race- and sex-based presumptions under the equal protection component of the Due Process Clause of the 5^{th} Amendment.

Proposed Joint Consent Order filed with the Court (May 28, 2025)

Defendants (USDOT) are stipulating the DBE Program's use of race- and sexbased presumptions are unconstitutional.

USDOT re-evaluated prior position based on Supreme Court's decision in Students for Fair Admissions, Inc. v. President & Fellows of Harvard College

Various Minority Contracting Associations have been granted authority to intervene and are opposing the Entry of the Joint Consent Order

Item Title: Resolution Authorizing the Procurement of a Consultant for the NCTCOG Strategic

Vision Plan

The population in the North Central Texas region grew by over 234,000 in 2024. The region is projected to grow from a current population of 8.7 million to 12.6 million by 2050. This continued growth will create opportunities and challenges for local governments across all facets of life in North Central Texas including economic development, water and solid waste resources, transportation infrastructure and services, workforce training and development, emergency communications, planning and response, and needs of a growing population of older adults, among other critical issues faced by local governments across the region.

Staff is proposing to initiate a long-term visioning process to develop the North Central Texas Council of Government's (NCTCOG) Strategic Vision Plan through 2050 to best position the organization to be responsive to member governments in meeting these opportunities and challenges to improve the quality of life in North Central Texas. This strategic direction will ensure NCTCOG continues to evolve and adapt in carrying out its mission to assist in regional planning, strengthen the individual and collective power of local governments, help local governments recognize regional opportunities, eliminate unnecessary duplication and make joint decisions for the benefit of all citizens in North Central Texas. To that end, staff is requesting the Executive Board authorize the initiation of a formal procurement process for a consultant to assist in developing the NCTCOG Strategic Vision Plan.

The proposed visioning process is intended to be a forward-looking and stakeholder-informed initiative that complements, but remains distinct from, our recurring five-year strategic plan. The five-year strategic plan is primarily shaped by state and federal grant requirements, which account for approximately 80% of our agency's funding. As the majority of NCTCOG staff focus on delivering these federal and state initiatives, at times in alignment with related local funding initiatives, this visioning process will consider how these grant-driven priorities continue to be delivered effectively, how they fit within broader regional needs, and how we can address the full range of regional needs and opportunities, including identifying funding sources for those that extend beyond our traditional grant funding opportunities.

Key foundational questions to be answered through this process include examples such as:

- Who does the NCTCOG want to be as an agency?
- How should NCTCOG best position itself to serve its local government members?
- What are the key regional challenges of which the NCTCOG plans to lead the development of the response?
- How should our structure, capabilities, and partnerships evolve to position the NCTCOG for a strategic future impact?
- How does the NCTCOG align our internal capabilities and external partnerships to get there?

Through this procurement, NCTCOG seeks to procure a consultant who will:

- Facilitate a multi-phase visioning effort that includes agency leadership, the Executive Board, and regional stakeholders
- Conduct organizational assessments and peer benchmarking
- Help articulate a long-term vision for NCTCOG that is aspirational, actionable, and regionally relevant
- Deliver a strategic implementation roadmap to guide agency priorities over time

Key deliverables from this procurement and awarded consultant include:

- Executive summary of the visioning process and outcomes
- A stakeholder-informed vision narrative for the agency's future
- Insightful analysis of emerging opportunities, challenges, and internal capabilities
- Strategic pathways and organizational recommendations
- Presentation-ready materials that can be shared across leadership and stakeholders

A draft resolution authorizing the procurement of a consultant for the NCTCOG Strategic Vision Plan is attached for Executive Board consideration. While the exact project cost will be determined through the competitive Request for Proposals (RFP) process, preliminary estimates place the anticipated budget in the range of \$150,000 to \$250,000. If approved, procurement will commence through a competitive RFP process. Upon completion of a thorough evaluation, staff will bring back a recommended consultant and budget for approval by the Executive Board.

Local Revenue – \$20.3 million net increase, primarily due to:

- Transportation (\$19.5 million increase)
 - Federation International Football Association (FIFA) World Cup (\$16.2 million increase)
 - County Pilot Maintenance Programs: Denton & Johnson (\$1.5 million increase)
 - ➤ Charging and Fueling Infrastructure (CFI) Community Grant: North Texas Equitable Electric Vehicle Infrastructure Project (\$1.3 million increase)

- Local Revenue (\$1.3 million increase) Increase is primarily due to a projected 9% or \$960,000 increase in wireless revenue.

- Pass-Through (\$7.0 million increase)
 - ➤ Childcare (\$8.8 million increase) Additional direct care funding primarily for childcare centers due to increase in funding of approximately \$8.6 million.
 - ➤ Workforce Programs (\$1.7 million decrease) Decrease in funding for the Workforce subrecipient to deliver the various Workforce Center services due to an approximate \$2.6 million decrease in related grants.

Research & Information Services – Total expenditures net decrease of \$1.3 million, primarily comprised of:

- Fee for Service (Aerial Photography, Cyclical) (\$1.7 million decrease)
- Software (\$123 thousand increase) Primarily due to the transition of the budgeting for certain platforms (Zoom, Smartsheet, Adobe) from the various departments to RIS as a centralized function.
- Contracted Services (\$163 thousand increase) Increase in consultant services primarily related to network security.



Area Agency on Aging – Total expenditures net decrease of \$734 thousand, primarily comprised of:

- Cost of Operations (\$108 thousand increase)
 - ➤ Personnel (\$167 thousand decrease) Primarily related to the one (1) FTE reduction in FTEs.
 - ➤ Contract Services (\$292 thousand increase) Primarily due to the growth in the Veterans Directed Care (VDC) program.
- In-Kind/Pass-through (\$842 thousand decrease)
 - > Carry over funds are not anticipated to be available for FY 2026.

Environment & Development – Total expenditures net decrease of \$833 thousand, primarily comprised of:

- Cost of Operations (\$327 thousand decrease)
 - ➤ Contract Services (\$435 thousand decrease) Funding for the Transportation Stormwater Infrastructure (TSI)-West project is coming to an end resulting in the decrease of the related consultant expenditures projected for FY 2026.
- Pass-Through (\$506 thousand decrease)
 - ➤ Solid Waste Management (\$322 thousand decrease) This is the first year of a two (2) year award. Implementation typically occurs in the second year along with increased costs.



Emergency Preparedness – Total expenditures net increase of \$352 thousand, primarily comprised of:

- Cost of Operations (\$390 thousand increase)
 - ➤ Contract Services (\$690 thousand increase) Primarily due to additional temporary employees assisting with the implementation of a new Regional Catastrophic Grant and a contractor to conduct after action review for the FIFA world cup.
 - ➤ Other (\$390 thousand decrease) Primarily due to the rephasing of the budgeted funds, from one (1) year to three (3) years, from the Transportation Department for a Department of Energy related project (Develop Resilient Electric Vehicle Infrastructure Plan).

Community \ Program Services – Total expenditures net increase of \$448 thousand, primarily comprised of:

- Cost of Operations (\$448 thousand increase)
 - ➤ Personnel (\$294 thousand increase) Includes the addition of one (1) RPA staff (JAG Grant).

Agency Administration – Total expenditures net increase of \$252 thousand, primarily comprised of:

- Agency Support (\$59 thousand increase)
- Facilities Management (\$193 thousand increase) Primarily due to 2% annual rent increase (\$63 thousand) plus operating cost increases (\$130 thousand).




NCT9-1-1 District – Total expenditures net decrease of \$5.1 million, primarily comprised of:

- Cost of Operations (\$4.9 million decrease)
 - ➤ Capital Outlay (\$4.1 million decrease) Non-recurring funding was received by the CSEC state agency (Proposition 8 funding) that was utilized to purchase 9-1-1 Next Generation equipment and related costs. Proposition 8 funding is projected to be fully utilized in FY 2025.
 - ➤ Other (\$974 thousand decrease) Primarily do the completion of the non-recurring 9-1-1 Next Generation costs during FY 2025.

Item Title: Status Report on Metropolitan Planning Organization Revolver Funds and

Regional Transportation Council Local Pool

The North Central Texas Council of Governments (NCTCOG) is required to pay for expenses associated with projects and programs it implements before federal reimbursement can be requested. To do this, the Metropolitan Planning Organization (MPO) Revolver Fund was created to hold local funds that pay these invoices. In September and December 2015, the Regional Transportation Council (RTC) approved the programming of projects to establish the MPO Revolver Fund. The MPO Revolver Fund is reimbursed as federal/State reimbursements are received. This memo refers to this fund as the "Permanent MPO Revolver Fund."

The Executive Board also authorized the Transportation Director to move interest between the Permanent MPO Revolver Fund, the Temporary MPO Revolver Fund, and the RTC Local Fund Pool based on need. This action also requires staff provide a semi-annual report to the Executive Board on the status of the MPO Revolver Funds and RTC Local Pool including interest transferred, if any, between funds. The Director has not moved any interest funds between accounts. Each account continues to accrue its own interest.

Attached is a summary of the status of the Permanent MPO Revolver, the Temporary MPO Revolver, and the RTC Local Fund Pool. At the last Executive Board presentation, Judge Hill requested a performance measure be added indicating the number of times the revolver has rotated. With the success of the Transportation Department competitive grants, the revolver has rotated nearly 20 times using the \$15 million cap number. I will provide a brief presentation on this item and be available to answer questions from the Board.
