Attendees provided feedback on the draft "Doo the Right Thing" educational explainer video. NCTCOG is requesting feedback from stakeholders by March 31, 2023. The final version will be posted online and shared in the June 2023 TMDL newsletter.

Attendees discussed the need for further information and discussions about benchmarking for pollutants of concerns related to stormwater permits, e.g., how are permittees gauging if educational tools are working, how are permittees identifying progress, and more. NCTCOG will work with stakeholders to host a roundtable discussion on this topic in Summer 2023.

Attendees provided feedback on the draft On-Site Sewage Facility (OSSF or septic system) postcard. NCTCOG is requesting feedback from stakeholders by March 31, 2023. The final version will be posted online and shared in the June 2023 TMDL newsletter.

Attendees discussed the need for more in depth OSSF educational materials that expand upon what is provided on the postcard. NCTCOG will begin developing a more detailed brochure that complements the postcard, including the addition of a QR code on both the brochure and postcard.

6. **NCTCOG Updates and Roundtable Discussion.** NCTCOG will provide general updates and members will have an opportunity to share what is happening in their communities.

The Trinity River Authority received a 319 grant to address on-site sewage facilities in their project areas to include Dallas, Tarrant, Johnson, and Ellis Counties. The grant will help improve the geodatabase of OSSF locations and also include funds for replacing some OSSFs.

The City of Arlington has developed an Arc GIS StoryMap: <u>The Way of Water: An Arlington Watersheds Story</u> that details water quality and watershed information within the city. They are requesting feedback on the StoryMap via email at environmental@arlingtontx.gov.
