North Texas Community Clean-Up Challenge

The Stormwater Public Education Task Force (PETF) will be hosting its first North Texas Community Clean-Up Challenge (NTCCC) this fall during the months of September and October. The NTCCC is structured as a friendly region-wide competition, where communities can organize and participate in litter cleanup events during the designated timeframe. Participants are also encouraged to take individual action picking up litter on behalf of their city at any point throughout the challenge timeframe. This cleanup challenge strives to reduce the negative impact escaped trash and litter causes our environment and tackle the problem from a region-wide

So what activities count for the challenge? Litter picked up from any cleanup event may be logged for the challenge and counts towards the overall totals for the city where the cleanup occurred. This means that organized cleanups through KTB affiliates, local non-profits, Scout troops, and environmental clubs all count towards the city's total! Informal cleanup activities such as collecting trash and litter on a daily walk or jog through neighborhoods and parks also count towards the goal of removing as much trash and litter from our environment as possible.

heard from Rachel Ritcher, Texas Parks & Wildlife Department, and Adam Henry, US Department of Agriculture Wildlife Services. Their presentations included an overview of the basics and biology of feral hogs, as well as the steps TPWD is taking to curb the impacts of feral hogs and the USDA Wildlife Services' direct actions that are currently utilized to manage feral hog impacts. Trinity River National Water Trail Update



The [Trinity Coalition](#), in partnership with NCTCOG, initiated the Trinity River National Water Trail Task Force in early 2021, following the recognition of the Upper Trinity River as a National Water Trail by the National Park Service in October 2020. The goal of this Task Force is to collaborate on the maintenance and promotion of the National Water Trail, and to support its use and expansion

throughout our region and beyond. Task Force members include representatives from cities and counties along the Water Trail as well as regional agencies and nature-based nonprofits.

Educational Explainer Videos

As part of the Public Education Task Force and Wastewater and Treatment Education Roundtable programs, NCTCOG has developed educational explainer videos over an array of topics that are available for sharing from NCTCOG E&D's YouTube. Available videos and their descriptions are listed below!

Personal Care Items Video: This video explains why personal care items such as floss, hair, and cotton balls should never be flushed down the toilet, and why you should only ever flush the 3 P's - pee, poo, and (toilet) paper! View the video [here](#).

The Lifecycle of Drinking Water Video: Do you know where the water in your tap comes from? This video explains the cycle of drinking water throughout our communities, from the source to the tap, to the treatment plant, and back to streams and lakes. View the video [here](#).

Proper Disposal of Household Hazardous Waste: Leftover paint, insecticides, herbicides, fertilizer, and other household wastes can be hazardous, and should never be disposed of through your drains! These chemicals are difficult and expensive to remove from the water and could damage your pipes. Learn more by viewing the video [here](#).

Stormwater Pollution Prevention - Lawn Care: Learn how to maintain your lawn while preventing stormwater pollution. View the video [here](#).

Stormwater Pollution Prevention - Litter: This video explains why litter is a big problem for you and the environment, and what you can do to prevent litter in the first place. View the video [here](#).

Fats, Oils, and Grease Explainer Video: This video showcases what happens when you put fats, oils, greases, and other solids (FOGS) down the drain. These substances can severely damage your household pipes and city sewer lines. Learn more by viewing the video [here](#).
