


June 3rd 2015 Meeting Summary

- Coordination Committee approved Addendum 1 to the current I-Plan. Addendum 1 authorizes NCTCOG to administratively amend the I-Plan to include the Mountain Creek Lake impaired segments and associated technical updates.
 - Strategy 9.1 - Expanding the geographic scope of the I-Plan as appropriate.
 - Continue to complete edits to maps and figures in the I-Plan to reflect changes in I-Plan coverage area.
- Coordination Committee approved the Resolution to include four TMDLs for Indicator Bacteria in the Cottonwood Creek, Fish Creek, Kirby Creek, and Crockett Branch Watersheds Upstream of Mountain Creek Lake to the existing I-Plan.



Recap of FY2016 TMDL Work

- Administrative Amendments to I-Plan including technical subcommittee comments
- Developed the BMP Library. Over 150 materials to help communities address bacterial impairments in regional waterways.
- Partnered with AgriLife Stephenville to address bacterial impairments in the Trinity River Basin 805 and those impaired sub-segments of the Trinity River. The first year of this effort increased education and outreach to raise stakeholders' water quality awareness.
- Supported Doo the Right Thing Pet Calendar with over 100 individuals taking the pet waste pledge.
- Developed an Implementation Plan strategies matrix for prioritizing strategies for FY2016



FY2017 TMDL Activities

- One-on-one meetings with I-Plan communities and entities.
 - Take credit for what you are already doing
 - Continue to update metrics for improvement in water quality via I-Plan strategies
- Developing Annual Report for the Coordination Committee Approval
- Workshop – identify topic areas and host workshops
- Continue to update the BMP library with additional resources
- Quarterly newsletter to keep committee members aware of current efforts underway with the TMDL program (Funding opportunities, regional highlights, etc.)
