# 1. Welcome and Introductions.

**3.** Presentation and Vote on Proposed Changes to Committee Procedures. NCTCOG staff will present changes to Committee Procedures proposed by ad hoc sub-committee and request a vote on their acceptance.

Staff presented changes to the Committee Procedures proposed by an ad hoc subcommittee which met after the August 17<sup>th</sup> RSWMCC meeting. The proposed changes help provide clarification on the Watershed Representative position. The changes were approved unanimously as presented.

4. FY23 RSWMCC Watershed Election for Vacancies. NCTCOG will accept nominations of Phase II entities for a Watershed Representative vacancy in the East Fork.

Staff asked for nominations to a vacant seat on the East Fork watershed. Krista Pender, City of Carrollton, nominated Jeff Haynes, DART. Staff will confirm whether DART is located in the East Fork and send out electronic voting to members of the East Fork in the coming weeks.

**Dallas:** For past 16 years have been under an environmental consent decree but are working with the EPA to get out of that in November starting with an inspection of the SWMP.

**Arlington:** Would like to know if the worksheet sent out for the P2 meeting should be turned in at the meeting or ahead of the meeting? Staff can accept the worksheets from members either way.

Allen: Nothing new to report but excited about new permit.

**Frisco:** Encourage other cities to submit to the Municipal Stormwater and Green Infrastructure Awards. The new General Construction Permit next March will have a significant word change. Trash bins, when full, should be remedied immediately. Will be very significant on trash handlers, specifically builders. Under the old permit it was necessary to publish in the Dallas Morning News at a cost of \$6,000. The draft of the new MS4 permit does not have the publishing requirement.

**Plano:** Have contacted TCEQ about their permit and have not received a response back. Still working on the 2020 permit.

**Irving:** Working on Annual Reports and SWMP. Have been doing optical brightener study since June and plan to do a case study for the IDDE Task Force whenever it is complete. About to start testing for caffeine, through a lab in Arlington, in our streams. Environmental Compliance Manager position open. Appreciate NCTCOG sending out the survey on litter control.

**Lewisville:** Still don't have an approved MS4 permit since the public notice was posted several months ago.

**Cleburne:** New permit, under Public Education Outreach have requirements for staff defining who must do it. For those people, communities on urbanizing fringe exempting MUDs and SUDs from outreach, and only noting requirements for staff. Cleburne is starting to be surrounded by communities that provide water but do not provide wastewater treatment service. Would like to know if COG will do formal comments on draft permit to provide feedback to TCEQ stakeholder group? NCTCOG staff have already discussed with the Chair and Vice Chair and will utilize a survey to collect comments. **Westra Consultants:** Would like to ask if anyone hasn't gotten technical review comments from TCEQ yet?

**13. Schedule for the Next Meeting.** The next meeting date is scheduled for Wednesday, February 8, 2023.Staff proposes a virtual format for the next meeting.
