### 1. Welcome and Introductions.

2. Meeting Summary. The <u>April 28, 2022 meeting summary</u> is available online for your review.

The April 28, 2022 meeting summary was approved.

3. Member Highlight Presentation. What happens when you combine basketball and water conservation? You get a series of basketball STEM clinics by the Texas Legends and North Texas Municipal Water District. Helen Dulac, Public Education Manager, will share how this unlikely partnership developed, what a basketball STEM clinic is, and information about all the three-pointers and penalties along the way.

Helen Dulac, North Texas Municipal Water District, shared a presentation on basketball clinics hosted by NTMWD and the Texas Legends. These clinics educate children on the water cycle and conservation efforts. The presentation included instructions on how to start a clinic, as well as challenges and opportunities.

4. **Promotional Activities Update.** NCTCOG will provide an update on promotional activities and provide analytics from the Defend Your Drains website and social media activities. Additionally, NCTCOG will request feedback on future educational explainer videos and other promotional activities from members during the meeting.

NCTCOG shared analytics from the Defend Your Drains North Texas social media posts and website. Attendees discussed future video topics and instructed NCTCOG to translate the currently existing educational explainer videos into Spanish. 5. **FY2023 Work Program Discussion.** NCTCOG will present the draft FY23 Work Program for discussion and approval.

Members approved the FY2023 Work Program, which is <u>available online for review</u>. NCTCOG will begin to accept commitments online for FY2023 in September 2022, and invoices will be distributed in October 2022.

6. **Regional Training Update.** NCTCOG will provide an update on the virtual Grease Interceptor Training for FY2022 and request feedback on future trainings for FY2023.

The Virtual Grease Interceptor Training for FY2022 was held on July 12, 2022 and included presentations on the City of Cedar Hill's Liquid Waste Hauler Program and the City of Irving's grease interceptor inspection process. Slides and recording will be posted on the WATER committee webpage. Attendees discussed potential future training options.

7. General Updates. NCTCOG will provide general updates on relevant programs and events.

The Annual Holiday Grease Roundup Request for Participants will be out soon. The event dates for this year's Roundup will be November 14, 2022 - January 9, 2023.

NCTCOG's Annual Public Works Roundup is scheduled for September 13, 2022 at the Grapevine Convention Center.

8. Roundtable. The group will share what is happening in their communities.

The North Texas Municipal Water District is focusing on water conservation and sharing videos available for download by our cost share members.

Arlington Water Utilities is focusing on water conservation and address water main breaks.


9. Schedule for the Next WATER Meeting. The next WATER meeting is tentatively scheduled for October 20, 2022 at 10:00 AM.
