### 1. **Welcome and Introductions.**

## **DISCUSSION**

2. **FY17-18 Project Update.** NCTCOG will provide the group an update for each video along with a corresponding screening of the draft videos.

NCTCOG staff screened for the group the Pollution Prevention training videos that are completed, or near completion. This includes *Introduction: What Can We Do*, *Fleet Maintenance & Material Handling*, *Streets & Drainage Maintenance*, and *Construction Activities & Land Disturbances*. Following a screening of the videos and a discussion on suggested edits, the video scripts for *Construction Activities & Land Disturbances*, *Parks & Ground Maintenance*, and *Solid Waste Management* were reviewed for any final comments and edits. It was suggested that with some entities going paperless and towards digital records, it would be beneficial to capture in both the video script and footage electronic Safety Data Sheets. NCTCOG staff then provided the group with a list of all pending shots and scenes needed to finish producing the final videos and requested volunteers to assist in the collection of them.

3. **FY19 Project Update.** NCTCOG will provide a status update to the group on the project.

Brian Geck, NCTCOG, provided the group a demonstration of the new online training portal for the training videos that is in development and requested input from the group on any additional features they would like to see or need. A request that will be incorporated into the final design is to add the quiz *score* to the final step of the training before being submitted by the user. The anticipated completion date for the training portal to be live and ready for use is by mid-December. The training portal will be housed on the NCTCOG website and made available to the group by a direct link given to Regional Stormwater members. The remaining training videos will be added to the online training portal as they are completed.

4. **Site Tour/Mock Inspection.** The Task Force will discuss potential sites for a Site Tour/Mock Inspection for FY20.

NCTCOG requested a volunteer to host a Site Tour and Mock Inspection in 2020. Julie Winchell, City of Cleburne, volunteered to host at their transfer station pending approval from city staff and group willingness to drive to Cleburne. NCTCOG staff will work on coordinating details with Julie prior to the next meeting.

## OTHER BUSINESS AND ROUNDTABLE DISCUSSION

5. **Roundtable.** Members share what is happening in their communities.

**Cleburne:** The Texas Department of State Health Services (TDSHS) is out doing audits. Even though in Texas, cities do not fall under OSHA regulations, they still came around to the City of Cleburne for an audit. Be sure that all safety training and documentation is updated, and all employees are trained should they continue to move around the region auditing at cities. The TCEQ Landfill Division is doing landfill audits now which appears to be a new initiative or, at the very least, something that has not been done in a very long time. Make sure that staff know where the books are and where appropriate documentation is located in the books. There is a new General Permit out for Water Treatment Plants so have been reading up on that and the water discharges from water treatment plants. There is a new chapter on sludge codes and rules that was written so have been reading up on those and they are worth everyone taking a look at.

**Carrollton:** Working on their annual report that is due to TCEQ soon.

**Mansfield:** Waiting on Phase 2 MS4 Permit to be approved by TCEQ.

6. **Next Meeting Date.** TBD

The next meeting will be held in the Spring of 2020, after the final two training videos are completed. An exact date will be determined later and communicated to the group.
