4. Conformance Review Recommendation. Stericycle, Inc. Type V registration application for a medical waste management facility, Garland, Texas.

Jeff Mayfield, North Texas Municipal Water District and Chair of the Conformance Review Subcommittee, will present the conformance review recommendation for RCC approval.



5. Allocating Returned Grant Funds from City of Denton. Kathy Fonville, City of Mesquite and Chair of the Grant Selection Subcommittee, will present the subcommittees' recommendation for how to allocate funding returned from the City of Denton for equipment that was purchased using solid waste grant funds during the FY16/17 biennium.



#### 5. Allocating Returned Grant Funds from City of Denton.

On April 9, 2020, the Grant Subcommittee met through a conference call to determine how to appropriate \$108,741.00 of solid waste grant funds returned to NCTCOG from the sale of the City of Denton's mobile slow speed shredder equipment.

A motion was approved to partially fund the City of White Settlement's grant to allow the purchase of a brush chipper in the amount of \$80,000 contingent on the NCTCOG staff contacting White Settlement to see if they could still implement their grant.

A second motion was approved to provide additional grant funding to the City of Fort Worth in the amount of \$25,324.21 for the purchase of additional illegal dumping cameras.

6. Reallocation Of City of Lewisville Grant Funding. Kathy Fonville, City of Mesquite and Chair of the Grant Selection Subcommittee, will present the subcommittees' recommendation for how to allocate funding from the City of Lewisville's FY20/21 solid waste grant.



#### 6. Reallocation Of City of Lewisville Grant Funding.

On Monday, May 18, 2020, the Grant Subcommittee met through a conference call to determine how to appropriate \$26,366.79 in grant funds (this is also includes the remaining amount from the sale of the Denton Shredder - \$3,416.79) that the City of Lewisville (\$22,950.00) will not be able to use due to budget cutbacks from COVID-19.

A motion was approved to fund the City of Denton's Illegal Camera grant in the amount of \$26,366.79 contingent upon the COG staff seeking approval from Denton to accept this grant award. Should the City of Denton decline this grant award, the Committee recommends using these grant funds, in the amount of \$26,366.79 to fund the Know What To Throw regional recycling campaign.



7. **Duncanville Multi-City Disaster Debris Management Plan.**Tonya Hunter, City of Duncanville, will present the Multi-City Disaster Debris management Plan for Cedar Hill, DeSoto, Duncanville, and Lancaster that was performed during the FY2018/2019 biennium. Acceptance of this plan by the RCC will be sought.










#### Potential for Multiple Tornadoes Strike the Region

The debris is in the form of vegetative, construction and demolition, household items, household hazardous waste, and white goods.



#### Purpose and Benefits of a DDMP

- One-time 2 percent increased federal cost share incentive for a FEMA-accepted DDMP
- Establishes clear roles and responsibilities in a debrisgenerating incident
- Identifies resources that can be used in response:
  - Debris haulers and monitors
  - Debris management sites (DMS)
  - Equipment
  - Personnel
  - Recyclers/landfills
- Identifies priorities and strategies for debris clearing and clean-up
- Identifies applicable regulations
- Provides pre-scripted public information messages
- Reduce disaster debris in local landfills

#### Separating Your Debris

Debris should be placed curbside, without blocking the roadway or storm drains.

#### NO PICKUP ZONE

Any debris placed from the sidewalk toward your property will not be picked up.



Separate debris into the six categories shown below.

#### DO NOT STACK OR LEAN

Placing debris near or on trees, poles, or other structures makes removal difficult. This includes fire hydrants and meters.

#### **UNSURE WHERE TO PLACE DEBRIS?**

If you don't have a sidewalk, ditch, or utility line in front of your house, place debris at the edge of your property before the curb.



#### Normal Household Trash

Normal household trash and bagged debris of any kind will not be picked up with disaster debris. You should continue to follow your normal garbage removal schedule.

- Leaves (do not put in bags)



#### DDMP Plan Maintenance and Next Steps

- Annual review by the cities
- Received approval letter from Texas Division of Emergency Management and FEMA on DDMP Plan Approval
- Cities of Cedar Hill and City of Duncanville Resolution approving DDMP in February March 2020. City of DeSoto has a State and FEMA approved DDMP in 2017. City of Lancaster is awarding Disaster Debris Removal and Monitoring Contracts in 2020 and submit to TDEM for review and approval.
- Ongoing training will be conducted for:
  - General staff
  - Debris managers
  - Finance and Administration
- Exercises
  - Workshops and exercises will be conducted periodically.
  - After-action reports and improvement plans will be developed following exercises and real incidents.
  - Disaster Debris Management Workshop conducted in March 2019 with all four cities to discuss a debris generating incident and roles and responsibilities for city departments and debris removal and debris monitoring contractors.
  - Annual Spring Severe Weather / Tornado Exercise to test objectives related to disaster debris removal and aspects of DDMP.
  - Met with some of our Debris Removal Contractors in March 2020 to review plan and disaster debris removal contracts.
