The subcommittee gave many helpful comments and guidance for visual elements and descriptive language to be updated. Comments included: NCTCOG staff will give the subcommittee more time to submit comments via email.

Lynn Lovell – Halff and Associates: Based on his review of recent application, the format should be more structured. NCTCOG staff said they will look at his suggestions and screen the applications more thoroughly.

City of Benbrook- Dave Gattis: They are updating their subdivision ordinance currently in Benbrook. They may consider iSWM after this is complete.

10. **Schedule for the Next Meeting**. The next meeting is tentatively scheduled for October 19, 2016.




