Per CJPDC Policies and Procedures, section 4.3.1: <i>A minimum score of seventy (70) is required for a project to be recommended for funding in the General Victim Assistance category. Due to a projected allocation that exceeds the total requested, CJPDC Policy and Procedure, Section 5.2.6 has been applied: In the event the Office of the Governor's Criminal Justice Division (CJD) provides the COG with projected allocations for a project category, and if there are insufficient applications recommended for funding with a minimum score of 70 points to expend the allocation, the CJPDC may continue to recommend projects in ranking order until the funding is expended or a minimum score of 60 points is reached.</i>										
Application Limitations: Per CJPDC Policies and Procedures, Section 3.3: <i>At the direction of CJD, funding limits do not apply for new applications submitted in the General Victim Assistance-Direct Services category.</i>										
Vendor Hold Deduction (new policy for FY16 scored projects): A vendor hold results in the Criminal Justice Division (CJD) withholding payments on all grants to an agency. CJD may place a grantee agency on vendor hold for any of the following reasons: delinquent single audit report, delinquent financial or programmatic reports, pending refunds to CJD, match requirement not met, unresolved monitoring findings, or non-compliance with State or Federal rules. At CJD's direction, five (5) points were deducted from grant applications for applicants shown on CJD's vendor hold list any time during the last two plan years (April 1, 2013 – March 31, 2015), and the point deduction has been incorporated into the final score for each affected new application. If the applicant has been on vendor hold during the last two plan years and the vendor hold was longer than 30 days (cumulative), 5 additional points will be deducted, for a total deduction of 10 points. A grant application may be disqualified by CJD from the grant application process if an applicant is on vendor hold at the time funding decisions are finalized.										
Tie Scores: Per CJPDC Policies and Procedures, Section 4.4.5: <i>In the event of a tie score when the projects are ranked, staff will delete a high score and a low score until the tie is broken. Projects will be placed on the priority list in the order of the tiebreaker score.</i>
