
Violent Crime Rate - Over Time



## **Definitions - County Crime and Jail Statistics**

County: For crime totals, agencies that overlap county lines are only counted as part of their DPS-defined primary county. For individual agency crime rates, see Appendix: Crime Statistics. For grant funding totals, agencies that overlap county lines are only counted as part of their eGrants-defined primary county of operation. For individual grant totals, see Appendix: All Grants.

Crime rate: All adult crime rates are calculated per 100,000 people. This value will differ slightly from the official DPS crime rate due to our use of TX Demographic Center Population Projections instead of UCR population numbers. This is done to ensure consistency between adult population figures and juvenile population figures (which UCR does not provide).

Population: Population estimates are drawn from the Texas Demographic Center's Population Projections by Migration Scenario Data Tool. These values have changed slightly this year due to the Texas Demographic Center's change in migration scenario, basing it off of more recent data (2010-2015 instead of 2000-2010).


Property Crime: "Property Crime" is an aggregation of Uniform Crime Reporting-defined larceny, burglary, and auto theft. Given the relative frequencies of occurrence for these crimes, this statistic is mostly defined by larceny totals.

Violent Crime: "Violent Crime" is an aggregation of Uniform Crime Reporting-defined murder, rape, robbery, and assault. Given the relative frequencies of occurrence for these crimes, this statistic is mostly defined by assault and robbery totals.



## Murder Clearance Rate - 2017


Murder Clearance - over time



## **Definitions - Statistics for Ten Largest Law Enforcement Agencies**

Assault: Aggravated Assault. An unlawful attack by one person upon another for the purpose of inflicting severe or aggravated bodily injury. This type of assault is usually accompanied by the use of a weapon or by means likely to produce death or great bodily harm.

Auto Theft: The theft or attempted theft of a motor vehicle, which is defined as a self-propelled vehicle that runs on land surface and not on rails.

Burglary: The unlawful entry of a structure to commit a felony or theft. This includes breaking and entering with intent to commit a larceny; housebreaking; safe cracking; and all attempts at these offenses.

Clearance: Cleared by Arrest or Exceptional Means – For Uniform Crime Reporting purposes, an offense is cleared by arrest or solved when at least one person is arrested, charged with the commission of an offense and turned over to court for prosecution. In certain situations police are not able to follow these three steps and, if the following four conditions can be met, the offense can be cleared exceptionally: (1) the investigation has definitely established the identity of the offender; (2) there is enough information to support an arrest, charge, and turning over to the court for prosecution; (3) the exact location of the offender is known so that he could be taken into custody; (4) there is some reason outside the police control that prevents the arresting, charging, and prosecuting of the offender.

Clearance Rate: Total number of clearances divided by the total number of actual offenses for the reporting period.

Larceny: The unlawful taking, carrying, leading, or riding away of property from the possession or constructive possession of another. This includes pocket-picking, purse-snatching, shoplifting, theft from motor vehicles, theft of motor vehicle parts and accessories, theft of bicycles, theft from buildings, theft from coin-operated machines, and all thefts that don't fit into the above mentioned categories.

Murder: The willful (nonnegligent) killing of one human being by another. This includes nonnegligent manslaughter as well as any death due to injuries received in a fight, argument, quarrel, assault, or commission of a crime. Suicides, accidental deaths, assaults to murder, traffic fatalities, and attempted murders are not included.

Rape: The penetration, no matter how slight, of the vagina or anus with any body part or object, or oral penetration by a sex organ of another person, without the consent of the victim.

Robbery: The taking or attempting to take anything of value from the care, custody, or control of a person or persons by force or threat of force or violence and/or by putting the victim in fear.




## Sexual Assault Rate - 2017



## **Definitions - Victimization Statistics**

Child Population: Child Population estimates are for the number of individuals age 0-17 and come from the Department of Family and Protective Services annual data book.

Confirmed Victim: An individual child who Child Protective Services has confirmed as a victim of abuse or neglect, whether as a direct result of a CPS investigation or otherwise.

Crime rate: All adult crime rates are calculated per 100,000 people. This value will differ slightly from the official DPS crime rate due to our use of TX Demographic Center Population Projections instead of UCR population numbers. This is done to ensure consistency between adult population figures and juvenile population figures (which UCR does not provide).

Family Violence: An act by a member of a family or household against another member that is intended to result in physical harm, bodily injury, assault or a threat that reasonably places the member in fear of imminent physical harm. The reasonable discipline of a child is excluded from consideration as family violence. <u>Family Violence offenses are **not** mutually exclusive with UCR offenses</u>. In other words, a family violence incident that results in assault charges will be counted toward assault totals as well as family violence totals. Clearances are not catalogued for family violence and sex assault cases/incidents, therefore clearance rates for these crimes are unavailable.

Population: Population estimates are drawn from the Texas Demographic Center's Population Projections by Migration Scenario Data Tool. These values have changed slightly this year due to the Texas Demographic Center's change in migration scenario, basing it off of more recent data (2010-2015 instead of 2000-2010).

Sexual Assault: This value is a broad category which includes offenses for all of the following crimes: Continuous Sexual Abuse of a Young Child, Indecency with a Child by Contact, Indecency with a Child by Exposure, Sexual Assault, Aggravated Sexual Assault and Sexual Performance by a Child. For full definitions of these offenses, see (<u>http://www.dps.texas.gov/crimereports/15/appendices.pdf</u>). <u>These</u> <u>offenses are mutually exclusive with UCR offenses</u>. In other words, if an offense is classified as a rape, it will not be counted toward sexual assault totals. Clearances are not catalogued for family violence and sex assault cases/incidents, therefore clearance rates for these crimes are unavailable. 







## **Definitions - Juvenile Justice**

Clearance: Cleared by Arrest or Exceptional Means – For Uniform Crime Reporting purposes, an offense is cleared by arrest or solved when at least one person is arrested, charged with the commission of an offense and turned over to court for prosecution. In certain situations police are not able to follow these three steps and, if the following four conditions can be met, the offense can be cleared exceptionally: (1) the investigation has definitely established the identity of the offender; (2) there is enough information to support an arrest, charge, and turning over to the court for prosecution; (3) the exact location of the offender is known so that he could be taken into custody; (4) there is some reason outside the police control that prevents the arresting, charging, and prosecuting of the offender.

Community Youth Development (CYD): The CYD program contracts with community-based organizations to develop juvenile delinquency prevention programs in ZIP codes with high juvenile crime rates. Approaches used by communities to prevent delinquency have included mentoring, youth employment programs, career preparation, youth leadership development and recreational activities. Communities prioritize and fund specific prevention services according to local needs. CYD services are available in 15 targeted Texas ZIP codes.

Juvenile Justice Referral: A formal referral occurs and should be counted when all three of the following conditions exist: (1) Delinquent conduct, conduct indicating a need for supervision, or violation of probation was allegedly committed; (2) The juvenile probation department has jurisdiction and venue; and (3) Either (a.) Face-to-face contact occurs with the office or official designated by the department or juvenile board and the alleged offense has been presented as the reason for this contact; or (b.) Written or verbal authorization to detain is given by the office or official designated by the juvenile board.

Juvenile Justice Referral Rate: The PSO-provided referral rate differs slightly from the TJJD-published rate due to differences in population assumptions. Please contact PSO or TJJD for more information on this if needed.

Property Crime: "Property Crime" is an aggregation of Uniform Crime Reporting-defined larceny, burglary, and auto theft. Given the relative frequencies of occurrence for these crimes, this statistic is mostly defined by larceny totals.

Services to At-Risk Youth (STAR): The STAR program contracts with community agencies to offer family crisis intervention counseling, short- term emergency respite care, and individual and family counseling. Youth up to age 17 and their families are eligible if they experience conflict at home, truancy or delinquency, or a youth who runs away from home. STAR services are available in all 254 Texas counties. Each STAR contractor also provides universal child abuse prevention services, ranging from local media campaigns to informational brochures and parenting classes.

Statewide Youth Services Network (SYSN) - The SYSN program contracts provide community and evidence-based juvenile delinquency prevention programs focused on youth ages 10 through 17, in each DFPS region.

Violent Crime: "Violent Crime" is an aggregation of Uniform Crime Reporting-defined murder, rape, robbery, and assault. Given the relative frequencies of occurrence for these crimes, this statistic is mostly defined by assault and robbery totals.

Youth Clearance: Youth offenses are unavailable for reporting. However, offenses cleared where the offender was under 18 *are* available, and this measure is used instead as a proxy for the youth crime rate.

Youth Population: Youth Population (ages 10-17) estimates are drawn from the Texas Demographic Center's Population Projections by Migration Scenario Data Tool. These values have changed slightly this year due to the Texas Demographic Center's change in migration scenario, basing it off of more recent data (2010-2015 instead of 2000-2010).
