4. Solid Waste Grant Program - Application Process Improvements. Kathy Fonville, Vice Chair, will present the Solid Waste Grant Task Force's recommendations on improving the solid waste grant application process to the RCC for approval.



- 4. Task Force Recommendations:
 - In-kind expenses are no longer eligible for reimbursement
 - Each entity will be limited to two applications and only one per department
 - Supporting documentation (quotes, photos, etc.) will now be required
 - Score sheets will be adjusted to be more detailed and to include scoring categories for past grant management performance and quality of application



- 4. Task Force Recommendations:
 - Application template will be shorter with more detailed instructions and will be fully up-loadable to the website
 - Project Summary Slide will be eliminated
 - NCTCOG will perform a preliminary review of all applications and disqualify those not meeting minimum requirements
 - Subcommittee members will review and score grants prior to Scoring Sessions and will be able to adjust scores as needed during the Scoring Sessions








83% of Americans view recycling as a valuable public service, but only 59% have access to recycling on par with disposal.








How It Works: Current System

Local governments bear all burden of funding residential recycling, and it's not enough to sustain or improve the system.







How It Works: Proposed System

Funding is injected from privatesector packaging and printed paper fees and public-sector disposal surcharges to sustain and improve the system.





Packaging and Printed Paper Fee: How it Works









Formation of an industry-led NGO to serve as Packaging and Printed Paper Stewardship Org (PSO)

Needs assessment determines level of funding required

Fees ecomodulated based on material characteristics NGO
disburses
funds for
infrastructure
and
education

ACCELERATOR

Brands pay packaging and printed paper fees with discounts for environmental design, such as recyclability and recycled content. NGO sets the fees and disburses funding based on the findings of the needs assessment through direct investments, competitive grants, etc.

Disposal Surcharge: How it Works









Levied per ton on MSW disposal

Operator of facility pays tax

Facility remits
levy to state or
federal
government

Revenue credited to the Recycling Trust Fund

Funds are distributed to states or local governments on a per-capita basis to be used as ongoing financial assistance to operate the collection, processing and marketing of recyclables by local government programs.





Public Sector Advisory Group

Engaging state and local government stakeholders in discussions to refine, improve, and advance policy solutions, including those outlined in the *Accelerating Recycling* policy report.

 - NCTCOG is contractually obligated to complete an update to <u>Volume I of the RSWMP</u> (Goals and Objectives) by January 2022.
 - Depending on whether there are significant changes to the goals and objectives, an update to <u>Volume II of the</u> <u>RSWMP</u> (Implementation Plan) may be necessary.



7. Regional Solid Waste Management Plan.

- NCTCOG recently received the templates from TCEQ for both the Volume I and II update and will be convening the Regional Management Plan Subcommittee (RMPS) on **December 7**, **2020 at 10:30 AM** to refresh the subcommittee on the plan forward, discuss TCEQ's expectations, and discuss next steps.
- The RMPS will serve as the advisory group for the plan update and will bring regular updates to the RCC.
