- 3. New Member Welcome. NCTCOG staff will introduce the new members. NCTCOG is excited to have these public works professionals join the Council and help lead the program!
- 4. **Service Awards.** NCTCOG Staff will announce the Service Awards that were mailed out to Public Works Council Members that no longer serve on the Council. 5. **Cooperative Tree Purchasing Concept.** A representative from the RISE Coalition will introduce a concept for a tree purchasing cooperative for the Council's feedback. (Jaime Bretzmann)

Jaime Bretzmann from the City of Plano asked the Council if there would be interest from their communities to have a tree purchasing cooperative through NCTCOG's SHARE program to help recover trees lost during the winter storm. If there is interest, NCTCOG staff will work with the RISE Coalition and SPROW Subcommittee to create the list of trees for the Request for Proposal (RFP). By using specific trees from these groups, it will motivate nurseries to have trees that are aligned with their regional program initiatives.

Several Council members asked for information to be emailed to them so they can forward it to the appropriate department. Jaime will send Olivia information to be sent out with the PWC Meeting Follow-Up. If cities are interested or have further questions, they should contact Olivia.

#### **INFORMATION ITEMS**

- 6. FY 2022 Public Works Work Program Update. NCTCOG staff will update the Council on recent Public Works efforts and Subcommittee activities. (Olivia Kale)
  There are 33 cost-sharing members of the Public Works Program for FY22 so far. This makes up 41% of the needed budget. Invoices for FY22 were mailed the first week of October. If a community has not received their invoice or has questions, please reach out to Olivia Kale.
  - Public Works Roundup. NCTCOG staff will give the Council feedback from attendees at Roundup. (Olivia Kale)
     Overall NCTCOG received positive feedback from the 2021 Public Works Roundup. The Council would like for the next Roundup to take place again in September. Olivia Kale will begin planning efforts.
  - Standard Drawings Subcommittee. A Subcommittee representative will brief the
    Council on progress made towards updating the drawings in the Construction
    Standards Fifth Edition. (Keith Marvin)
    Keith Marvin explained that the subcommittee is finishing the final review of Division
    2000, 4000, 5000, and 6000. These should be ready for the Council's approval at the
    February meeting. All divisions will be released as one amendment to the 5<sup>th</sup> edition
    Public Works Construction Standards.
  - Sustainable Public Rights of Way (SPROW) Subcommittee. The Subcommittee
    Chair will update the Council on the activities of the SPROW Subcommittee. (Misty
    Christian)
    Misty updated the Council on SPROW's efforts to create a utility coordination chapter
    for the BMP Guidebook. They are currently discussing shared duct banks. If anyone
    has any experience, their knowledge would be greatly appreciated at the next meeting
    on Dec 14<sup>th</sup>.

• integrated Stormwater Management (iSWM) Activities. The Subcommittee Chair will present an update of iSWM program activities. (Ranjan Muttiah)

Halff Associates is working with the subcommittee to complete tasks. For Task 2 – Reorganize/Re-evaluate Site Development Controls, a draft of 5 BMP summary pages will be provided to subcommittee in January. For Task 3 – BMP Design and Maintenance Training, the virtual training on permeable pavement is scheduled for December 9th. For Task 4 – Technical Manual Updates, a draft of the updates was provided for the subcommittee to review in October. For Task 5 – Guidance on Forebay Design, the subcommittee is examining forebay design options for subsurface discharge in wet ponds. For Task 6 – Hydrologic Mimicry Research, Halff is drafting memo with recommendations and goals. For Task 7 – Technical Assistance for Case Studies, Halff is identifying and evaluating potential case studies

For Task 8 – Economic Benefits of iSWM, Halff is developing draft educational document with commentary of participating communities for review in January.

## 7. Other Program Activities.

Cooperative Technical Partnership Program and the Community Rating System **Users Group.** NCTCOG staff will provide an update on FEMA's Cooperative Technical Partner (CTP) Program activities and the Floodplain Administrators/Community Rating System Users Group. (Olivia Kale) The FY18 flood risk identification project on Mary's Creek (Parker County) is complete. The FY19 flood risk project on Harriet Creek (Denton County, 7 miles) is 45% complete. The survey is ongoing and hydrologic and hydraulic analysis is underway. The other FY19 flood risk project on Waxahachie Creek (Ellis County, Midlothian, Waxahachie; 19 miles) is 60% complete. The survey is complete and hydrologic and hydraulic analyses is underway. The FY20 flood risk and outreach project on Catherine Branch (Denton County) is 40% complete. The survey is complete and hydrologic and hydraulic analyses is underway. The FY20 Transportation and Stormwater Integrated Project Engagement is in progress. The community survey is complete, stakeholder list developed, and the initial community meetings will be held in early 2022. NCTCOG was awarded FY21 CTP grants for five projects including: Program Management; Hog Branch (Denton County); East Fork (Lowery Crossing and McKinney); Upper West Fork Discovery; COMS Project (CHARM Outreach Workshops).

The CRS Users Group meeting will be held in early 2022. If you have questions or to suggest future meeting topics, please contact Breanne Johnson at BJohnson@nctcog.org.

Public Works Emergency Response Team (PWERT). A PWERT representative will
give an update on recent PWERT activities. (Manny Palacios)
Manny told the Council that PWERT has grown from 62 jurisdictions to 70. They are
working to create similar groups in Houston and Austin area.
