- 1. Welcome and Meeting Purpose.

 - Future Goals for the Trail. A discussion of future opportunities for the Trail, including new launch sites and Trail expansion. Steve Smith, Trinity Coalition

 - Michael Kim discussed initial funding and ongoing maintenance costs for the City of Lewisville's new boat launch. This was a city-funded project and future costs were considered when allocating budget funds.
 - Steve Smith discussed the importance of trail upkeep in meeting National Water Trail criteria and maintaining the designation. Dale Harris noted that not all launch sites need to meet the same high level of construction as Lewisville's to be ADA compliant, and not all sites along the trail must be ADA compliant to retain the designation.
 - Edith Marvin requested that participants share ideas for future meeting presentation topics and to volunteer to present on their Trinity River Paddling Trail efforts.
