- 2. FY23/24 Special Project Discussion.** NCTCOG will share final drafts of the posters for the FY23 special project for approval. The group will also continue their discussion on the special project for FY24 and identify needed updates to the shop posters to be refreshed.

City of Mansfield – TCEQ will be providing a SWMP Template.

City of Plano – Large Sanitary Sewer Overflow with over 1 million gallons of sewage. NTMWD had to report to the TCEQ and are tasked with remediation.

City of Irving – Industrial program issuing lots of permits. Conducting Bacteria Source Tracking with TAMU AgriLife to understand impairments.

City of Cedar Hill – Upcoming trash cleanup on April 13<sup>th</sup>.

City of Fort Worth – Is getting close to being fully staffed.

City of Arlington – Dakota Livingston is with the P2/Good Housekeeping Program and Edgar is with the IDDE program.

Tarrant County – Provided a brief update on the concrete batch plant going up in Rendon.

City of Frisco – Weston with Frisco discussed their use of LIDAR to map watershed. Very useful for big sites before & after rain events.

City of Denton – Will be using tests kits for caffeine to sample for any wastewater in stormwater. Stormwater team was in a video for Denton TV on sampling program. Had a Sanitary Sewer Overflow with a hit of ammonia from landfill next to golf course.

City of Richardson – Mitchell staff member who is now having to learn stormwater and will begin conducting industrial inspections. Upcoming Trash Bash in April.

City of North Richland Hills – Stormwater Permit is due next week.




