

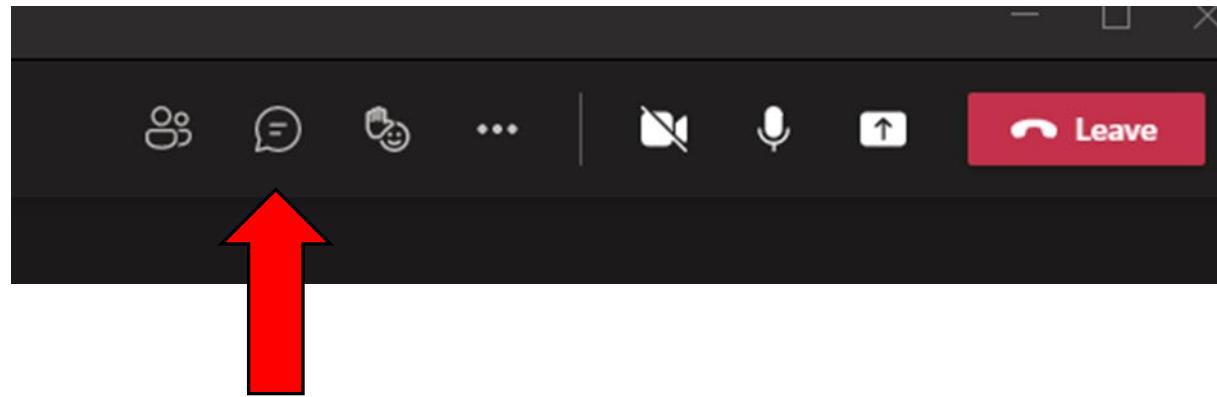

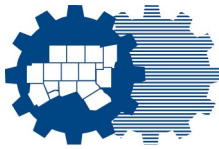

•**Fire Advisory Board, Bob Morgan.** Approval of the 2021 International Fire Code and International Existing Building Code.

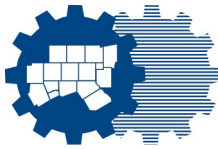
