 - One year planning requirement
 - Equity reimbursement
 - Diversity of locations, business models, operations plans
 - Access for all
 - Economic growth
 - Priority to eligible entities that collaborate with commercial AAM entities, institutions or higher education, research institution or relevant stakeholders to develop and prepare a comprehensive plan.
