The original chairs were Kenny Shaw and Juan Ortiz. Joe took over for Kenny and Amanda took over for Juan. In 2020, Tonya Hunter was nominated as co-chair.
- Operating and policy guidelines will change to Bylaws to align with EPPC.
- Change from 2 co-chairs to Chair and Vice Chair this will allow continuity
- Leadership includes Candice, Project Manager, chair and vice chair and Brenda.
- Update Chair terms to 2 or 3 years, this will help them be more in line with EPPC Bylaws and REPAC guidelines.
- Chase suggest 2 years would be good term limit, Dave agrees. Item D. i

#### Brenda Philips, CASA

- Eric Lyons new company will contract with UMASS.
- DFW Airport update relationship going well and open to proposal of replacing and repairing radars. Writing up proposal to send to DFW.
- Arlington is interested in Drone capability for CASA, potential of getting them on board as a member. Demonstrate the CASA data can help with potential UAV funding.
- Academia review research grants and expand the use of the data

- Infrastructure bill Brenda has been trying to see if there are any funds to try to replace all the radars. Conversation with Congressman, best place for CASA to fit in is transportation. Having precise weather information will help with transportation. May need to link up with Environmental Dept to address flooding.
- Build Back Better Partner with Transportation with COG to be part of the proposal. Eventually decided to partner with UTA autonomous freight.
- The state does not understand CASA well enough to apply for mitigation grants, but might be worth a shot now. We host the radars but not own the radars. New Addison radar may think about shifting ownership.
- Tonya, the challenge is how to show a radar mitigate life and property.
- Amanda bring up the funding subcommittee to see if anyone is interested.

## Item 5: CASA Radar Network Update 10:10 AM

- Denton radar is up and running
- Johnson County in need of more significant repair amplifier \$25,000; EWR will provide the repairs.
- Mesquite radar had huge wasps nest, modulator board might be the issue to be fixed. Original date was September and is delayed. Radar has to come down in order to raise.
- Addison needs a new pedestal; it is not worth replacing pedestal.
- UTA pedestal issue as well.
