# **Summary**

1. Welcome and Introductions.

David Kerr, City of Melissa and Chair of the RCCC, welcomed all meeting attendees.

#### **ACTION ITEMS**

**2. Summary of the October 4, 2018 Meeting.** The October 4, 2018, meeting summary is available <u>online</u> for your review and consideration.

Jim Olk, City of Garland, made a motion to approve the summary and Bob Morgan, City of Fort Worth, seconded the motion. The meeting summary was approved unanimously.

#### **PRESENTATIONS**

3. Presentation over Structural Insulated Panels. Matt Mitchell, James Andrews Custom Homes, will give an overview of Structural Insulated Panels.

Matt Mitchell, James Andrews Custom Homes, gave a presentation on Structural Insulated Panels (SIPs), their function, benefits, concerns, and how they can be integrated into the building process. It was followed by a discussion on its effectiveness with other building components (i.e. electrical and plumbing systems).

### **DISCUSSION**

4. 86th Texas Legislative Session Update. Jim Olk, City of Garland, will discuss relevant legislative bills.

Jim Olk, City of Garland, gave a brief overview of legislative bills of interest to the group. The following legislative bills were highlighted in discussion:

- HB 219: Relating to requirements regarding a municipality's comprehensive plan for long-range development, including adoption of an environmental report.
- HB 291: Relating to the authority of a political subdivision to issue a building construction permit or final
  certificate of occupancy for a building or facility required to meet certain accessibility standards; providing
  an administrative penalty.
- HB 591: Relating to substandard residential building fines issued by certain municipalities.
- HB 969: Relating to the authority of a political subdivision to regulate the removal by a landowner of noxious or invasive plant species or brush species detrimental to water conservation from the landowner's property.
- HB 984: Relating to requirements for new or increased municipal fees.
- SB 357: Relating to the height of outdoor advertising signs regulated by the Texas Department of Transportation.

**5. RCCC Chair Discussion**. The RCCC will discuss David Kerr's change of employment from the City of Plano to the City of Melissa and his wish to remain Chair of the RCCC.

David Kerr, City of Melissa, announced his change in employment and desire to continue to serve as the Chair of the RCCC. The RCCC expressed full support in having David Kerr remain as the Chair of the committee.

**6.** Advisory Board Membership Discussion. NCTCOG will discuss the need for a chair for both the Energy and Green Advisory Board and the Electrical Advisory Board.

NCTCOG announced that there is a need for a chair and vice chair of the Energy and Green Advisory Board, as well as a need for a Chair of the Electrical Advisory Board. As a reminder, Chairs of the Advisory Boards must be a public sector representative who currently serves on the RCCC. 7. Regional Codes Work Program Discussion. NCTCOG will update the RCCC on the current funding status for the FY2019 Work Program and discuss anticipated activities and deliverables. Additionally, NCTCOG will discuss the FY2020 Work Program <u>Cost Sharing</u> amounts, anticipated activities, and priorities. The RCCC will also discuss the possibility of charging a fee to non-cost sharing participants for deliverables and for participation in trainings/workshops developed by the RCCC.

NCTCOG updated the RCCC on the current funding status of the Regional Codes Work Program (\$21,700).

NCTCOG announced that FY2020 cost sharing information will be emailed out to members soon. NCTCOG introduced and demonstrated a new online interface that allows members to commit online for the next fiscal year. NCTCOG showed examples of how other committees charge for their implemented standards and workshops as a method to promote member cities to participate in the cost-sharing program. The RCCC decided to visit this topic at a later date and focus on getting private sector funding.

**8. FY2019 Training Discussion.** The RCCC will prioritize FY2019 of training topics and will discuss NCTCOG's draft training timeline. The committee reviewed the draft video script. Jim Olk, City of Garland, mentioned that the video should include information about state mandates, public hearings, and benefits of establishing separate building advisory boards.
