1. Welcome and Introductions.

PRESENTATION

2. Ben Camacho, Director of Permitting and Compliance, WRM, Steve Charo, Director of Operations, SouthWaste, and Spenser J Harvey, P.E., Civil Engineer, Parkhill, will brief the Subcommittee on the permit amendment application for SouthWaste Disposal, LLC, Dallas Facility, a Type V facility in Mansfield, Texas.

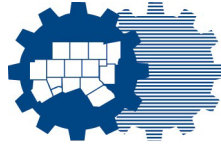
Mr. Camacho stated that the SouthWaste Disposal, LLC, Dallas Facility, is a full-service liquid waste management company. It accepts all non-hazardous liquid waste, but mostly grease trap waste. The amendment seeks to increase the waste acceptance rate from 32 million gallons per year to 50 million gallons per year.

Ways that the facility works towards the goals of the Regional Plan: Any oil (approximately 1.5% to 2%) that is recovered from grease capture is sold as biofuel. Further, the facility will assist with public awareness about illegal dumping by using signs and brochures.

ACTION ITEM

3. The Subcommittee will discuss the permit amendment application for SouthWaste Disposal, LLC, Dallas Facility, and vote whether to recommend to the Resource Conservation Council (RCC) that the application conforms to the North Central Texas Regional Solid Waste Management Plan.

There was one question from the Subcommittee:

- 1) If 1.5% to 2.0% of the waste is reclaimed for biofuel, and 80% is liquid, what is the remaining portion?

Approximately 17-18% is solids, which is landfilled.

Risa Weinberger, Risa Weinberger & Associates, Inc., made a motion to recommend to the Resource Conservation Council that the major permit amendment application for SouthWaste Disposal, LLC, Dallas Facility, conforms to the North Central Texas Regional Solid Waste Management Plan. Ami Reeder, City of Denton, seconded the motion. The motion passed unanimously.

4. Next Steps – The RCC will vote to approve the Subcommittee’s conformance recommendation for SouthWaste Disposal, LLC at its next meeting on August 18, 2022. After this meeting, a letter stating the RCC’s final conformance determination will be submitted to TCEQ, and a copy will also be sent to the applicant.

PRESENTATION

5. Jason Edwards, P.E., Senior Engineer, Weaver Consultants Group, and Adam Hart, Team Environmental Manager, Republic Waste Services of Texas, Ltd., will brief the Subcommittee on the major permit amendment application for the City of Arlington Landfill, a Type I facility in Tarrant County.

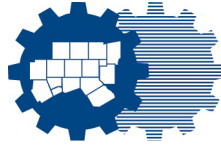
The City of Arlington has owned and operated the City of Arlington landfill for about 40 years. About 17 years ago, Republic Services began operating the facility. The amendment will increase the permitted waste disposal area, currently at 382.7 acres, by 7.8 acres, resulting in an additional site life of approximately 15 years. The existing permit boundary is 774.3 and will remain unchanged with this amendment. The permitted maximum elevation (759 feet mean sea level) and the type of waste accepted will also remain unchanged. No traffic pattern changes are anticipated with the amendment.

Ways that the facility works towards the goals of the Regional Plan: Maintaining landfill facilities are a long-term component of the Regional Plan.

There was one question from the Subcommittee:

- 1) How are you getting the additional 7.8 acres to the permitted waste disposal area?

About 22-23 acres was trimmed from the northern boundary and space was added in the center.

6. The Subcommittee will discuss the major permit amendment application for the City of Arlington Landfill and vote whether to recommend to the RCC that the application conforms to the North Central Texas Regional Solid Waste Management Plan.

Risa Weinberger, Risa Weinberger & Associates, made a motion to recommend to the Resource Conservation Council that the major permit amendment for the City of Arlington Landfill conforms to the North Central Texas Regional Solid Waste Management Plan. Ami Reeder, City of Denton, seconded the motion. The motion passed unanimously.

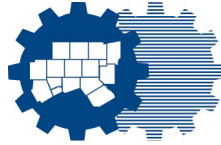
