  - Participants will include the City of Denton and City of Mansfield
- Task 4 Research "Cumulative Impacts" on Small Footprint Developments
  - Using City of Fort Worth's Linwood area XPSWMM model as a basis for study
  - Halff presented an example of study findings and will provide the final draft for subcommittee review following the meeting
- Task 5 Development Submittal and Review Process Memo
  - Halff is developing the memo with the findings from the October 1 Development Submittal and Review Process

  - Creating plan for monitoring pollutant removal efficiency of several BMPs in North Texas area installed according to iSWM criteria
- 4. *i*SWM Standard In-Comparison to Public Works Standard Drawings. NCTCOG will present a comparison of *i*SWM Standards & Public Works Standard Drawings for update in FY25. (Kate Zielke NCTCOG)

NCTCOG presented findings from a review of the Public Works Construction Standards Division 1000 and iSWM Construction Controls Standard Details.

NCTCOG reviewed iSWM drawings to see whether:

- A corresponding drawing occurred in newly amended Construction Standards
- The content of a newer drawing was revised

The review found that several drawings need to revise in the iSWM Construction Controls to align with the current Public Works Construction Standards.

After discussion, NCTCOG and the subcommittee decided to ask the Public Works Council would be able to provide any additional funding to support the update of these drawings. Additionally, NCTCOG will prepare a strategy for revisions of the drawings and develop a proposal to present to the Subcommittee at the January meeting.
