4. Work Scope. Task Order three projects update by consultants, Halff Associates, Inc.

- a. Task order 3 project update.
  - <u>Task 2</u>: Halff will summarize feedback from Workshop #1 into recommended updates for technical manual.
    February 2020 - Workshop #2 to review recommended updates to technical manual.

April 2020 - Present recommendations to iSWM Implementation Subcommittee.

- <u>Task 3</u>: Workshop #2 October 22, 2019 Presentation regarding streambank erosion, flood mitigation, water quality Presenters City of Fort Worth, City of Grand Prairie, and City of Frisco. Next workshop, Feb 11, 2020
- Task 4: In person workshop was converted into an online survey. The survey will close January 31, 2020.
- Task 5: Criteria Research for the community inventory is 90% complete. Halff incorporated 7 criteria for the 8 counties researched by NCTCOG.
- <u>Task 7</u>: BMP Installation Videos. Construction EcoServices is installing bioretention systems in Roanoke. Halff collected video footage of installation and activation in October and December.
  - <u>Action</u>: Halff will develop maintenance and installation video. COG will work on a case study video.

- 5. Technical Manual rainfall intensities Comments. Review results from survey. The subcommittee discussed feedback received from the Public Works Council. A motion was made to incorporate the NOAA-14 memo into the manual and reference the NOAA website. In addition, Appendix A -Rainfall tables for North Central Texas (found in 2006 iSWM Design Manual) will be posted to the iSWM website. The motion was seconded and passed.
- iSWM certified communities' participation in the Public Works Program. This item was requested by the iSWM Subcommittee Chair, who will lead the discussion. The subcommittee discussed certification/recertification fees, requiring Public Works Council cost share participation, and rethinking limiting access of iSWM materials to paying members.

NCTCOG staff is taking volunteers for a pool of reviewers to participate on the iSWM certification review board.

  - <u>Standard Drawings Subcommittee</u> The subcommittee is finishing comments on Division 3000. They will begin commenting on Division 2000: Pavement Analysis at the next meeting. Division 1000 edits are being prepared by NCTCOG staff to be released in the final format.
