### Item 1. Pledge of Allegiance, Welcome and Introductions:

The Committee was called to order at 1:30 pm. Introductions were made around the room.

### Item 2. Approval of the April 16, 2018, Meeting Summary (Action):

The motion to approve minutes was requested by Joe Ashton and seconded by Councilmember Ron Sauma. The minutes for April 16, 2018, passed unanimously.

#### Item 3. Approval of Draft 2019 Legislative Position (Action):

Paul Paine presented the Draft 2019 RCC Legislative Position, which includes the expansion of real estate disclosures to new residential, multifamily and commercial developments and the addition of military installations/training areas and adjacent land to restricted areas for UAS operation. The motion to approve was requested by Joe Ashton and seconded by Randy Skinner. The 2019 Legislative Position passed unanimously.

#### Item 4. Update from Lockheed Martin:

Steve Ehrlicher presented an aeronautics facilities overview on behalf of Lockheed Martin. The F-35 program is the largest contract in aeronautics as well as the corporation. Ninety-one deliveries have been made in 2018 to date, with the rate continuing to increase. The F-35 aircraft test facility expansion is a congressionally approved project commissioned in 2018. The project includes 34.3K of adjacent space for pre and post test activities. Steve said the intent is to conduct testing in a closed environment. Councilmember Ron Sauma asked if there have been any mechanical issues with the Navy aircrafts. Steve said vehicle performance has been spot on.



## Item 5. Meandering Road Project Update:

Eric Greenman and Jill Van Hoewyk from Lamb-Star presented an update on the Meandering Road Project. Eric said they have been looking at existing conditions and collecting traffic data. The biggest concern related to the project is the intersection of Meandering Road as it turns south into NAS Fort Worth JRB because different vehicles are trying to utilize the same road space for different reasons. The project involves more than 42 different entities, and two town hall meetings have been held in the City of River Oaks, where the project team provided concepts of what the roads will look like. Eric said roundabouts might be a better solution in certain areas than traffic signals. The project still needs to obtain environmental clearance.

Sterling Naron asked what kind of public feedback the project team had received regarding the use of roundabouts. Eric said at first, the use of roundabouts was questioned by the public. However, once it was explained roundabouts work very well when applied appropriately, the public was supportive of the concept. Dan Kessler said the project team knows people will be concerned about roundabouts, but they usually work very well in situations with relatively low traffic volume. Dan also asked what the timeline is moving forward on the project. Eric said they are 30 percent of the way complete with the design and will hopefully be 60 percent complete by early September. Another public hearing will take place in early 2019. Councilmember Ron Sauma asked how long it will take to construct the project. Eric said around 18 months.

### Item 6. Development Review Tool Update:

Dan Kessler presented an update on the Development Review Tool. He said four projects, all residential and in the City of Lake Worth, were discussed. Comments received were related to noise attenuation. Dan also said NCTCOG recently reconstructed their website, but everyone should still be able to use the Development Review Tool. He strongly encouraged everyone to continue to do so.

#### Item 7. NAS Fort Worth JRB Update:

Captain Townsend was not able to attend the committee meeting. Dan Kessler introduce Ed Spurlin, the new Community Planning Liaison Officer (CPLO) for NAS Fort Worth JRB.

#### Item 8. Administrative Updates:
