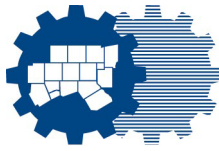

Creek runs adjacent to library and can easily see impacts. Just had high school teacher that completed stream team core data training and resurrecting stream team program. Julie retiring in October. Working on Tire Cleanup Grant, first event was on the 15th at one of the precincts. Had great turnout! Had to close down event because there wasn't enough room. Increased the dollar amount because they did not expect the support.

Burleson – had great turnout for trash bash on April 1. Have HHW event on May 6 at Russell Farm? Won GCAA community achievement award for landscaping project. Jesse Tate moved on to Tarrant County Health, and Kristen Tanz is new environmental specialist. Event in July for a class with Trinity River Authority.

Grand Prairie – Had Earth Day Event on Saturday the 15th with good turnout.

Southlake – Keep Southlake Beautiful events. On Earth Day Teaming up with Kendra Scott for giveaway, Each purchase at local Kendra Scott when mentioning KSB kicks 20% back to pay for cleanup events, incentives, etc. Great American Cleanup event on May 13th to clean up other adopt a street locations currently not committed to.

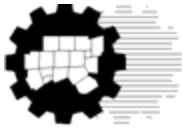

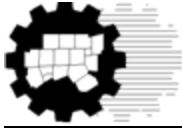

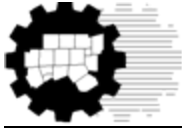
