1. **Welcome and Introductions.**
2. **Meeting Summary.** The subcommittee can provide feedback on the April 13th meeting summary.

The Subcommittee had no edits or changes to the summary.

3. **Division 2000 Drawings Review.** The subcommittee will continue reviewing the Division 2000 Drawings.
 - a. Review the 2010 and 2020 intersection plan view markup from NCTCOG Transportation Department.
Add note, "If there's a required bike lane the buffer should be 1'-3' depending on the speed." Add note, "Sidewalks should be 5' as directed by city but can be reduced to a minimum of 3' sidewalk with 5' bulb out."
Remove notes on NACTO and stick with resources from FHWA.
 - b. Review PED-18 from TxDOT to reference in 2125.
The subcommittee agreed to use PED-18 from TxDOT to reference in 2125
 - c. Review Arlington, Carrollton, Coppell, and Flower Mound's driveway approaches to replace 2150-2160.
The subcommittee wants to use the Arlington drawings for residential, Carrollton for commercial, and Coppell for alley driveway approaches.
 - d. Clarification on a comment on 2180.
The note should read, "Sand cushion as needed, not to exceed 1".
 - e. Discuss updated resources on Note 3 on 2115.
The subcommittee would like to reference both ASHTO and TMUTCD.

2200: Remove "Corrugated metal pipe."

2210-2250: Remove drawings because these are not used much.

2260: Make sure this is updated to be consistent with the new alley approaches.

2270-2290: Remove and reference the TxDOT Metal Beam Guard Fence.
