Texas LoanSTAR Revolving Loan Open Enrollment Period Closing August 30, 2019

The Texas LoanSTAR (Saving Taxes and Resources) Revolving Loan finances energy-related, cost-reduced retrofits of facilities supported by the state, including public school districts and public colleges and universities, as well as units of local government such as counties, cities, towns, public hospital taxing districts or political subdivisions (10 Tex. Gov. Code §2305.032). The Texas LoanSTAR (Saving Taxes and Resources) revolving loan program open enrollment period is open through August 30, 2019. Updates on Energy Related Legislative Bills Affecting Texas



A few legislative actions that affect renewable energy development, energy storage, and distributed energy resources were passed by the 86th Texas legislature.

HB 852

This bill has passed both houses, was signed by the Governor, and is effective immediately.

In determining the amount of a building permit or inspection fee required in connection with the construction or improvement of a residential dwelling, HB 852 now prohibits a municipality from considering the value of the dwelling, or the cost of constructing or improving the dwelling.

SB 1012

This bill has passed both houses, was signed by the Governor, and will become effective on September 1, 2019.

This bill does not require a municipally owned utility or electric cooperative that owns or operates electric energy storage equipment or facilities to register as a power generation company. This will greatly reduce regulatory red tape and promote the further growth of electric energy storage, and hopefully distributed energy resources.

SB 241

This bill has passed both houses, and was sent to the Governor to be signed. This bill updates key dates associated with the local government energy reporting requirement in Texas Health & Safety Code Section 388.005 (commonly referred to a "SB 898 reporting"), which requires an annual report to the State Energy Conservation Office on efforts to reduce electricity consumption by 5% each year. The new legislation resets the start date of the reporting as September 1, 2019 (previously it was 2011) and extends the reporting requirement until 2026 (previously it would have expired in 2021).

SPEER Updates & Expands Index of Texas Cities and Codes

SPEER published a list of all the cities in Texas for which we can verify code adoption. The first version of this tool only tracked cities with a population of 10,000 or more. Over the last months, SPPER have expanded the list to include all cities in Texas that reference an adopted building code on their website and that report issuing at least 20 building permits in 2017. The tracking tool now included two lists: One for cities that have adopted current or equivalent energy codes, and the other for cities that are still operating under older, out-of-date codes. In 2018 there were over 118,000 permits issued for single family homes in Texas, the largest number for any state, or about fourteen percent of all homes built nationally.

Energy Efficiency and Renewable Energy Helps American Small Business with \$21.6 Million for Phase I Innovation Projects

American small businesses got nearly a \$22 million boost from the Energy Department's Office of Energy Efficiency and Renewable Energy (EERE) Small Business Innovation Research (SBIR) program. Small businesses are receiving Phase 1 Release II grants that demonstrate technical feasibility for innovations during the first phase of their research, including one funded by the Water Power Technologies Office. Most Phase 1 awards are for \$200,000 for less than one year.
