2. Approval of the July 28, 2015 Meeting Summary.

The meeting summary was approved with no comments.

3. **Regional Public Works Program Update.** NCTCOG staff will provide an update on the FY16 Regional Public Works Program.

NCTCOG staff provided the group with an update regarding the Construction Standards update process. It was noted that the Public Works Construction Standards Subcommittee (PWCSS) was in the process of completing their second review of the *Roadway Construction, Maintenance and Rehab* group's edits. SPROW members were informed that the Public Works Council will have 60 days for their review of the sections.

NCTCOG reported on the Federal Highway Administration (FHWA) *Designing for the Americans with Disabilities Act (ADA)* trainings that were held this month. NCTCOG staff reported that the classes were well received with over 100 people attending the trainings.

NCTCOG staff informed the Subcommittee that the City of Denton had applied for iSWM Silver status and their application was approved.

4. Sustainable Public Rights-of-Way (SPROW) Education and Outreach Activities. The North Central Texas Council of Governments (NCTCOG) staff will provide an update on the vision and continued direction for SPROW.

NCTCOG staff provided SPROW members with a handout on the goals of the SPROW program, and the Subcommittee members were able to provide comments. NCTCOG staff noted that an edited version of this document would be brought to the Subcommittee at the next meeting.

5. Other SPROW Activities. The NCTCOG staff will provide an update on flood photo collection and compilation of case studies. NCTCOG staff will also provide an update on membership and provide SPROW website analytics.

NCTCOG staff provided an updated version of the Case Library to the Subcommittee as a handout and requested that members submit case studies. NCTCOG staff noted that the Case Study Library is categorized by project type, and the Subcommittee was able to provide input on any missing categories.

NCTCOG staff provided a handout on the web analytics for the SPROW website and members discussed the future direction of the website.




