



2017 Mode Share







Enhanced Bus Stop Bus stops within the City of Farmers Branch should meet the minimum requirements for spacial design set forth in the appendix of this report and recommended by NACIO. This site is a retro-fit to an existing commercial development. Improvements at this site could benefit the private and public infrastructure adjacent to the bus stop. Coordination with the development could allow for the bus stop to get large to accommodate more amenities.





Resource for local governments to develop publicly-led community gardens programs as a strategy for increasing food access in communities, especially near transit


Community gardens provide many health, social, and environmental benefits for all

## Inventory of Potential Community Garden Sites

- 12,555 total acres across Dallas, Denton, Collin, and Tarrant Counties
- Publicly-owned properties including city, county, transit districts, educational facilities, non-profits, etc.
- Located within 0.5 miles of both transit and existing bikeways
- Local governments may investigate other aspects such as tree canopy and soil conditions before selecting sites
- Will be available via interactive map





### **TRANSIT MANAGEMENT & PLANNING**

- Serve as Designated Recipient for Federal Transit Administration funds for North Central Texas.
- Plan and develop transit corridor and subarea studies, provide various transit planning activities, and deliver technical assistance for small transit providers and local governments.
- Enhance public transportation options in North Central Texas by coordinating services, leveraging funding, and improving access for all transit users, including individuals with lower incomes, individuals with disabilities, and older adults.



### MOBILITY MANAGEMENT



To identify transit gaps, coordinate regional resources, and promote partnerships with governments, transit providers, and stakeholders in order to serve the transportation needs of the region, including disadvantaged populations.

## SUSTAINABILITY: REGIONAL PROJECTS

#### DART/Toyota:West Dallas Circuit Circulators

- > Free on-demand service using six small electric shuttles
- Operates 5 days per week (Mon-Fri, 7am-7pm) across West Dallas and connection with DART transit hubs

#### Trinity Metro: The Dash in Downtown Fort Worth

- All-electric bus connecting downtown with the Cultural District and the West 7th entertainment corridor
- > Operates 7 days per week (expanded hours on Friday/Saturday)

#### NCTCOG: Enhancing Mobility Within the Southern Dallas Inland Port

- Transit enhancements, pedestrian infrastructure, and traffic signals across the Southern Dallas County Inland Port area
- Electric vehicles will be purchased for on-demand services
- > Installation of charging equipment at strategic locations



### FTA'S HEALTHY PLANET CHALLENGE

#### Launched in April 2021

- Call for transit agencies to develop climate, sustainability, or electrification or zero-emission transition plans
- Include strategies with measurable goals to achieve greenhouse gas (GHG) emission targets

#### Phase I: June 2021-April 2022

- NCTCOG staff encouraged transit agencies to participate in the challenge
- Four transit agencies in North Texas registered: Dallas Area Rapid Transit (DART), Trinity Metro, Denton County Transportation Authority (DCTA), and STAR Transit
- Two agencies submitted plans: DART (Climate Action Plan), Trinity Metro (Sustainability Plan)

#### Phase 2: April 2022 – April 2023

• FTA seeking to increase participation of agencies developing climate action plans

## TRANSIT STRATEGIC PARTNERSHIP PROGRAM

- > Process to evaluate transit project ideas and implement services based on need and feasibility
- > Accepting proposals on rolling basis, 2 distinct cycles
- > Encouraging nonservice providers to partner with existing transit providers
- > Not intended to make up for operating shortfalls, but to pilot services in urbanized area





### **NAAQS Compliance**

- A design value is a statistic used to summarize air quality data for an area to determine compliance.
- Design values must be greater than the NAAQS for an area to exceed the standard.
- An area that monitors over the NAAQS is not automatically designated as nonattainment.
- The area must go through the U.S. Environmental Protection Agency's (EPA) designation process to determine regulatory compliance.

### **2008 Eight-Hour Ozone NAAQS**

- Standard is 0.075 parts per million (ppm).
- Initial designations on May 21, 2012.

– DFW designated moderate effective July 20, 2012.

- 10-county DFW nonattainment area includes Collin, Dallas, Denton, Ellis, Johnson, Kaufman, Parker, Rockwall, Tarrant, and Wise Counties.
- DFW nonattainment area reclassified to serious, effective September 23, 2019.



### 2008 Eight-Hour Ozone NAAQS Severe Reclassification

- DFW nonattainment area reclassified to severe, effective November 7, 2022.
  - Attainment Demonstration (AD) and Reasonable Further Progress (RFP) SIP revisions due by May 7, 2024.
  - Federal Clean Air Act (FCAA) Section 185 fee program rules due by November 7, 2025.
  - Attainment is required by the end of 2026 to meet the July 20, 2027 attainment deadline.
  - Anticipated proposal of SIP revisions in November 2023 with adoption in April 2024.

### **FCAA Section 185 Fee**

- Penalty imposed if an area fails to attain by its severe attainment date.
- If the state does not impose the fee, the EPA will impose it with interest.
- Texas Emissions Reduction Plan revenue history in HGB.
- Applies to major sources of nitrogen oxides (NO<sub>X</sub>) and volatile organic compounds (VOC) in the ozone nonattainment areas.
- Enforced each year until redesignation to attainment.

### **FCAA Section 185 Fee Rates**

- Fee rate is \$5,000 per ton of  $NO_X$  and VOC emitted over a baseline amount and is adjusted by inflation, using the Consumer Price Index.
  - For calendar year 2022, the EPA-published fee rate was \$11,122 per ton.
- The fee could be imposed as early as 2028.
  - The estimated Section 185 Fee obligation for DFW could be as much as \$45 million in 2028.



### **2015 Eight-Hour Ozone NAAQS**

- Standard is 0.070 ppm.
- Nine-county DFW marginal nonattainment area includes Collin, Dallas, Denton, Ellis, Johnson, Kaufman, Parker, Tarrant, and Wise Counties (Rockwall County removed).
- Required marginal nonattainment area Emissions Inventory SIP revision submitted on June 24, 2020.



# 2015 Eight-Hour Ozone NAAQS Moderate Reclassification

- DFW nonattainment area reclassified to moderate, effective November 7, 2022.
  - RFP and AD SIP revisions due January 1, 2023.
  - Attainment is required by the end of 2023.
- Anticipated proposal of SIP revisions in May 2023 with adoption in November 2023.



### **Ongoing Work for DFW Area**

- Evaluating contingency measures requirements.
- Ongoing industry outreach.
- Researching and inviting input on new reduction strategies.

#### Texas EV Charging Plan Phase 1

- Install DC fast charging in recommended study areas along designated corridors
- Competitive grant program opening soon
- Waiting on FHWA to issue final rulemaking

#### Phase 2

- Install DC fast charging in county seats
- Build additional infrastructure in urban areas
  - MPOs to recommend locations
  - \$64.5 million to install DC fast charging within MPA

- Report should reflect electricity consumption between Jan 1, 2022 and Dec 31, 2022
- Deadline: Friday, March 3, 2023

## Categories for Submittal

#### **New Development**

Recognizes developments that are constructed on previously undeveloped sites and successfully exemplify many of the Principles of Development Excellence.

#### Redevelopment

Recognizes those developments that reuse and/or rebuild existing structures and successfully exemplify many of the Principles of Development Excellence.

#### **Special Development**

Recognizes projects that exemplify only a limited number (one or two) of the Principles of Development Excellence, but which are outstanding in their promotion of those selected principles. Projects that exemplify the Environmental Stewardship principle may be highlighted here. Examples include but are not limited to a sustainable infrastructure project, an energy conservation initiative, an open space or trail project, or a stormwater best management practice (BMP) such as low-impact development (LID).

#### **Raising Public Awareness**

Recognizes an organization and/or individual for educating the public or raising awareness of development excellence. Examples include but are not limited to a media outlet in the North Central Texas region for a story or series or an organization or local government for a public education campaign.

#### **Public Policy and Planning**

Recognizes a local government or private/public partnership for implementing a program or policy that facilitates and promotes various aspects of the Principles of Development Excellence. Examples include but are not limited to adopted policies, programs, ordinances, and guidelines (mixed use, open space, natural features protection, public space, historic preservation, design standards, or incentives) that can include a public/private initiative as well as comprehensive, neighborhood, area, or strategic plans.
