**Motion:** Sean Hughes, seconded by Steve Howie to approve the December 2, 2019, and August 12, 2020, meeting notes. The motion carried.

- REPAC Handbook Recommendations
  - o Recommendations
    1. Designation of the REPAC Higher Education (SME) seat as a non-voting seat (Impacts Higher Education Nominees)
    2. Creation of REPAC Cybersecurity (SME)
    3. Creation of Virtual Attendance Guidance
      - Sean Hughes had an issue with the verbiage in sentence “a.” specifically with the word “all future meetings.” I would like to remove the word “all.”
      - Steve Howie likes the idea of virtual meetings due to reducing the long-distance drive time. Steve highly recommended keeping the virtual meetings as an option
      - Randall Gurney like the idea of virtual meetings due to the amount of time spent traveling to the meetings, but recommends that a requirement is put in place to have a certain amount of the REPAC meetings virtually when COG opens up
      - Eric Gildersleeve likes the idea of working virtual. COVID is here to stay, and virtual meetings give us more capabilities to prepare us for future pandemics
      - Chase Wheeler recommends meeting halfway, 50% virtual, 50% meet in person when we can
      - Irish Hancock recommends that there be a continued investigation by the COG and regional personal at a later date whether or not to host an in-person REPAC meeting vs. virtual
      - Randall Gurney – this topic is on their EM working group meeting agenda that is scheduled for this Thursday
      - David Mccurdy thinks virtual meetings are a great opportunity and want to know do we have to have a certain requirement that states we have to have at least one in-person meeting per year for members
      - Eric Gildersleeve states that when having scoring project meetings, there may be some challenges when scoring projects virtually technically.

Maybe come up with a way to socially distance for this meeting in order to successfully have the meeting

- Option A – Remove the word “all” in sentence 3.a.
- Option B – Recommend to conduct a review with COG and Regional partners to conduct future REPAC meetings in a concurrent virtual/in-person meeting

**Motion:** Elliott Reep, seconded by Sean Hughes to approve the revised verbiage in section 3.a. to read “Recommend to conduct a review with COG and Regional partners to conduct future meetings in a concurrent virtual/in-person meeting.” The motion unanimously carried.
