4. Felipe A. Wescoup, P.E., Senior Engineer, Biggs and Mathews Environmental, Inc. will brief the Subcommittee on the limited scope permit amendment application for the City of Stephenville Type IV Landfill in Erath County.

[Mr. Wescoup noted that the landfill was permitted as a Type I Landfill, but was later permitted as a Type IV Landfill. The goal of this amendment is to reclaim airspace. TCEQ advised that the application be submitted as a limited scope amendment. The application is currently undergoing technical review by TCEQ.](#)

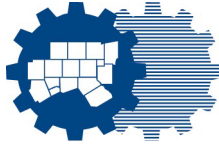
5. The Subcommittee will discuss the limited scope permit amendment for the City of Stephenville Type IV Landfill, and vote whether to recommend to the Resource Conservation Council (RCC) that the application conforms to the North Central Texas Regional Solid Waste Management Plan.

2) How much capacity will this amendment add?

A little over 20 years of expanded site life for the C&D waste.

3) At Denton, a liner was added to a portion of the Subtitle D area and additional waste was added. Why not do that?

In 1995, a decision was made to only accept Type IV waste.

4) Will this affect the air permit?

The expected increase in waste (100 tons/day, 5 days a week) is just outside of the air permit requirement.

5) Are there recycling components to the landfill?

No, not at the landfill. However, HHW and other outreach events that suggest diversion are held in town.

6) What kind of cover is on it now?

2-foot vinyl cover.

Risa Weinberger, Risa Weinberger & Associates, Inc., made a motion to recommend to the Resources Conservation Council that the limited scope permit amendment application for the City of Stephenville Landfill conforms to the North Central Texas Regional Solid Waste Management Plan. Ami Reeder, City of Denton, seconded the motion. The motion passed unanimously.

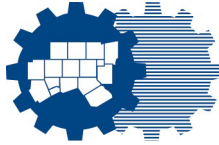
6. Next Steps – The RCC will vote to approve the Subcommittee’s conformance recommendation for the City of Stephenville Type IV Landfill at its next meeting on Tuesday, August 15, 2023. After this meeting, a letter stating the RCC’s final conformance determination will be submitted to TCEQ, and a copy will also be sent to the applicant.
