1. Welcome and Introductions.

3. Organic Waste Gap Analysis Study. Risa Weinberger, Risa Weinberger & Associates, Inc. will present on the Resource Conservation Council's Organic Waste Gap Analysis Study. This Technical Study seeks to identify opportunities for organics management in North Central Texas by expanding on the results of <u>Organic Waste to Fuel Feasibility Study</u> completed by NCTCOG in October 2022. Risa will be describing the study's goals and seeking feedback from the group on the current state of wastewater organics management in the region.

Risa Weinberger, Risa Weinberger & Associates, Inc., provided details on the Organic Waste Gap Analysis Study, including goals, anticipated stakeholder input, information requests, and more. Additional information is available on the <u>project website</u>.

4. **Preliminary Annual Holiday Grease Roundup Results.** NCTCOG will provide the preliminary results of the 2022 Holiday Grease Roundup and plans for the 2023 event.

NCTCOG provided the preliminary results of the 2022 Holiday Grease Roundup, which ended with 45 participants and 71 drop off sites/events. Over 7,561 gallons of grease were collected during the Roundup. The 2023 Holiday Grease Roundup is the 10th Annual Roundup and is scheduled for November 13, 2023 through January 12, 2024.

5. **Promotional Activities Update.** NCTCOG will provide an update on promotional activities and provide analytics from the Defend Your Drains website and social media activities. Additionally, NCTCOG will request feedback on future promotional activities from members during the meeting.


9. Roundtable. The group will share what is happening in their communities.


