

A. Structure & Representation

The Coalition structure shall consist of the following makeup:

1. Voting Members: Voting members must be members of NCTCOG and be paying participants of the RISE Coalition.

C. Appointment Process/Terms of Office

Each primary member organization's representative (representative) shall serve a two-year term, after the initial Coalition start-up year (Fiscal Year 2020). The term of appointment for each representative of the Coalition shall begin October 1 and shall be through September 30 of the second fiscal year. A member who is up for reappointment can be re-elected to subsequent terms.

The officers of the Coalition shall be Chair and Vice-Chair. They shall serve a two-year term. The Vice-Chair will ascend the to the Chair position once the two-year term is completed. NCTCOG staff will solicit nominations for the open vice-chair position before the last meeting of the fiscal year. Voting members are eligible to serve as officers. Before the last meeting of the fiscal year, Coalition members will vote according to Section 3.

F. Officer Duties

- i. The Chair presides at meetings of the Coalition. The Chair and NCTCOG staff will solicit input from the Coalition and will develop agendas for the meetings.
- ii. In case of a tie during a vote, the Chair will be deemed to have the authority to break the tie.
- iii. The Vice-Chair performs the Chair's duties in his/her absence.
- iv. If the Chair and Vice-Chair and their designated alternates are absent or unable to perform their duties; upon mutual agreement, Coalition representatives present will elect a Chair Pro-Temp for that meeting.

- Signing new two-year contract with State Energy Conservation Office to focus on:
 - Advancing Local Government Actions in Energy Management (Adoption of PACE, SolSmart Designation, Energy Code Adoption, Resilience (Hazard Mitigation Planning), and Food Waste to Energy and Renewable Natural Gas
 - Enhancing Local Government Energy Reporting
 - Collecting Data and Engaging Utilities (Electricity, Water, and Gas)
