
# Topic Prioritization

3. Complete Streets Planning 14 votes
4. Green Infrastructure and Low Impact Development 13 votes
5. ROW Planning, Administration, and Policy (Fees, Ordinances, Incentives, and Coordination) 13 votes
6. Bikeway & Pedestrian Facility Amenities and Policy (Locations, Safety, ADA Requirements, etc.) 12 votes
7. Small Cell Implementation and Policy 12 votes
8. ROW Safety and Maintenance Considerations 11 votes
9. Street/Roadway/Pavement Planning, Management, and Lifecycle 10 votes




