SUBJECT: Re-Issuance of Request for Proposals for a Platform to Measure the Performance of the Traffic Signals in the Dallas-Fort Worth Region

The North Central Texas Council of Governments (NCTCOG) is requesting written proposals from consultant firms for a Platform to Measure the Performance of the Traffic Signals in the Dallas-Fort Worth region. For this project, firms will host and provide any necessary data, databases, software, and provide training for the full functional traffic signal performance measures platform as described in the Scope of Work. NCTCOG may consider a software as a service platform.

This Request for Proposals (RFP) was originally issued on March 17, 2023 with a contract award. However, prior to contract execution, a formal bid protest was received. As a result, NCTCOG has determined to re-issue the RFP to ensure a level playing field for all firms. See the Preamble to the RFP for additional details.

This is an invitation to respond to the Request for Proposals (RFP). Proposers must submit one hard copy or one flash drive of the submission to Natalie Bettger, Senior Program Manager, North Central Texas Council of Governments, 616 Six Flags Drive, Arlington, Texas 76011. Flash drives that are unreadable or contain corrupted files will be considered non-responsive. **Proposals must be received no later than 5:00 pm, Central Time, on Friday, September 29, 2023.** Proposals received after that time will not be considered and will be returned unopened. The in-hand submittal will count as the official submittal. In addition to the in-hand submittal, NCTCOG is requesting electronic submission of proposals to TransRFPs@nctcog.org. Electronic submissions only will not be evaluated. The RFP will be available at www.nctcog.org/rfp by the close of business on **Friday, September 1, 2023.**

A Pre-Proposal Conference will be held at 10:00 am on Tuesday, September 12, 2023 via TEAMS and at the NCTCOG offices (Room TBD). Written questions submitted in advance of the pre-proposal conference will be answered at the pre-proposal conference. No additional questions will be accepted after the completion of the September 12, 2023 pre-proposal conference. Any amendments or updates to the RFP, as well as all questions and responses, will be posted on NCTCOG's website.
