Attendees discussed the need for general educational materials and standard language for wastewater concerns for commercial entities, such as car washes, restaurants, day cares and more. NCTCOG will develop draft materials such as brochures, flyers, standard email language for this audience and present it to the subcommittee for feedback and use.

Attendees discussed that after these materials were created, that similar materials be created for providing information to real estate agents/companies and homeowners associations.
