## 1. Welcome and Introductions.

## **ACTION ITEMS**

2. Meeting Summary. The April 13, 2022 meeting summary will be presented for approval.

Wes Kucera, City of Garland, made a motion to approve the April 13, 2022 meeting summary, and Grace Darling, Arlington Conservation Council, seconded the motion. The motion passed unanimously.

**3. FY2022 Water Resources Council Membership.** The FY2023 roster, recommended by the FY2023 Ad Hoc Nominations Subcommittee, will be presented to the WRC for approval. The WRC will also vote to approve the WRC Chair and Vice-Chair. Pending WRC approval, the FY2023 WRC roster will then be presented to NCTCOG's Executive Board for approval at its meeting on September 22, 2022. FY2023 membership terms begin on October 1, 2022.

NCTCOG presented the FY2023 WRC roster, recommended by a WRC Nominations Subcommittee that convened on June 27, 2022, to the WRC for approval. The recommended roster consists of those who wish to be reappointed and two new members: Stephen Gay, City of Denton; and Matthew Jalbert, P.E., Trinity River Authority. Stephen Gay was recommended to serve in the WRC category Utility Provider, Development Community or Industry Representative Region-At-Large. Matthew Jalbert, P.E. was recommended to serve in the category Major Utility Provider Customer Member-At-Large (for Trinity River Authority). Rachel Ickert, P.E., Tarrant Regional Water District was brought forth as a new WRC member for FY2023 to serve in the category Major Utility Provider Customer Member-At-Large (for Tarrant Regional Water District). No nominations were received for the Chair and Vice-Chair positions. The current Chair and Vice-Chair agreed to be reappointed for FY2023. Larry Patterson, Upper Trinity Regional Water District, made a motion to approve the FY2023 WRC roster. Danielle Tucker, DEVA Service's seconded. The motion passed unanimously.

4. Approval of the Draft 2022 Update to the North Central Texas Water Quality Management Plan (WQMP). Comments received on the <u>Draft 2022 WQMP</u> during the public comment period will be summarized and the WRC will vote to locally adopt the Draft 2022 WQMP, pending any revisions needed based on public comments. If approved by the WRC, the Draft 2022 WQMP will be recommended for endorsement by NCTCOG's Executive Board at its meeting on August 25, 2022.

NCTCOG provided an update on the major elements of the 2022 Draft Update to the North Central Texas WQMP, and they are listed below.

- 2022 population estimates for the NCTCOG region were included.
- The locations of permitted on-site sewage facilities were added for Erath, Kaufman, Navarro, and Parker Counties.
- The boundary for the Lake Granbury Watershed Protection Plan was corrected to show just the two-mile buffer around Lake Granbury, which is where the WPP focused.

NCTCOG then reviewed and discussed the comments received on the draft 2022 WQMP during public review. Some comments addressed edits to names and data, which the WRC agreed should be corrected. Other comments were about content and the WRC discussed those and agreed to three revisions to the WQMP: 1) To remove the Wastewater Treatment Plants section, which was out of date and had unreliable data, and instead rely on the Wastewater Outfalls section, where the data was provided by TCEQ; 2) To not add water and wastewater service boundaries for communities in Johnson County to the deliverable and keep the focus on regional entities; and 3) To work to correct the wastewater service area boundary for Upper Trinity Regional Water District. Stacy Walters made a motion to locally adopt the draft 2022 WQMP and recommend it for endorsement by NCTCOG's Executive Board, pending the edits to names and data provided in public comments and the three changes noted above. Wes Kucera seconded the motion. The motion passed unanimously.

## DISCUSSION

5. The Unintended Consequences of Texas Senate Bill 13 and Texas Senate Bill 19 on Funding Flexibility. Larry Patterson, Upper Trinity Regional Water District. Mr. Patterson will share his knowledge and efforts about this topic and discuss with the WRC options for moving forward.

Mr. Patterson noted that Senate Bill 13 may not have a large impact in Texas at this time. However, Senate Bill 19 will likely have a larger impact in that it will lead to less banks competing to purchase bonds, which then could likely lead to higher interest rates.

8. Roundtable. WRC members are invited to share what is happening in their communities.


- Discussion centered on the importance of water conservation due to the current extreme heat and high water demand. WRC members noted that there are record levels of water use in some areas of the region recently.


