4. Pavement Analysis contract Update


- NCTCOG's SHARE Pavement Analysis Contract is up for a one-year renewal on Dec 31st.
 - The initial three-year contract expired Dec. 31, 2019 and has 3 one-year renewals available.
 - 2 renewals left
- NCTCOG staff has received feedback from vendors that they can not provide all their services through the contract and it limits new technology they can use for cities.
- NCTCOG staff would like to know if it would be beneficial to the users to update the contract and open it up for bidding again next year.
 - Pavement companies would give price per type of employee, instead of line items for specific services and mileage.
 - This would allow companies to provide new technology, new services, etc. for cities instead of only being able to provide what was only included in the initial bid.




USEFULNESS OF CASE STUDIES AND PRESENTATIONS










HOW WOULD YOU RATE THE ONLINE MEETING PLATFORM HOPIN?

- Benefits of Trail Oriented Development ("TOD2")


- Enhancing ROW continuity and interregional drainage capacities - for both eco and human connectivity. Last mile and 'node'-district overlay strategies.






PLEASE INDICATE THE VALUE OF YOUR MONEY SPENT ON THE SPONSORSHIP THROUGH THE SCALE BELOW.

Standard Drawings Subcommittee



FY18 Projects

• Flood Risk ID on Marys Creek in Parker County is 92% complete. The flood risk review virtual meeting was held October 2nd. The flood resilience meeting is planned for early spring.

FY19 Projects

 Harriet Creek (Denton County, 7 miles) and Waxahachie Creek (Ellis County, Midlothian, Waxahachie; 19 miles) flood risk identification projects kicked off in April and are ongoing, with survey and hydrologic and hydraulic analyses underway. Waxahachie Creek is 38% complete and Harriet Creek is 8% complete.

FY20 Projects

 NCTCOG received awards for flood risk identification on Catherine Branch (Denton County) and communications and outreach to the northern/western area of the region for integration of transportation and stormwater planning. Projects will kick off in early 2021.

FY21 Projects

• NCTCOG will submit a draft business plan to FEMA at the end of December.


