1. Welcome and Introductions.

The Chair welcomed the group and led introductions.

2. Approval of the May 24, 2019 Meeting Summary.

The subcommittee voted to approve the meeting summary without changes.

3. **Regulatory Update**. The North Central Texas Council of Governments (NCTCOG) staff will provide an update on legislative and regulatory developments.

NCTCOG staff provided the following updates:

- 1) TX HB 1059 Relating to a biennial report of stormwater infrastructure in the state Vetoed by Governor.
- 2) TX HRJ 4 Proposing a constitutional amendment providing for the creation of the flood infrastructure fund to assist in the financing of drainage, flood mitigation, and flood control projects.
- 3) The renewal period for Phase II MS4's ends July 23, 2019. Renewal applications along with an updated Stormwater Management Program need to be submitted on paper forms to TCEQ.
- 4. Work Scope. Discuss Task Order projects with consultants, Halff Associates, Inc.
 - a. Task Order 3 project updates and deliverables

Ashley Lowrey (Halff) provided the following updates:

- 1) The final revision of the community inventory maps was presented. Comments were made on the frequency of revisions made to the maps and the addition of a map that shows only the iSWM silver certified communities.
- 2) A call was made for iSWM certified communities to volunteer to take part in upcoming technical workshops to discuss issues and best practices. In addition, the subcommittee discussed how to get cities to sign up for iSWM designation implementation workshops to receive assistance implementing iSWM.
- 3) Subcommittee discussed the need for a "Best Practices" information discussion and the best venue for hosting the discussion (forum, discussion board, in person or webinar).

- 5) Halff discussed progress on BMP installation videos and requested volunteers to propose potential developments that could be filmed.
- b. Temporary sediment basin drawdown time discussion.

City of Mansfield - Page 34 of the Construction General Permit references utilizing the 2yr-24hr storm to determine the volume capacity for a temporary sediment basin. Discussion on what times are being used throughout the region (36 vs 48) and in cities that are outside of the region.

c. Detention Basin Drawdown Time Discussion

d. Frustum of a pyramid formula correction

Subcommittee discussed what to do when errors are found in the technical manuals. Subcommittee proposed that all errors would be sent to Halff for correction. NCTCOG would broadcast and push out announcement that a change has been made to the manual(s) to the Publics Works Council.
