The third annual North Texas Community Cleanup Challenge had yet another great year as a regional initiative targeting litter and floatables in the environment and our waterways! This year, the Community Cleanup Challenge was held from March 1st through May 31st, 2023, with fourteen communities who signed on to participate. NCTCOG would like to thank all the individuals, organizations, and communities who participated and helped spread the message of environmental stewardship throughout the region. EVENT CALENDAR

A total of **nine** events were added to the event calendar on the Community Cleanup Challenge website. This allowed participating communities to have a greater reach, connecting potential volunteers to events happening across the region.

VOLUNTEERS

There was no shortage of volunteers willing to get involved in their communities. This year, the North Texas Community Cleanup Challenge saw fourteen cities participating in the challenge, some for the third year in a row! This cohort of communities motivated their residents to get out in droves. A total of 15,370 volunteer hours were logged by 5,370 volunteers across the region.

LITTER

The total amount of litter collected from 204 different locations during the Community Cleanup Challenge filled the equivalent of 9,924 bags of trash which weighed somewhere around 135,079 lbs.!

Starting with the 2022 Community Cleanup Challenge, participants made the switch from reporting their data through the NTCCC website to reporting through the Texas Litter Database (https://txlitter.org/). This change was made to help support the statewide effort to centralize the reporting of all trash and litter data from across the state into one repository. This centralized location, which is free to access, helps support the studying of data across the state and can be used to impact or support policies centered around trash and litter.

LOCALITY

The many different locations where litter was cleaned up by participants were varied in both size and geography, but they can be simply quantified as:

- .4 Miles of Waterways This distance is about double as tall as the Eiffel Tower.
- 26.7 Acres Which is equal to about 20 football fields.

ADDITIONAL LITTER RESOURCES

Sometimes litter can be widespread and unintentional such as when unsecured trash blows out of the back of a vehicle or overflows a waste bin located outside. These sources of litter can often be easily addressed through education and behavior changes like not leaving trash or light items in the back of moving vehicles or securing the lids on outside waste bins. Illegal dumping, however, can become a more complex and costly problem to solve for local communities. If you happen across an illegal dumping site, you can report it to Report Illegal Dumping DFW by calling the hotline at 1-888-335-DUMP or submitting a report online at www.reportdfwdumping.org. If you are a resident that has items you are unsure how to dispose of properly, check with your city to find out what options are available to you or look into these resources to help you find a way to recycle or properly dispose of them.

2024 North Texas Community Cleanup Challenge

The 2023 Community Cleanup Challenge may barely be over, but we are already planning and looking forward to the 2024 Community Cleanup Challenge which is scheduled to take place from March 1, 2024 – May 31, 2024. Participants have until April 1, 2024, to sign-on to the Community Cleanup Challenge and the Mayors' Challenge. All cleanup data will need to be submitted by June 30, 2024, to be eligible. To join the optional Mayors' Challenge, communities simply need to have their Mayor or Commissioners issue a proclamation that the community is joining the challenge. Hopefully a challenge is also issued to a neighboring community to keep the friendly competition going!
