4. **Overview of Implementation Strategy Revisions.** NCTCOG will present the current status of the revisions to the TMDL Implementation Plan Strategies.

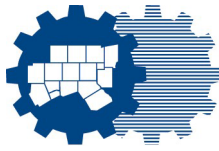

NCTCOG presented a recap of the TMDL I-Plan Strategy Task Force meeting details. This included dates of the task force meetings and the purpose and outcome of each meeting. I-Plan strategy 3 and 6 were presented to the committee for feedback at the request of the Planning and Development I-Plan Task Force and the Monitoring Coordination Forum I-Plan Task Force. The committee did not give feedback on the proposed revisions to the I-Plan strategies. This agenda item concluded with details on how NCTCOG will continue working on the I-Plan.

DISCUSSION

5. **Future TMDL Activities and Stakeholder Engagement.** NCTCOG will request feedback from attendees on the future of the TMDL Program and how to continue encouraging stakeholder engagement in the program, both within and outside of the TMDL Project Area.

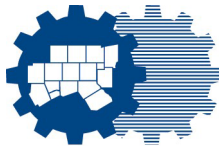
7. **Roundtable.** The group will share what is happening in their communities.
