### Project Background

#### **General Project Overview**

Las Colinas Automated Transportation System (ATS) infrastructure project is to modernize and prepare the system for the next generation of ATS technology. This will be accomplished by the development of the retrofit design and engineering of the Las Colinas ATS infrastructure. This project is located in the Las Colinas District of Irving Texas.

#### **Scope of Work Overview**

The scope is to advance the engineering and design of the retrofit as close to 100% design plans as possible, with intermediate milestones at 30%, 60%, and 90%. The project will cover approximately one mile of the existing ATS infrastructure. The expected duration of the retrofit agreement is 1 year from the notice to proceed.


#### Overview of Scope of Work

#### The scope of work will include:

- Project Management Project Management Plan, with project approach, project organization structure and engaging with Key Stakeholders
- Retrofit Assessment Inspection of existing infrastructure, evaluation of track and integration of new decking
- Infrastructure Evaluation Potential accommodation of dynamic wireless charging elements and/or static charging locations
- Engineering Documentation Design of necessary infrastructure components to retrofit, vehicle storage and charging facility
- Environmental Documentation Obtain Categorical Exclusion or complete the NEPA process for the retrofit project
- Implementation Plan Develop plan and include cost estimation and future project scheduling
