North Texas Community Cleanup Challenge Results Announced!

The North Central Texas Council of Governments would like to extend congratulations to the **City of Fort Worth** as a winner of the first annual North Texas Community Cleanup Challenge (NTCCC) and Mayors' Challenge!

The North Texas Community Cleanup Challenge is a region-wide litter cleanup challenge between communities which ran between September 1st and October 31, 2021. As part of the NTCCC, communities competed to see who could cumulatively clean up the most litter during the designated timeframe.

Thank you to all twenty-one participating communities: Allen, Anna, Arlington, Carrollton, Cleburne, Denton, Ennis, Fort Worth, Frisco, Garland, Grand Prairie, Grapevine, Greenville, Irving, Lake Dallas, Little Elm, Lucas, Mansfield, Mesquite, Plano, and Rowlett.

The following four communities also competed in the Mayors' Challenge by having their mayors issue proclamations urging residents and businesses to get involved: Anna, Fort Worth, Grand Prairie, Mansfield.



Trash Free Texas Adopt-A-Spot Map Now Has a Link to the Texas Litter Database



[The Trash Free Texas Adopt-A-Spot Map](#) now has a link in the bottom, righthand corner to the [Texas Litter Database](#). This will help raise awareness about the Texas Litter Database as well as make it easier for Trash Free Texas coordinators, partners,

and volunteers to find the database for entering their litter cleanup data. All litter cleanup volunteers and cleanup organizers in Texas are encouraged to enter their data in the database.

[The Texas Litter Database](#) was created by Keep Texas Beautiful, the Houston Advanced Research Center, and Black Cat GIS, and funded by the Garver Black Hilyard Family Foundation. It organizes and stores the trash and marine debris data collected in Texas in a central location and can be accessed through any smart device or computer. The database also introduces [Take 2 for Texas](#), which is a new way for volunteers to contribute data on plastic bottles by taking two minutes to collect only plastic bottles in any given area.

Partnerships with Restaurants and Cities

The Trash Free Texas team continues to seek partnerships with local governments, restaurants, and third-party delivery services to identify ways to reduce the consumption of single-use plastic. This effort can help restaurants save money while cleaning up our communities and waterways. Trash Free Texas Partner Updates

City of Fort Worth Announces Giant Waterwheels Coming to Banks of Trinity River

The City of Fort Worth announced in December plans to install two giant, trash-collecting waterwheels on the banks of the Trinity River. The solar powered waterwheels are a collaboration between the City of Fort Worth, Tarrant Regional Water District, and community partners. The waterwheels will have the capacity to remove 50,000 pounds of solid waste per day from the Trinity River. Current plans are to place them on the Clear Fork and the West Fork of the Trinity River. Recent Legislation

The “Reducing Waste in National Parks Act” was introduced to the Senate on October 7, 2021, by Sen. Jeff Merkley (D-OR). This legislation, if passed, would allow national parks to voluntarily ban the sale of single-use plastic items such as plastic water bottles, bags, utensils, and other disposable plastic materials. - Webinar by Busch Systems: **“Tackling Litter and Recycling Contamination – Steps to Influence Behavior in Parks and Outdoor Public Spaces”**

It seems easy enough to toss recycling and trash items into the correct bin. And yet, anyone involved with waste collection knows it’s rarely that simple. People tossing items in the wrong bin – or on the ground – is a perennial challenge that facility managers have struggled with for years. While there are no silver bullets, behavioral research and hard-earned experience can point to solutions. This program will feature experts sharing local case studies as well as research-based best practices for designing collection bins and signage, planning bin placement patterns, and other steps to positively influence how people discard waste in outdoor settings.


