
The Committee discussed the new EPA refrigerant guidelines that went into effect at the beginning of the year.

The Committee discussed discrepancies between cities adopting and supporting older versions of the recommended codes, including the 2017 version. This also impacts electricians that are certified under the 2023 codes, while cities only require older versions, potentially leading to liability concerns and further documentation needed.


